# Japan's efforts to mainstream the 2030 Agenda in national context

# 1. Active contribution to the discussion and negotiation of SDGs

- Japan actively contributed to the discussions through various dialogue opportunities even before the international society 's discussion became fully in progress.
  - ✓ Organized policy dialogue(2011-2013), side event at the UN General Assembly (In 2013, Prime Minister Abe and Minister of Foreign Affairs Kishida participated) etc.
- In the SDGs negotiation process, Japan actively contributed to the discussions under the concept of human security and incorporated development agendas that Japan attaches importance on. (Education, Women, Health, High Quality Infrastructure, DRR etc)

# 2. Establishment of the SDGs Promotion Headquarters

- At the United Nations Summit where SDGs were adopted, Prime Minister Abe expressed the intention to fully implement the SDGs.
- Established the SDGs Promotion Headquarter in May last year, headed by the Prime Minister Abe, to ensure a whole-of-government approach to implementing the 2030 Agenda in a comprehensive and effective manner and worked on the SDGs Implementation Guiding Principles.
- Established the Round Table Meeting where a wide range of stakeholders
  (government, NGOs / NPOs, experts, private sectors, international organizations,
  various organizations, etc.) gather and exchange opinions.

# 3. Major Processes till Now

2016

May 20 Established the SDGs Promotion Headquarters headed by the Prime

Minister and composed of all ministers . At the first meeting, the PM

directed the formulation of the "SDGs Implementation Guiding

Principles".

Sep. 12 Held the 1st Round Table Meeting

Oct. 18 Decided the outline of the SDGs Implementation Guiding Principles

Oct. 19 – Nov. 1 Conducted public comment

Nov. 11 Held the 2nd Round Table Meeting

Dec. 22 Held the 2nd SDGs Promotion Headquarters Meeting. Approved

## Systems to promote SDGs

• **SDGs Promotion Headquarters**: serve as a "control tower" to facilitate the overall coordination among the relevant ministries and agencies and implement related policies effectively.

## Mainstreaming SDGs:

- ✓ Incorporate the SDGs into government's plans, strategies and policies as much as possible.
- ✓ As policy incentives, explore means to achieve necessary systemic reforms and endeavor to appropriately secure financial resources.

## Partnering with relevant stakeholders:

- ✓ Build close partnership through the SDGs Round Table Meetings
- ✓ Consider setting platforms to exchange views and partner with related stakeholders on cross-sectorial issues.

# Overview of the SDGs Implementation Guiding Principles (Cont'd)

## Systems to promote SDGs

#### Communication:

- ✓ Foster the sharing of good practices among implementing partners, including the private sector, by giving awards and promoting the use of SDG logos and branding.
- ✓ Promote Education for Sustainable Development (ESD) as well as encourage learning about SDGs in all settings, including schools, households, workplaces and local communities
