

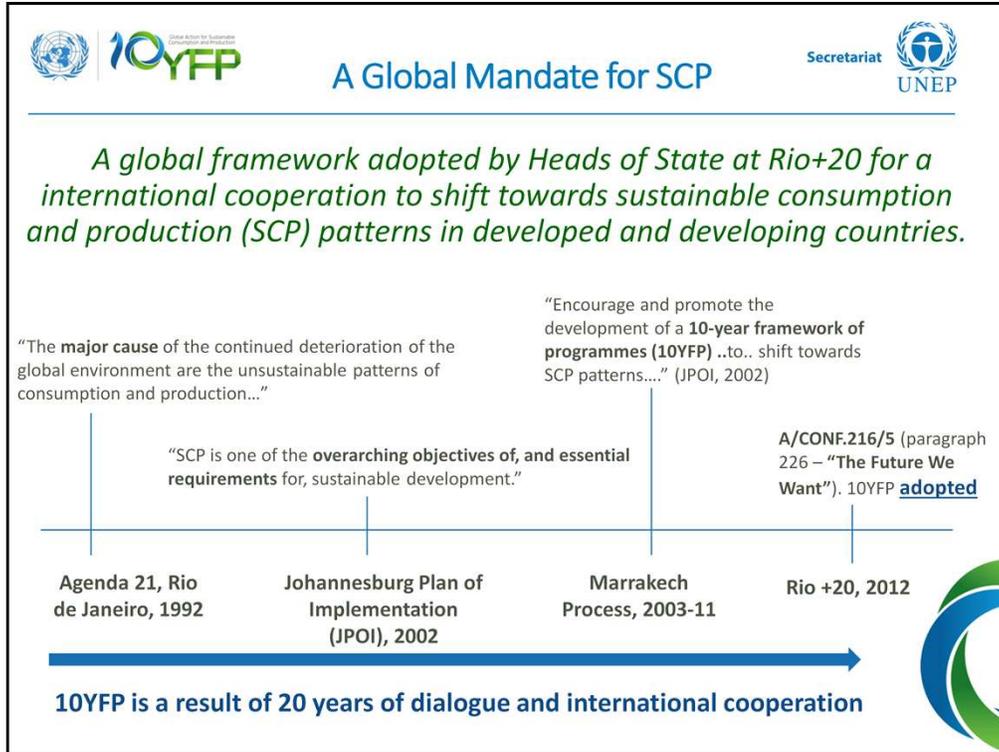

The 10YFP will encompass capacity building, technical and financial assistance to developing countries for this shift. The 10 YFP will develop, replicate and scale up SCP and resource efficiency initiatives, at national and regional levels, decoupling environmental degradation from economic growth, and promoting a transition to a green economy.

“ Fundamental changes in the way societies produce and consume are indispensable for achieving global sustainable development.... Governments, relevant international organizations, the private sector and all major groups should play an active role in changing unsustainable consumption and production patterns;” (A/CONF.216/5 , para 1.a)

What is the 10YFP?



It is a global framework of action to enhance international cooperation to accelerate the shift towards SCP in both developed and developing countries.

A concrete and operational outcome of Rio+20

“Fundamental changes in the way societies produce and consume are indispensable for achieving global sustainable development. All countries should promote sustainable consumption and production patterns, with the developed countries taking the lead and with all countries benefiting from the process, taking into account the Rio principles...”

WHAT IS THE 10YFP?

It is a global framework of action to enhance international cooperation to accelerate the shift towards SCP in both developed and developing countries. The framework will support capacity building, and facilitate access to technical and financial assistance for developing countries for this shift. The 10YFP will develop, replicate and scale up SCP and resource efficiency initiatives, at national and regional levels, decoupling environmental degradation and resource use from economic growth, and thus increase the net contribution of economic activities to poverty eradication and social development. The framework will encourage innovation and cooperation among all stakeholders.

All actors from all countries can be involved in the implementation of the 10YFP activities: government, private sector, civil society, researchers, UN agencies, financial institutions, and other major groups.



10YFP main objectives



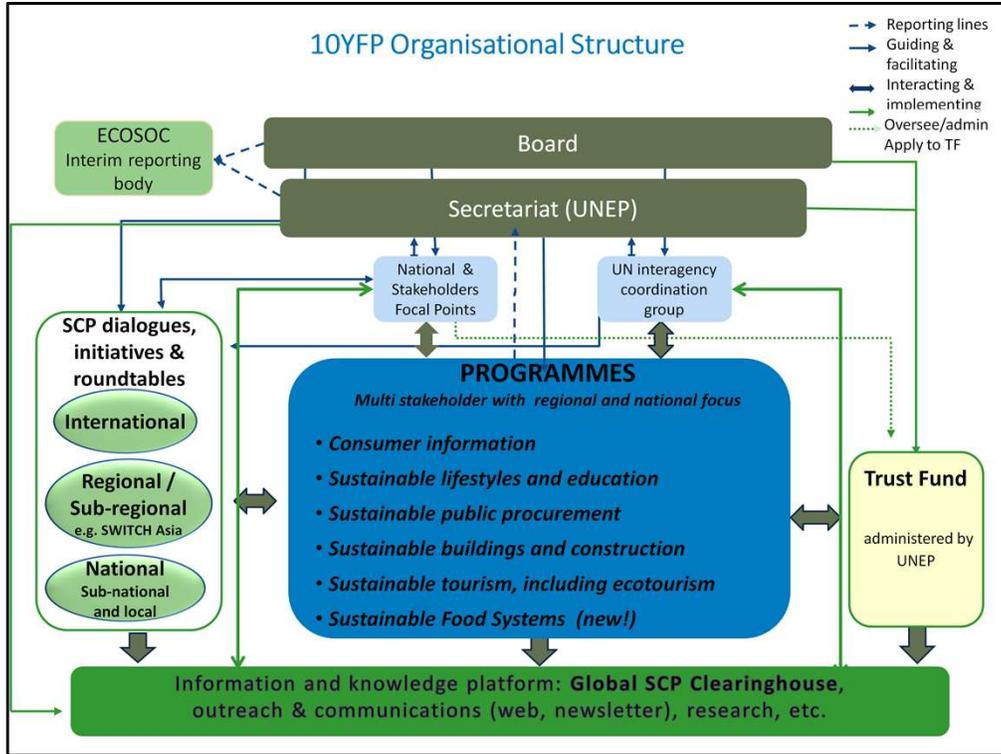
Accelerate the shift towards **SCP** in all **countries** by supporting regional and national policies and initiatives

Increase **RE** and decouple economic growth from environmental degradation, creating **decent jobs** and contributing to **poverty eradication and shared prosperity**

Support **capacity-building** and facilitate access to **financial and technical assistance for developing countries**, to implement SCP activities at all levels

Serve as an **information and knowledge sharing platform on SCP** to enable **all stakeholders** to exchange policies, tools, initiatives and best practices, enhancing cooperation







Why 10YFP Programmes are important?



Programmes serve as “umbrellas” that bring together existing and/or develop new initiatives and partnerships to fill capacity & knowledge “gaps” on SCP.

They **build synergies and cooperation** between stakeholders, and allow scaling up and replication of policies, voluntary measures, management practices, and partnerships promoting the shift to SCP patterns, engaging governments, business, civil society, consumers and other major groups.

Programmes are expected to **deliver capacity building and technical support at all levels:** regional, sub-regional, national and local

They are about delivering **collective impact**

10YFP programmes:

Programmes are at the core of the framework. They will bring together existing initiatives and partnerships, building synergies and cooperation between stakeholders, and allows scaling up and replication of policies and best practices on SCP, engaging governments, and all major groups.

Programmes are the most dynamic element of the 10YFP. Here is where most of the activities will take place. Programmes will develop new SCP tools, support capacity building, training, workshops, implement demonstratin projects

10YFP programmes:

Programmes are at the core of the framework. They will bring together existing initiatives and partnerships, building synergies and cooperation between stakeholders, and allows scaling up and replication of policies and best practices on SCP, engaging governments, and all major groups.

Programmes will ensure MULTI-STAKEHOLDER participation. Each of them will have a Multi-stakeholder Committee with regional balance that will support the implementation and delivery of the programmes, as well as the fund raising and coordination with the 10YFP Secretariat, Board and Trust Fund.

Status of the Programmes :

The next steps on the 10YFP programmes are as follows.

Sustainable Public Procurement (SPP): The [Sustainable Public Procurement Initiative \(SPPI\)](#) is preparing a proposal for the 10YFP programme which will be released for public consultation by the end of the year, with launch expected early in 2014. The focus of the programme is likely to be: (1) developing a vision for SPP and defining purchasing principles. (2) monitoring SPP/GPP implementation and assessing impacts; (3) addressing barriers to SPP implementation and proposing/disseminating innovative solutions; (4) promoting collaboration with the private sector; and (5) cooperating for SPP implementation.

Consumer Information: a stock taking analysis, including interviews of key organizations and stakeholders working in the area of consumer information, and an on line global survey (160 responses), have been undertaken. A proposal will be circulated to experts, 10YFP national and stakeholder focal points and the UN Inter-agency Coordination Group by the end of the year. The programme may focus on the following objectives: i) easy, practical and sustainable choice by consumers, through ii) provision of accessible, reliable and verifiable life cycle based sustainability information by market suppliers.

Sustainable Tourism: a Global Survey on Sustainable Tourism yielded 370 responses from the full range of stakeholders. Preliminary findings were presented at the 92nd Session of the OECD Tourism Committee (October 2013, Paris) and at the UN Expert Group Meeting on Ecotourism, Poverty Reduction and Environmental Protection (October 2013, New York). 10YFP programme areas may include: i) Tourism/ Destination Planning, ii) Tourism Investment; iii) Tourism Monitoring and Evaluation, iv) Tourism Operations and Management. A proposal will be ready for public consultation in the first quarter of 2014.

Sustainable Buildings and Construction The SBCI Symposium (25-26 November 2013, Paris, France) served as a platform for early discussions, and highlighted the importance of sustainable social housing and energy efficiency as potential activities of the Programme, in addition to policy development, and resource efficiency in construction along the supply chain. The first draft concept for a programme is currently being developed.

Sustainable Lifestyles and Education: consultation with key stakeholders and partners on this programme has been initiated, and will be concluded in early 2014, with the launch of the programme expected in mid-2014.
