SIDS share a number of key challenges when it comes to financing for sustainable development. These include limited capacities to mobilize domestic resources, high per capita costs when it comes to essential service provision and vulnerability to environmental and economic shocks. The data shows that SIDS receive very little Official Development Assistance (ODA) as a share of total ODA, at just 5.7%. However, when aid receipts are measured as a proportion of national income and on a per capita basis, they are larger recipients. A robust and inclusive outcome to the Mid Term Review must recognize the special development challenges faced by SIDS, and include measures designed to strengthen their capacity to leverage and effectively use resources to meet the SDGs. This session aims to inform and reinvigorate international policy debates around how SIDS can finance their sustainable development agendas.
