
#### Mani Objectives:

- 6. Administrative & Financial Affairs




# 1. Integrated Water Resources Management Programme

Applying the IWRM Approach towards sustainable use of water resources

#### Projects under this programme aim to:


- Apply appropriate technologies and principles to ensure optimum use of available water resources.
- Preserve and protect water resources from contamination and over-exploitation.
- Implement appropriate water policies for improvement of water resources management.



#### 2. Environmental Water Protection

#### **Objectives:**

- 1. To preserve the quality of water resources and protect them from contamination and overexploitation.
- 2. To provide clean water for various uses.



#### 3. Water Resources Development

#### Objectives:

Conducting research and studies to:

- Evaluate available water resources
- Ensure sustainable use of water resources.
- Control water resources degradation.
- Explore additional water resources.
- Increase available water resources




## Addressing Drought in the Action plan





#### Addressing Drought in the AWSS Action plan






#### The Strategy:

The strategy proposes indicators for evaluation each 5 years.






## What is the AWSS action plan?

- Documentation of a concrete timetable for five years of defined activities to be undertaken for the strategy to succeed, with indicators to track progress towards achievement of strategy.
- Focused at the regional level, but prioritised according to common national objectives and inviting national participation.
- Organised by *clusters*.




#### Clusters:

6 Expected Accomplishments

In reviewing the Arab Water Security Strategy the Working Group proposes clustering these Outputs into 6 Expected Accomplishments to be addressed by the action plan:

- 1. Enhanced provision of updated information on the status of water in the Arab Region;
- 2. Improved implementation of IWRM;
- 3. Strengthened scientific, technological and industrial base;
- 4. Improved sanitation and safe water;
- 5. Enhanced capacity for climate change assessment and adaptation; and
- 6. Established mechanisms for the protection of Arab water rights in shared water resources.




### Principles
