# Structure of the Ministerial Declaration of the High-level Segment of the 2021 Economic and Social Council (ECOSOC) and the high-level political forum on sustainable development (HLPF)

#### I. Introduction

- COVID-19 and its impact, need for a coordinated global response to the crisis and international solidarity. 2030 Agenda as our first line of defense.
- Reaffirmation of the commitment to the implementation of the 2030 Agenda and the SDGs and the realization of the decade of action and delivery with accelerated actions and transformative pathways, reaffirmation of the 2030 Agenda principles especially leaving no one behind, while protecting the planet.
- The reaffirmation of the role of multilateralism and the importance of the UN system in guiding and supporting the implementation of the 2030 Agenda and the achievement of the SDGs.

- Assessing each goal under in-depth discussion (1, 2, 3, 8,10, 12, 13, 16, 17 as well as 2020 targets) and impact of COVID and recommendations for the way forward for each of the goals and for 2020 targets) Addressing the interlinkages with other goals and the 2030 Agenda.

 Poverty including multidimensional aspects, peace, security, LNOB, human rights, social inclusion, countries in special situations, middle-income countries, economic prosperity and decent work trade, gender, children and youth, disaggregated data, climate change, DRR, prevention and response to future health crises, localization, role of science and rapid technology change, digital connectivity

  and partnerships, multi-stakeholder approaches.
