Dear Friends and Colleagues,

With this information note we invite your organization to make a contribution to the *twelfth session of the Commission on Sustainable Development* (CSD-12), which will convene from <u>14 to 16 April at UN</u> <u>Headquarters in New York</u> to serve as the Preparatory Committee for the International Meeting to Review Implementation of the Barbados Programme of Action for the Sustainable Development of Small Island Developing States, followed by the actual CSD-12 Review session <u>from 19 to 30 April 2004.</u>

The note contains detailed information on the agenda of the session, the milestone dates to keep in mind as you prepare your contributions to the session's work, the related regional and inter-sessional meetings organized around the agenda themes, and a list of useful contacts in the CSD Secretariat and in its partner UN bodies.

The CSD has historically been innovative in generating broad-based participation in sustainable development, relative to other similar bodies, and it will continue to experiment and adopt novel participatory mechanisms to increase the involvement of major groups in sustainable development efforts at the UN and around the world. The 2002 World Summit on Sustainable Development (WSSD) succeeded in integrating major groups even further into the intergovernmental process through new approaches and formats for participation, moving beyond the tradition of the multi-stakeholder dialogue to establish their presence in high-level roundtables, expert panels, and partnership initiatives.

With the increasing recognition of the essential role played by major groups as key partners in the WSSD follow-up, the CSD Secretariat is developing other formats for stimulating more productive dialogue and inspiring collaborative efforts among governments, major groups and the UN system, building on lessons learned from past traditions and practices. At CSD-12 major groups are expected to be involved in the various activities planned throughout the official session, including a multi-stakeholder dialogue within the High-level Segment. We anticipate that such developments will inspire new traditions and produce fruitful outcomes in the years ahead.

Maintaining and enhancing the established participatory tradition of the CSD requires continued commitment by all parties. Without **your** involvement the sustainable development agenda will not have the same depth and breadth that other participants have come to expect. We therefore invite you to begin preparing for CSD-12, and hope that this information note will provide your organization and its constituency with the starting points of how to contribute and influence the CSD-12 related cycle.

We look forward to working with all of you and to facilitating your active involvement in the work ahead.

## 1. INTRODUCTION TO CSD-12

At its eleventh session, held in New York from 28 April - 9 May 2003, the Commission on Sustainable Development decided that its multi-year programme of work following the 2002 World Summit on Sustainable Development would be organized on the basis of seven two-year cycles, with each cycle focusing on selected thematic clusters of issues.

These guidelines aim to provide you with a road map of the process leading up to the session and information how to contribute and prepare for the session.

#### 1.1. CSD-12 THEMES, CROSS-CUTTING ISSUES AND PROCESS MILESTONES

The Commission will now function on the basis of two-year "Implementation Cycles" comprised of "Review Years" and "Policy Years." CSD-12 will constitute the first Review Year, during which the CSD will evaluate the progress made in implementing sustainable development goals and identifying obstacles and constraints, while the Policy Year (CSD-13) will decide on measures to speed up implementation and mobilize action to overcome these obstacles and constraints.

For the first two-year cycle (2004-2005), the CSD will focus on water, sanitation and human settlements (see <u>Annex 1</u> for the full programme of work through 2017). In every cycle, a number of cross-cutting issues will be addressed, such as poverty eradication, changing unsustainable patterns of production and consumption, health, education and sustainable development in a globalizing world as shown below. Means of implementation should be addressed in every cycle and for every relevant issue, action and commitment.

In each cycle, the thematic clusters of issues would be addressed in an integrated manner, taking into account economic, social and environmental dimensions of sustainable development. The Commission agreed that the implementation process should cover all these issues equally and noted that the selection of some issues for a given cycle did not diminish the importance of the commitments undertaken with respect to the issues to be considered in future cycles.

The Commission on Sustainable Development will convene its twelfth session (CSD-12) over a two-week period scheduled from <u>19 to 30 April 2004</u>, in New York. CSD-12 will be preceded by a three-day preparatory





meeting for the upcoming Ten Years review of the Barbados Programme of Action for the Sustainable Development of Small Island Development States (scheduled in New York from <u>14 to 16 April 2004</u>).

#### 1.2. CSD-12 FRAMEWORK FOR ORGANISATION OF WORK

At its second meeting held in New York on 3 October 2003, the Bureau of the 12<sup>th</sup> Session of the Commission on Sustainable Development agreed on a framework that outlines the organization of work at CSD12. The framework includes a number of "givens", such as opening, closing, statements, regional presentations and discussions of the three themes - water, sanitation and human settlements.

It is proposed that Conference Room 1 be used as a venue for discussions addressing key strategic and policy issues in implementation, including cross-cutting issues and Conference Room 2 as a venue for discussions dealing with the scientific, technical and practical aspects of implementation. It is proposed that discussions in both conference rooms be organized through a variety of activities, including keynote speeches by eminent persons, presentations by experts and moderated panel discussions, as well as interactive discussions from the floor, with inputs from UN agencies and major groups.

## 2. THE CSD-12 REPORTING PROCESS

The CSD's review session is based on reports and supplementary materials that analyze the progress made in implementing Agenda 21, the Programme for the Further Implementation of Agenda 21 and the Johannesburg Plan of Implementation, while focussing on identifying constraints and obstacles in the process of implementation with regard to the thematic cluster of Water, Sanitation and Human Settlements. Each theme is covered in a Secretary-General's (SG) Report that may be supplemented by one or more Addenda, and at times by other materials such as background papers or case studies.

The SG Reports are limited to 16 pages in length and are produced in the six official languages of the United Nations. The Addenda to the SG reports are also of limited length and available in the official languages. A number of background papers and case studies on the agenda themes are also prepared to provide more detailed information but are available in English only.

## 2.2. INPUTS FROM MAJOR GROUPS

The official reports and supplemental materials for CSD-12 also include inputs from major group organizations around the world to the extent that they wish to provide information on their activities, experiences, views, and proposed solutions for future progress. - 2. A Background Paper prepared by the CSD Secretariat summarizing views from major groups on overall progress on all areas as well as thematic areas of water, sanitation, and human settlements.
- 3. Data and information should be provided in the form of factual evidence to allow a fact-supported analysis of progress achieved in the implementation of the commitments, goals and targets agreed upon in Agenda 21, the Plan for the Further Implementation of Agenda 21 and the Johannesburg Plan of Implementation related to the thematic areas of water, sanitation and human settlements.

## 3.2. MAJOR GROUPS PARTICIPATION AT THE REGIONAL LEVEL

The CSD-11 decision invited UN Regional Commissions to consider organizing regional implementation meetings in order to contribute to the work of the Commission of Sustainable Development. The meetings organized by the UN Regional Commissions will feed into the work of CSD-12 through:

- Contributing to advancing the implementation of Agenda 21, the Programme for the Further Implementation of Agenda 21 and the Johannesburg Plan of Implementation;
- Focusing on the thematic cluster of issues to be addressed in the ongoing implementation cycle;
- Providing input to the Secretary-General's reports and the sessions of the CSD. Those inputs may include identification of obstacles and constraints, new challenges and opportunities related to the implementation of Agenda 21, the Programme for the Further Implementation of Agenda 21 and the Johannesburg Plan of Implementation, and sharing of lessons learned and best practices;
- Providing for contributions from the major groups active at the regional and sub-regional levels.

The nature and formats of the regional meetings will vary, but to the extent possible will include major groups participation according to the following common approach:

- The three thematic areas of water, sanitation and human settlements will be the focus of the regional meetings being organized in conjunction to the CSD-12 Review Session.
- Major Groups representatives are invited to participate in the five regional meetings.
- The following detailed information related to each regional implementation meeting will be available shortly on this website including links to the Regional Commissions' ones:
  - format of the meetings (including details on eventual limitations in access due to space capacity)
  - ways in which major groups will be able to contribute to the review discussions, including detailed agenda (e.g. major groups active participation in plenary meeting session or in sub-regional or thematic breakout groups)
  - registration and other logistical information
- Each regional meeting will make provisions for an interactive participation of major groups, including opportunities for dialogue among the various stakeholders. The time allocated to this interaction may slightly vary from one region to another, according to how the meeting's agenda is being designed by the organizers.

Major Groups may provide written inputs that will be made available to the participants. Each organization will be responsible for the reproduction of its documents (100 is the minimum number of copies required).

## 4. <u>SMALL ISLAND DEVELOPING STATES (SIDS) REVIEW PROCESS</u>

The CSD convene the Preparatory Meeting for the International Meeting to Review Implementation of the Barbados Programme of Action for the Sustainable Development of Small Island Developing States. The International Meeting will convene in Mauritius during August 2004. The preparatory meeting will take place from <u>14 to 16 April 2004</u>, during which it is envisaged that there will be plenary sessions as well as working group meetings. The preparatory meeting will consider the Report of the Secretary General, which will give a comprehensive account of implementation of the Barbados Programme of Action ten years after its adoption. It will also include a synthesis of the outcome of the Regional and Inter-regional Meetings and relevant expert meetings held in preparation for the Mauritius International Meeting, as well as contributions from the specialised agencies of the United Nations system, and from the involvement of the major groups. #### 4.1. MAJOR GROUPS PARTICIPATION IN SIDS REVIEW PROCESS

The preparatory meeting will provide an opportunity for major groups to make a contribution to the meeting. Past experience would indicate that there will be a strong presence of civil society in the delegations of Small Island Developing States attending the CSD and the preparatory meeting will be considered open to the major groups unless in accordance with the Rules of Procedure of the CSD. *Further details on the organization of work and the agenda for the preparatory meeting will be provided after the General Assembly has completed its consideration of the matter in November 2003.* A separate note with details on participation including accreditation of non-governmental organizations and other major groups currently not accredited to the United Nations and pre-registration information for the Mauritius International Meeting will be provided shortly posted on both <a href="http://www.sidsnet.org">http://www.sidsnet.org</a> and the major groups site at <a href=





## 5. MAJOR GROUPS PARTICIPATION IN CSD-12

The CSD has traditionally provided a lively forum for non-governmental participation, including organizations representing all major groups. Major group participation has infused the CSD with new ideas, challenges and information and has thus enriched the inter-governmental debate. Major group representatives in the CSD process have participated in multi-stakeholder dialogues, developed coordinated statements by thematic NGO caucus groups, organized dozens of side events to share experiences, and successfully lobbied for particular initiatives that they felt the CSD should undertake or support.

In recent years, major groups have been increasingly accepted within the official intergovernmental process as respected partners in sustainable development, and their presence is now more integrated into the official sessions than ever before. The unique and innovative participatory traditions of the CSD have been widely acknowledged and are fully supported by the CSD. As the CSD undertakes a new era of implementation cycles, the CSD Secretariat will continue to explore new ways to enhance major groups' participation in the CSD process.

## 5.1. <u>ACCREDITATION</u>

Non-governmental participation in the CSD is subject to the rules of participation of the UN Economic and Social Council (ECOSOC). These rules require that the non-governmental participants represent an NGO in consultative status with ECOSOC. Major Group organizations that are in consultative status with the Economic and Social Council of the United Nations (ECOSOC), including those in the CSD List, can send representatives to CSD-12. Major group organizations who were accredited to the WSSD will need to apply for ECOSOC consultative status in order to participate. An update on the status of WSSD-accredited organizations can be found in <u>Annex 5</u>.

Accredited organizations planning to send representatives to CSD-12 should write to the NGO Section **at** least three weeks in advance of the meeting.

#### 5.2. ENHANCED MAJOR GROUPS INVOLVEMENT IN OFFICIAL SESSIONS

#### Structure and Modalities of Participation

The participation of major groups throughout the official CSD-12 session will be integrated throughout the various activities being planned. The following "entry points" for major groups are currently being developed and discussed by the Bureau:

<u>General debate</u>: major groups will be included in the list of speakers of the general debate. Details on the schedule will be made available closer to the CSD-12 session.

*Interactive discussion with major groups on water, sanitation and human settlements* (morning of 20 April 2004): this session will open the week-long review discussions taking place in conference room 2 (see below).

<u>Interactive review discussions on status and practical aspects of implementation</u>: it is envisioned that major groups be integrated in all other sessions pertaining to the review exercise, which may include panel discussions, lectures followed by question and answer periods, high-level speakers inspiring discussion on a specific topic, expert knowledge forums, and partnership discussions. Major groups could be called upon during such interactive discussions to make comments on presentations, pose questions, participate in panels, and serve as resource persons or facilitators. Furthermore, major group experts and practitioners who are active and knowledgeable in the areas of water, sanitation and human settlements will be invited to share experiences and lessons learned and exchange practical approaches in implementation relevant to the issues being reviewed by the CSD.

<u>*High-level segment:*</u> this will take place from 28-30 April 2004. One session will be allocated to a multistakeholder interactive dialogue on the state of implementation within the three thematic areas between Ministers and high-level representatives of major groups. Details on this session are provided below, in Section 5.4 on major groups organizing partners.

<u>Closing session</u>: make provisions during the closing session on 30 April for overall comments by all major groups on the outcomes of the Review Session.

#### **Outcomes**

Major group's views made during the CSD-12 session will be captured in the Chairman's summaries (Chair's summary Part I covering the first part of the session, and Chair's summary Part II covering the High-Level Segment). The summaries need not reconcile differing views, but instead should reflect the flavour of the debate as accurately as possible. Major groups' views and <u>proposed solutions</u> to meet challenges and overcome problems related to the topics being reviewed could potentially influence the final CSD decisions in the Policy year (CSD-13), as Governments make use of or endorse them in the negotiation stage.





## 5.3. MEETING WITH THE CSD-12 BUREAU AND THE MAJOR GROUPS

It is customary for the Chair and other members of the Bureau to meet with major groups representatives. The first meeting of this kind will be organized in conjunction with the third meeting of the Bureau scheduled in New York on 18 November 2003. Major Group representatives who will be in New York at that time will be welcome to participate. Information on time and venue will be disseminated through our list serve and posted on our website. At least one additional meeting will be scheduled closer to the CSD-12 session, and as per past practice, a Co-chair will serve as contact person for the Major Groups during the CSD-12 session.

#### 5.4. MAJOR GROUP ORGANIZING PARTNERS FOR CSD-12

The preparation of multi-stakeholder participation within the CSD is itself a multi-stakeholder process. For the dialogue and the other participatory sessions, key major group networks are invited to form a steering group, which coordinates the preparations and facilitates the engagement of the stakeholders through the leadership and guidance of the organizing partners. The Division for Sustainable Development chairs the steering group and facilitates its work during the preparatory period.

The major groups organizing partners are responsible for:

- Consulting with networks to prepare a dialogue paper (approximately 16 pages) that reflects their group's overall views on the topics for each session, involving themes of water, sanitation and human settlements and the successes and challenges of implementation;
- Consulting with networks to identify relevant experts and other participants to serve on their delegations;
- Coordinating and facilitating the participation of their delegation throughout the CSD-12 session.

## 5.5. <u>PARTNERSHIPS FAIR</u>

The CSD-12 Partnerships Fair will provide a venue for existing and potential new partners of WSSD Partnerships to network, create synergies between partnerships, identify new partners and funding sources and learn from each other's experiences. Partners will have the opportunity to launch new partnerships, update other CSD participants on progress with existing partnerships and present ideas on the follow-up process within CSD. There will also be moderated discussions on relevant themes and a number of educational "How to" sessions providing practical advice and information on partnerships issues. The Partnerships Fair will be a parallel activity to the official discussions at the CSD.

#### General Structure of the Partnerships Fair

- Partnership presentations: Those involved in partnerships registered with the CSD will have the opportunity to present information pertaining to their specific partnership, implementing mechanisms and action plans. This will also be an opportunity for exchanging lessons learned, networking, and attracting new partners or funding
- "How-to" sessions: These will be exercises in information-sharing and discussion on issues related to establishing and running effective partnerships. These could include partners with first-hand experience stemming from established partnerships highlighting challenges and lessons learned, followed by interactive discussion, as well as general information sessions on such topics as funding partnerships and raising awareness.
- Thematic discussions of partnerships that contribute to water, sanitation and human settlements international commitments might also be organized.
- There may also be some scope for poster and exposition-type facilities.

#### Who Can Present at the Partnerships Fair?

Partners involved in a sustainable development partnership initiative that is registered with the CSD Secretariat and posted on the CSD Secretariat website will have the opportunity to make presentations. Partnerships related to the thematic areas of water, sanitation and human settlements are particularly encouraged to participate. More information about participation in the Partnerships Fair will be made available on the DSD website as soon as it is available.

Partners must ensure that they are accredited to the Commission on Sustainable Development (through a major group, Government or intergovernmental organization) to be able to participate in the Partnerships Fair.

#### Annex 5: Update on the Status of WSSD-Accredited NGOs

During the 11th Session of the Commission on Sustainable Development, held in New York from 28 April - 9 May 2003, a discussion was held on the issue of how to accommodate the future participation of the 737 NGOs and other major group organizations accredited to participate in the World Summit on Sustainable Development.

The CSD subsequently recommended to the Economic and Social Council to "consider, in accordance with established United Nations rules of procedure and taking note of the ongoing work of the NGO Committee, the status of NGOs that were accredited to the World Summit on Sustainable Development so that the Commission can benefit from their contributions as soon as possible."

During the ECOSOC Substantive session held in Geneva from 30 June - 25 July 2003, the Council considered the CSD-11 decision addressing the question of NGO accreditation. Delegations were divided on this issue, and proposed two different solutions. The first group requested that all WSSD-accredited NGOs apply for consultative status with ECOSOC through the NGO Committee, in accordance with the rules of procedure and practices of the United Nations. The second group preferred a special arrangement whereby NGOs applying for consultative status with ECOSOC in accordance with established rules of ECOSOC would also be added to ECOSOC's "CSD List" while their applications were pending, so that they could participate in the sessions of the CSD, and that this arrangement would be reviewed following the first two-year cycle of the CSD.

There was no agreement on this issue, and several different versions of the proposed text were transferred for future consideration during the resumed session of ECOSOC, to be held in February 2004.

While a final decision on this issue remains pending, we strongly encourage all NGOs and other major groups accredited to the WSSD to apply as soon as possible for consultative status with ECOSOC by contacting the NGO Section at <u>desangosection@un.org</u> or by visiting their website at: <u>http://www.un.org/esa/coordination/ngo/</u>

Applications received before 1 June 2004 will be reviewed in 2005 by the NGO Committee and submitted to ECOSOC for final approval.





#### **Annex 6: Side Event Guidelines and Event Request Form**

- 1. The proposed side event should be directly related to the goals and objectives of the Commission on Sustainable Development and should reflect an approach to sustainable development that integrates its economic, social and environmental dimensions.
- 2. Every effort should be made to align the proposed events with the main thrust of the agenda of the 12th Session of the Commission on Sustainable Development.
- 3. In order to ensure that as many organizations can be involved as possible, side event proposals should involve several organizing partners. Preference will be given to events that are organized by governmental, non-governmental and intergovernmental partners.
- 4. Each side event organizer can be involved in only one side event at each session of the Commission on Sustainable Development
- 5. The Secretariat will distribute copies of the consolidated programme on the first day of the meeting to inform participants about the session and related events. The Secretariat will also provide a daily leaflet containing the most up-to-date list of events and meetings taking place that day. The Secretariat will not produce fliers, distribute notices, or run other publicity efforts for side events; publicizing a side event is the responsibility of its organizers
- 6. Side events are open to all participants. Organizers of closed events or events aiming for an exclusive audience are advised to obtain alternative locations.
- 7. Non-governmental representatives proposing a side event must be accredited with the Commission for Sustainable Development. Organizations that are already in consultative status with ECOSOC are automatically accredited.
- 8. Inter-governmental meetings always have priority over other events or meetings. Side events may have to be cancelled at the last minute if an inter-governmental meeting needs to use the room where the side event was scheduled to take place. In these cases, the Secretariat will attempt to reschedule the cancelled event to another location or another date.
- 9. Side event organizers can request equipment and services for their event including: projectors (slide, video, overhead or laptop-to-screen), microphones (standing microphones or use of the sound system in the conference rooms), projection screens, sound recording (based on availability of recording equipment in the room).





- 10. Organizers should plan to hold their event in English as interpretation services are not available for side events.
- 11. Printed materials may be distributed by using the tables or other such facilities that will be available outside the meeting rooms. Since side events take place in the rooms where the official meetings are conducted, organizers are requested to remove all their materials when leaving the rooms after their side event.
- 12. Only printed materials that are directly related to the agenda of the 12th Session of the Commission for Sustainable Development can be distributed during a side event or at any other time at the session. The Secretariat reserves its right to remove materials judged to be inappropriate.
- 13. The sale of printed materials (or any other items) at the UN premises during the side events or at any other time is strictly prohibited.
- 14. Displays and exhibitions can only be organized through the Secretariat. Side event organizers are advised not to set up displays or put up posters on meeting room walls during a side event or at any other time during the meeting to avoid removal and loss of their materials.
- 15. Food and drinks are prohibited in the conference rooms of the UN. Activities that involve food or drinks, such as receptions, are allowed only in the designated areas and must be arranged directly with the UN Catering Services, tel: (+1-212) 963 7098. The Secretariat will not facilitate these arrangements.
- 16. The side event organizers should make their own arrangements regarding UN ground passes for individuals, invited as speakers or guests to the event.
- 17. The charges for the use of the conference rooms and the equipment should be covered by the organizers in advance to their side event.

#### **Submission of Proposals**

#### How to submit a side event proposal

Anyone interested in organising a side event at a session of the Commission on Sustainable Development must submit a proposal using the Side Event Request Form and attach a detailed description of the proposed event, including its thematic focus, speakers/presenters and its potential contribution to the 12<sup>th</sup> session of the Commission. ## Deadlines for submission of proposals:

Proposals for side events at the 12<sup>th</sup> Session of the Commission on Sustainable Development (New York, 19 - 30 April 2004) must be submitted by 9 March 2004.
