**Mr. Chairman,**

**It is a great pleasure and honour to address you all on behalf of Bosnia and Herzegovina on the occasion of the preparation of very important global event in the world, where the Rio + 20 process and Sustainable Development all over the World will be evaluated and defined further steps towards cleaner, greener and sustainable future.**

**As a country with the Economy in Transition Bosnia and Herzegovina associates itself with the statements made by European Union.**

**At a this meeting we want to emphasize a great importance of UN Conference on Sustainable Development and it is our pleasure to work together with other countries in the process of preparation of Outcomes Documents.**

**We want to stress that all the catastrophes that occur around the Globe carry the message on the necessity of turning towards the Green Economy, which will ultimately lead us to the Sustainable Development.**

**We think that human society, at present, can find the answers to achieve Sustainable Development only in harmony with nature which will be defined through the global political documents, and with the synergies of Three Rio Conventions. Any opposite actions lead towards new eco-systems degradation and made a huge negative impact on environment and people.**
