



MEETING SUMMARY

Meeting of the Multi-stakeholder SDG 7 Technical Advisory Group

12 July 2018, UNHQ - New York

The multi-stakeholder SDG7 Technical Advisory Group (SDG7 TAG) met on Thursday 12 July 2018 at the United Nations Headquarters in NY in the margins of the High-Level Political Forum. Ms. Sheila Oparaocha of ENERGIA and Mr. Hans Olav Ibrenk of Norway, the co-facilitators, kicked off the meeting. The Agenda is attached in [Annex 1](#). Main Issues:

1- HLPF 2018.

- a. **An official SDG 7 review** was held on Tuesday 10 July at the High-Level Political Forum. Discussions highlighted challenges and opportunities for advancing SDG7 informed by many advancements being made on the ground. Chaired by President Marie Chatardová, moderated by Mr. Adnan Amin, DG of IRENA, and joined by three of the SDG7 TAG members as speakers (Ms. Sheila Oparaocha, Mr. Hans Olav Ibrenk and Mr. Riccardo Puliti), SDG7 Policy Briefs served as a point of reference during the interactive dialogues as Member States and other stakeholders shared their perspectives for the accelerated achievement of SDG7 and other SDGs.
- b. **Ministerial Declaration** was still under silence procedure. Judging from the latest draft, it was very evident that SDG7 Policy Briefs, especially the Summary for Policy Makers including the Global Agenda for Accelerated SDG7 Action, have substantively informed the orientation of the ministerial declaration on the part of SDG 7. More detailed reporting of the session will be captured in the summary of HLPF 2018 by the President of ECOSOC, to be released after HLPF.
- c. **Side events:** Over 20 official side events and high-level gatherings related to SDG7 are being organised by SDG7 TAG member organisations in collaboration with many other partners.

2- SDGs Progress Monitoring.

- a. **Secretary General's annual SDGs progress report** was launched on Tuesday 10 July 2018, at the High Level Political Forum, including a short global highlight on SDG7 progress contributed by the 5 custodians of SDG 7 indicators.
- b. **Custodians of SDG7 indicators** shared a good progress being made on their collaborative efforts in working toward the 2019 SDG7 Tracking Report, including their expected new governance structure and possible funding arrangements. Representatives of the UN Regional Commissions also noted their intention to continue working on regional SDG7 tracking reports in the future.

- 3- **SDG7 TAG's Draft Workplan 2018-2019.** An overview of the proposed work plan for the SDG7 Technical Advisory Group ([Annex 3](#) - under separate cover) was presented with a focus on: a) turning the Global Agenda for Accelerated SDG7 Action into action, b) contributing to the HLPF 2019 focusing on energy's linkages with those SDGs to be reviewed in 2019, and c) convening global gatherings on SDG7, at a high level, in support of HLPF 2019 and SG climate Summit. The Group endorsed the proposed workplan, noting that the proposed three focus areas provided the

solid basis to elaborate specific activities to be conducted over the next one year. The Group stressed the need for focusing on a few value-adding outputs. It was emphasised that the Group must continue supporting HLPF by providing relevant technical inputs (e.g. focusing on energy's linkages with the SDGs 4,8,10,13,16 and 17 to be reviewed in 2019) and helping translate its political decisions into action. The Group noted that while global gatherings would be useful, synergies should be created with existing and planned international gatherings to maximise impacts, reduce duplications and effectively contribute to key milestones including UNFCCC/COP, the midpoint of the UN Decade of Sustainable Energy for All 2014-2024, the mid-term review of Samoa Pathway and the Secretary-General's Climate Summit in September 2019.

Conclusion and Next Steps:

The Group members enthusiastically welcomed the continuation of the SDG7 Technical Advisory Group, based on the proposed workplan for 2018/2019. They agreed on the need for diverse composition of the Group taking into consideration multi-stakeholders' perspectives and geographical balance with more participation from developing countries. The Group should, as well, develop clear working arrangements that will enable substantive participation and contributions of its members. DESA as secretariat will prepare Terms of Reference of the SDG7 Technical Advisory Group, along with a plan of activities based on the endorsed workplan as well as a more balanced suggested membership of the group, for discussion.

It was proposed that the next meeting of the SDG7 Technical Advisory Group would take place in Geneva on 2 November 2018, hosed by WHO, back to back with the first Global Air Pollution and Health Conference 30 Oct – 1 Nov 2018.

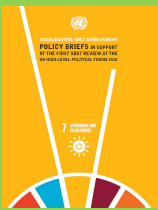

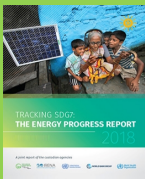
