### **Foreword**



In September 2015, Governments worldwide adopted the 2030 Agenda for Sustainable Development, with 17 ambitious goals (SDGs) at its core. Many see in this historic moment a cause for hope. That hope, however, may dwindle before the stark contrast between the transformative vision and aspirations set forth in the agenda, and the current state of affairs in the Arab region. The Arab Sustainable Development Report depicts a situation that warrants serious concern: dramatic increases in conflict, violence and terrorism; rising numbers of refugees and internally displaced persons (IDPs); persistent injustice; mounting frustration over unemployment and rising rates of poverty; unequal access to, and overexploitation of, scarce water and other natural resources.

This report explores a number of reasons for this apparent development impasse. It contends that, despite the significant progress made, especially in education, health and gender equality, the region still faces a number of persistent challenges. Education systems fail to prepare youth to participate in the

modern economy. The vast majority of women are denied opportunities to contribute to economic and public life. The rentier structure of the economy in some countries prevents growth from translating into the well-being of citizens. Accountability and governance deficiencies undermine the legitimacy of Governments. Opportunities for regional integration, resource mobilization and the use of science and technology continue to be missed. Moreover, brutal political forces continue to plague the region, including the only remaining physical occupation in the twenty-first century, that of Palestine.

In a globalized world, countries do not suffer alone. Troubles in the region affect neighbouring countries and regions and even those further away. Solidarity is essential: we all have an interest and the obligation to act, and we have the means to do so. The 2030 Agenda is first and foremost a guide for national action, but its main value is in stimulating a new phase of global cooperation.

The Arab region is at a crossroads. It could continue to be mired in the status quo of occupation, conflict, inequality, division, frustration, development stagnation and, ultimately, disintegration. Or it could heed the aspirations of people in the region and embark on the path of sustainable development, ending the occupation of Palestine, achieving peace, providing quality education and empowering women. That is the path that will ensure dignity and well-being for all, men and women alike, irrespective of age, origin, religion, ability, or social and economic background.

We at the Economic and Social Commission for Western Asia (ESCWA) and the United Nations Environment Programme (UNEP) support those who are striding out along that second path towards the future we want. We hope this report will provide a useful contribution to that noble pursuit.

## **Preface**

The Arab Sustainable Development Report 2015, being launched on the start date of the 2030 Agenda for Sustainable Development in early 2016, comes at an opportune time: it provides a comprehensive review of sustainable development progress and trends in the Arab region over the past two decades and analyses the current situation, looking at how sustainable development might be achieved and the obstacles that must be overcome.

By March 2016, Member States of the United Nations are expected to agree on a set of global indicators to measure progress in implementing the agenda. This first edition of the report relies on published data relevant to the themes of the 17 Sustainable Development Goals (SDGs). Future editions will be realigned with the global indicator set. People are placed at the heart of this report's integrated framework of analysis, which highlights the links between the five Ps of the agenda: people, planet, prosperity, peace and partnerships.

The report illustrates the extent to which human dignity and well-being have been secured in the region, and assesses Arab societies and their modes of living through the lenses of sustainability and resilience. Cross-cutting prerequisites and means of achieving sustainable development are examined. The report sheds light on a blend of factors: the occupation of Palestinian and other Arab lands, the prevalence of conflict, and governance, human rights and institutional deficits. It also examines gaps in the areas of financing, science and technology, trade and statistical capacity.

The report reveals that, although significant progress has been made in some sectors and subregions, complex and interlinked economic, social, environmental and governance challenges remain. Urgent action is needed at the national and regional levels, in the context of a more effective global partnership. The report concludes that the path to sustainable development necessarily passes through integrated, long-term and evidence-based planning and investments that take into account the risks and consequences posed by the turmoil in the region, and address its root causes.

Preparation of the report was challenging in two ways. Data covering the 22 Arab countries and spanning the past two decades are incomplete. In some instances, significant data gaps prevented the identification of trends and the calculation of averages for all country groupings. That raises questions about the capacity of Arab countries to make the best use of evidence in policymaking, and about future reporting on the 2030 Agenda. The second difficulty was how to accurately depict the situation in a region that is in constant flux. For example, no data seemed up-to-date enough to capture population movements due to instability and their impact on key development indicators. Nevertheless, we believe that the analysis provides a solid basis for assessing sustainable development in the Arab region in future issues.

The report is the outcome of a joint effort involving a wide range of United Nations agencies in the Arab region, regional and international experts and stakeholders, and national Governments. We would like

to thank all contributors for their input. Our appreciation also goes to the core team members, who showed the utmost commitment in preparing a report that, we hope, will reflect global momentum and stimulate a frank dialogue on how to fulfil the aspirations of this region's people.



### 1. Overview

The people of the Arab region face an uncertain future. Millions are fleeing their homes to escape violence and millions more remain trapped by conflict or in occupied territory. The expanding population is placing increasing strain on the environment through unsustainable consumption of limited water supplies and abundant energy resources. The rentier economy that prevails in many countries has proven unable to adapt to new realities or absorb the growing and increasingly youthful labour force.

Nevertheless, the region has a solid base on which to build a better future. Improvements in health care have lead to a life expectancy well above the global average. The population is increasingly educated; school enrolment and adult literacy have improved considerably, especially in the least developed countries (LDCs) and for females. Those accomplishments mean that the region is well placed to meet the challenges of sustainable development that lie ahead.

The region's challenges and priorities are well reflected in the 2030 Agenda for Sustainable Development and its 17 Sustainable Development Goals (SDGs).1 The SDGs maintain the focus of the Millennium Development Goals (MDGs) agenda on eradicating poverty in all its forms, emphasizing the interdependence of development issues and covering themes not fully addressed in the MDGs, including equality, governance and promoting peaceful and inclusive societies. In the agenda, it is recognized that, although the goals are universal, each country has its own realities, capacities and policies: each country is firmly in the driver's seat in terms of setting targets,

designing policies and monitoring and reporting progress.

At this juncture, the authors of the Arab Sustainable Development Report asked: Where does the Arab region stand with regard to the SDGs and what were the trends over the past two decades? What is hampering sustainable development? Where is the region heading and what alternatives are available in order to bring the SDGs to fruition? This report attempts to provide answers within an integrated framework that places the dignity and wellbeing of people in the region at the heart of its analysis.

#### A. Purpose of the document

This report reviews the current situation in the Arab countries in relation to sustainable development. In particular, it uses regional and global benchmarks to aid in examining progress over the past two decades, trends, and remaining gaps and opportunities. It also includes examples and cases from the region. In the absence, at the time of writing, of globally adopted SDG indicators, authors selected a set of indicators guided by a number of criteria, including data availability for Arab countries, with preference given to the Sustainable Development Indicators for the Arab Region adopted by the League of Arab States.<sup>2</sup> Although the report covers the themes of the 17 global SDGs, it emphasizes the issues of highest priority to the Arab region.

One aim of this report is to provide national stakeholders with evidence-based information to be used for establishing targets, designing policies and monitoring/reporting progress.

It should also help regional stakeholders to advocate for change.

#### B. Scope and methodology

This report has been produced at the request of Arab Governments.<sup>3</sup> In addition to input from experts and United Nations agencies, five Arab countries conducted national sustainable development assessments that provided a wealth of examples. The Arab Forum on Sustainable Development, which met in April 2014 in Jordan and in May 2015 in Bahrain, constituted important milestones in the preparation of this report. See annex I for the participatory methodology for preparing the report.

The report focuses on the Arab region. As far as possible, it includes data on all 22 Arab countries and provides comparisons between the Arab region and other regions, while benchmarking with global averages. Due to lack of data, not all countries are included for all indicators.

The region's considerable diversity makes it indispensable to break it down into the following subregions: the Gulf Cooperation Council countries (Bahrain, Kuwait, Oman, Qatar, Saudi Arabia and the United Arab Emirates); the least developed countries (the Comoros, Djibouti, Mauritania, Somalia, the Sudan and Yemen); the Maghreb countries (Algeria, Libya, Morocco and Tunisia); and the Mashreq countries (Egypt, Iraq, Jordan, Lebanon, Palestine and the Syrian Arab Republic). This breakdown has its limitations, but it enables the consideration of geographical proximity and development level criteria at the same time. It is also in line with the methodology adopted in previous Millennium Development Goals Reports.

Because international agencies use different country classifications, some parts of the analysis could not be presented using the Arab regional focus. For example, analysis from the World Bank and some United Nations agencies is based on the Middle East and North Africa regional classification, while analysis from the United Nations Environment Programme (UNEP) divides the Arab countries between the regions of Africa and Western Asia.

While acknowledging the limitations of nonnationally sourced statistics, data in this report were collected from a range of official databases, mainly from the United Nations system (see annex II). They cover the period from 1990 until 2015. A review of country experiences on monitoring and evaluation for the post-2015 period by the Economic and Social Commission for Western Asia (ESCWA) identified significant gaps in data for MDG national reporting.<sup>4</sup> Official country data was therefore not sourced directly from national statistics offices owing to problems concerning comparability, quality and the availability of time series in most of the 22 countries.

# C. Framework of analysis and organization of the document

In the report, issues are analysed in clusters in a way that highlights links between them. The



report starts with a snapshot of trends in the Arab region today using the themes of the 17 SDGs. The remainder of the report is organized in accordance with a framework developed in consultation with Governments, experts, civil society and other stakeholders. Five other frameworks considered for the report are presented in annex III.

The adopted framework (figure 1.1), with its four nested areas, recognizes:

- The need to place human dignity and wellbeing at the core of the analysis, so that all people in the Arab region might fulfil their potential and achieve their aspirations.
- The link between those core objectives and the natural resource base. Achieving wellbeing of populations will depend upon, and have a significant impact on, the environment and natural resources. For societies to be resilient and sustainable, economies will need to be transformed and decoupled from environmental decline, and ecosystems will need to be sustainably preserved.
- The importance of peace, governance and effective institutions as goals in themselves and as cross-cutting factors contributing to sustainable development.
- The role of the means of implementation, such as finance, technology, trade and data,

and the importance of partnerships, for addressing existing gaps.

Based on this framework, the report includes four core chapters (3 to 6) on human dignity and well-being; sustainable and resilient societies; peace, governance and institutions; and means of implementation and partnerships for sustainable development. Figure 1.2 shows the relationships between the framework, the report's core chapters and sections, and the 17 SDGs. A thorough regional reading of the SDGs and their corresponding targets took place ahead of their inclusion under one of the four nested areas. The framework reflects in part the outcome of negotiations on the global agenda in early 2015 and regional priorities. The principle challenges facing the region concern occupation, conflict and instability, and governance and institutional deficits. Those issues constitute the main elements of this report.

#### D. Summary of analysis

#### 1. Human dignity and well-being

Although significant progress was made on some MDGs, it was uneven across the Arab region. Some goals have remained elusive and new challenges have emerged.

Growth has remained relatively high but there has been little change in economic structure over the past two decades. The rentier structure of the economy in most countries means that growth has little impact on human well-being. Productivity growth rates have been low and wages as a share of gross domestic product (GDP) have declined. Economic opportunities have expanded too slowly to fully employ the growing labour force. Unemployment remains the highest in the world, with moderate gains for women offset by commensurate losses for young people.

The region is well below the global average in terms of poverty incidence (based on the international poverty line), but inequality of opportunities and income has fuelled conflict in several countries, unleashing waves of refugees and internally displaced persons (IDPs) who have thus been plunged deeper into poverty.

Gender equality has increased in several important respects, including employment and political representation. Nevertheless, shortfalls remain significant relative to global benchmarks, especially considering the high levels of educational achievement in the Arab region. The failure to match educational achievement with analogous employment and gender outcomes is due in large part to the incapacity of the region's economies to generate employment, in addition to problems regarding the quality of education and its relevance to the labour market.

Across the Arab region, up to 195 million people gained access to improved sources of water and sanitation between 1990 and 2015. However, growth in the provision of water has not kept pace with population growth in the LDCs, where the share of the population with access to water has fallen. Access to electricity is almost universal in three of the four subregions. In the LDCs, however, the degree of access is less than half the regional average and has seen little improvement since 2000. There has been significant progress in eliminating slums, except in the LDCs. The existing housing shortfall (estimated at over 3.5 million units) is being aggravated in several countries by war, occupation and conflict.

Hunger and malnutrition in Arab countries is not a problem of food availability, but rather affordability. Despite significant progress in some subregions, undernourishment has remained constant in the Arab region and the nutritional status of children in the LDCs has deteriorated. Access to health care has generally improved, reflected in favourable

trends in child and maternal mortality rates. As communicable diseases become less of a problem, non-communicable illnesses such as heart disease, diabetes and mental disorders are becoming more of an issue. Violence and conflict are creating additional health concerns for the region.

#### 2. Sustainable and resilient societies

The population of the Arab region has grown significantly in the past decades and exceeded 377 million in 2014. The urban population of Arab countries accounted for 57 per cent of the total, slightly above the global average of 53 per cent. The 215 million people living in Arab cities and urban areas require large public investments in infrastructure to provide essential services such as housing, roads, energy, water, waste and wastewater management, and other utilities.

Nowhere more than in the Arab region, where the scarcity of water is a defining characteristic, is the link between water, food and energy so keenly felt. Per capita water resources available in the Arab region represent 10 per cent of the global average. The scarcity and degradation of water and arable land, the arid climate and the erosion of genetic resources all place limits on food production. The agricultural sector is by far the largest consumer of water in the region - a common occurrence in arid regions - while water productivity and irrigation efficiencies are well below global averages.

Water scarcity has led some Arab countries to invest heavily in desalination, and the region now accounts for more than half the world's desalination capacity. This has implications for energy security and carbon emissions (unless renewable energy desalination is considered)<sup>7</sup> and contributes to the deterioration of marine ecosystems. Energy is also needed to lift, move, process, and treat water at every phase, and water is used in power generation and oil exploitation.

The consumption of resources such as water and energy in the region is increasing at rates that cannot be sustained, and new approaches are urgently needed. A water-food-energy nexus approach could "ensure coherence across policies, initiatives and projects at the national and regional levels, taking into consideration differing natural resource endowments across countries of the region, with a view to minimizing negative trade-offs across sectors".8

Over the past several decades, the region has seen an increase in droughts, storms and floods. Droughts affect the largest number of people and earthquakes, followed closely by floods and storms, which cause the worst damage to infrastructure. Expanding cities have become concentrated hubs for economic development and are increasingly vulnerable to the risk of natural disasters.

Climate change is exacerbating the intensity and frequency of extreme weather events and the region is more likely than others to be affected by rising temperatures. It is predicted that it will experience growing variability in precipitation, which may have detrimental consequences, especially for agriculture-based communities. The impact of climate change on environmental migration and shared water resources has been found to fuel conflict.9

Although Arab countries are considered under annex II of the United Nations Framework Convention on Climate Change and are not formally bound to greenhouse gas emission reductions, some are making voluntary efforts to reduce emissions. Several Arab countries have prepared statements of their Intended Nationally Determined Contributions. However, the increase in per capita greenhouse gas emissions and the regional economy's carbon intensity is worrying.

Marine and terrestrial ecosystems are facing significant pressures due to misuse and biodiversity degradation. Vegetation cover is

shrinking and the sharp rise in average annual fish-catch rates for Arab countries over the past two decades has put a strain on fish stocks. On the positive side, Arab countries have acted to preserve their biodiversity, including through the expansion of protected areas.

#### 3. Peace, governance and institutions

The links between peace, governance and effective institutions for development are evident. By 2015, the Arab region had overtaken South Asia as the least peaceful part of the world. The Israeli occupation of Palestine continues and conflicts have worsened in Iraq, Libya, the Syrian Arab Republic and Yemen. Conflict and criminality have led to hundreds of thousands of fatalities and massive displacement. In 2015, about 7.6 million Syrians were IDPs and 4.1 million were living as refugees, mostly in neighbouring countries.<sup>10</sup> More than 2 million Somalis are displaced within or outside their country.11 These numbers are in addition to the 5.2 million Palestinian refugees.<sup>12</sup>

A major cause of the Arab uprisings was the desire of citizens for a greater say in political decision-making and more accountability. In certain cases, their demands led to change. Improvements came in some cases, such as with free and fair elections, but in some respects matters have deteriorated, such as with freedom of expression. Variations between countries are considerable. The recent record of fairness and justice has been similarly mixed: although improvements have been made in the majority of Arab countries with regard to the separation of powers, things have worsened in terms of misuse of public funds and cronyism. Legal identity continues to be a concern. Many Palestinians, the Bidun and children whose fathers are not citizens of the relevant country are often considered stateless. The increase in the number of refugees across the region has highlighted the need for a unified regulatory framework for refugee status and asylum in Arab countries.

Several countries in the region are showing the way with examples of good practice that may serve as models for others. Indeed, some countries have demonstrated growing capacity to implement strategies with a broad ownership, harmonize short-term actions with long-term priorities, coordinate across sectoral ministries, and make full use of evidence. At the regional level, institutional mechanisms are being established and strengthened in order to support national stakeholders in this work.

## 4. Means of implementation and partnerships for sustainable development

Estimating the finance needs in the Arab region for achieving sustainable development is difficult. Based on the methodology used in this report, and acknowledging its limitations, it would appear that the LDCs have, contrary to expectations, lower financing needs than middle-income countries. The financing gap can be narrowed through tax and subsidy reforms and by rationalizing military expenditure. International flows are significant sources of finance for the region.

Official development assistance (ODA) received by the Arab countries, including from Arab development funds, peaked in 2005, decreased thereafter, and picked up again in 2012. Foreign direct investment peaked in 2008 at \$97 billion and has declined since, reflecting the need to restore stability, reduce risks and improve the investment climate. Similarly, intraregional investments have been decreasing since the 2008 peak of \$35 billion. Remittances constitute a sizeable source of finance in some countries (Egypt, Lebanon and Morocco). Public-private partnerships are concentrated in energy and transportation projects and require adequate legal and institutional frameworks to ensure their sustainability. Only a few Arab countries have tapped into green finance opportunities.

The Arab countries have strived to develop their national systems of science, technology and innovation over the past decades. Most have increased access to information and communications technology at rates exceeding the global average. However, the Arab region remains mostly a user of technology, with knowledge generation remaining very low relative to the rest of the world and even to developing countries. The little knowledge generated is not benefiting the productive sectors due to weak and undiversified economies.

The region's share of the world's nonoil exports remains modest and it is less economically integrated than other world regional groupings. Bilateral and other trade agreements with non-Arab countries and groups have been signed much faster than intraregional agreements, which remain stalled mainly for political reasons.

Statistical capacity in the Arab region remains limited. Many Arab countries were unable to report fully on the 45 MDG indictors using their national official data. The situation will be exacerbated with the anticipated 100+ global indicators to be used for monitoring the SDGs. The data gap has prevented Governments from fully benefiting from evidence in replacing failed policies. The success of statistical capacity development efforts will depend on the willingness of Governments to improve transparency and accountability.



# 2. Snapshot of Trends and Status in the Arab Region

This chapter provides information covering a range of indicators structured along the themes of the 17 SDGs (table 2.2). Many crucial issues could not, however, be included due to lack of data. The remainder of the report elaborates on these and many other issues. Weather symbols are used to characterize sustainable development trends over the past two decades (table 2.1). Such symbols are often used to benchmark progress against a specified quantitative target. Given the absence of such targets in the Arab region in most of the thematic issues reviewed, the symbols were usedhere

to highlight whether regional or subregional trends could be considered favourable or unfavourable. The regional average value for each indicator is benchmarked against the MDG target or world average, where these are available or applicable, using traffic lights (RED or GREEN) to indicate how the Arab region compares against world averages and MDG targets. In future reports, evaluations for the SDGs should focus on progress with regard to quantitative targets.

The use of such symbols in the evaluation of trends and progress is limited by the absence

of quantitative targets in most instances. The evaluation represents the views of the authors and is primarily aimed at promoting discussion on sustainable development between stakeholders.

Data were collected from official databases of the United Nations and other international and regional organizations. Trends were reviewed for the Arab region as a whole and the four subregions. Due to considerable data gaps, the methodology relied on only two data points (one for the early 1990s and another for the late 2000s, unless otherwise specified), which provided a basic interdecadal trend analysis for each indicator. The evaluation of each indicator was based, as far as possible, on the evolution of the indicator between 1990 and the latest year of data available for the Arab region. The methodology and data sources are detailed in annex II. Each indicator was graphically

represented to show its trend for the Arab region and each of the four subregions, and trends were then interpreted using the weather symbols and rules provided in table 2.1.

For each indicator in table 2.2, traffic symbols show the current regional status compared to the world, whereas weather symbols reflect past trends in the region and subregions. However, these need not be correlated. For example, a red traffic light with a sunny weather symbol implies significant progress, but the situation is still below the world average or the MDG target has not been met, and further improvement is needed. Furthermore, while individual indicators are provided under each SDG, it is often necessary to look at a cluster of indicators in order to get the full picture of the situation and prospects for achieving the SDG under consideration.







# 3. Human Dignity and Well-being



Achieving human dignity and well-being in accordance with human rights is central to sustainable development efforts. This means that economic growth should be inclusive and provide opportunities for all people to achieve their full potential through decent work, the eradication of poverty, quality education, and the reduction of income and gender inequality. In addition to opportunity and equality, human dignity and well-being also require access to the basic necessities of life, including water and sanitation, energy, food, health and housing.

Relatively high economic growth has had little positive impact on human well-being in the region. Opportunities have increased too slowly to fully employ the growing labour force, and unemployment rates are the highest in the world, especially for young people. Shortcomings in terms of the quality of education and its relevance to the needs of the labour market have exacerbated the

situation. Gender gaps remain wide relative to global benchmarks. Although poverty in the region based on the international poverty line is well below the global average, inequality of opportunities and income has remained high. There is a high degree of poverty among refugees and IDPs.

Across the region, a large chunk of the population gained access to an improved water source and improved sanitation facilities between 1990 and 2015. Three of the four subregions boast almost universal access to electricity. There are, however, significant shortfalls in the LDCs in terms of access to these services. Progress on eliminating slums has been significant, again with the exception of the LDCs. Undernourishment remains a constant in the Arab region and nutritional status of children has deteriorated in the LDCs. Access to health care has improved across the region, reflected in favourable trends in child and

maternal mortality rates. As communicable diseases are increasingly brought under control, non-communicable diseases are taking their place as a source of concern. Warfare and conflict are creating additional health problems in the region.

This chapter is largely based on issues briefs and expert papers prepared for the report on gender, social development, economic growth, poverty, employment, inequality, industrialization, energy, water and food.<sup>1</sup>

# A. Opportunity and equality

# 1. Inclusive growth




Figure 3.1. GDP growth rate (percentage)

GDP in the region has grown strongly over the past decades, however, it has declined more recently due to conflicts (figure 3.1). Although GDP growth has been relatively strong, GDP growth per capita has been considerably weaker due to increases in population (figure 3.2), highlighting that the Arab region has not been as successful as some other regions in translating growth into greater well-being for its population.




Figure 3.3. GDP per capita (thousands of constant 2005 United States dollars)

The regional average of \$4,795 per capita in 2014 was well below the global average of \$8,055.2 However, there is significant variation across the region, with the oilexporting GCC countries registering close to three times the global average, while the LDCs register just 11 per cent of the global average (figure 3.3).

### (a) The demographic window of opportunity

The population of the Arab region grew by 70 per cent between 1990 and 2014, from 221 million to 377 million. Although growth continues, rates have slowed since the late 1990s (figure 3.4), indicating a shift in age distribution. The decline in the ratio of children and elderly to the working age population means that the dependency ratio has decreased significantly across the region.<sup>3</sup> Data show that the proportion of dependents per 100 working-age people dropped by around 31 per cent between 1990 and 2015.

The current average regional dependency ratio for Arab countries of 60.16 per cent is still above the global average of around 54 per cent in 2014.4 Trends were particularly favourable for the GCC and Maghreb

subregions, which now have ratios below the global average (figure 3.5).

The current age distribution is often considered a window of opportunity

because a greater share of the population is now available to contribute to production. However, that only applies if the working age population is productively employed. The Arab countries have been less able to benefit from this opportunity than many




Figure 3.6. Economic structure of Arab countries (percentage share of sector in GDP)

other regions because of low employment to population rates.

#### (b) Economic structure and productivity

The economic structure of the Arab countries has changed little since the 1990s. Despite some shifts, oil, gas and mining still comprise 41 per cent of GDP in the oil-rich countries and almost 10 per cent in the non-oil rich countries (figure 3.6). The emphasis on oil, gas and mining is important because these sectors generate little employment relative to other sectors. In Iraq, for example, petroleum accounts for more than half of GDP, but less than 1 per cent of employment. The service sector, a high employment but low productivity sector, comprises a large and growing share of GDP. Agriculture represents a small share of GDP, but is an important source of livelihoods for many of the rural poor. Manufacturing remains a very small part of most Arab economies. Moreover, within manufacturing, there is a greater emphasis on lower technology manufacturing than would seem to be warranted by the region's

generally high level of education. Indeed, only 1.5 per cent of manufactured exports in the Arab region in 2008 were considered to fit into the high-technology category, compared to a global average of 17 per cent.<sup>6</sup>




Figure 3.7. Productivity growth rate, 1991-2010

Higher productivity leads to increased wages, which enhances social expenditure and skill development and further productive capacity through a virtuous cycle. The region's low productivity reflects the service-focused structure of the economy. The productivity growth rate (defined as output per worker) of the Arab region over the period 1991-2010 was only 0.9 per cent, the lowest of the world's regions (figure 3.7).

Productivity can increase if the region's technological readiness and capacity to innovate are improved. According to the World Economic Forum's Global Competitiveness Index (GCI), technological readiness, defined as the agility with which an economy adopts existing technology to enhance productivity of its industries, has improved throughout the region over the past




Figure 3.8. Global Competitiveness Index: Technological Readiness Score

decade (figure 3.8). As of 2015, the United Arab Emirates is within the top quintile worldwide, and the worldwide median score is 3.7. However, capacity to innovate, as

measured in the GCI by a number of research and development input and output indicators, remains low and has actually declined over the past decade in half of the countries of

the region (figure 3.9). As of 2015, Qatar and the United Arab Emirates are within the top quintile worldwide, while Algeria, Egypt, Lebanon, Libya, Mauritania and Yemen are within the bottom quintile worldwide. The worldwide median score is 3.3.




Figure 3.12. Percentage of adult saving by method used, 2011

Investment is an important driver of productivity. Fluctuations in gross capital formation (investment in fixed assets) are often seen as a reflection of future business activity, business confidence and the pattern

of economic growth. Average gross capital formation has increased in the region over the past two decades by more than 25 per cent, with the 2000s value reaching 27 per cent of GDP (figure 3.10). This has

been driven by considerable increases in capital investment in the LDCs (up by 56 per cent), GCC countries (up by 40 per cent) and the Maghreb (up by 53 per cent). The Maghreb achieved the highest level of capital investments (39.88 per cent of GDP). However, the Mashreq saw a drop of 30 per cent in capital formation as a percentage of GDP, reflecting recent and ongoing conflicts.

Foreign direct investment (FDI) generally brings with it new technology and new ways of organizing production. Average net FDI inflows as a percentage of GDP increased significantly across the region between 1990 and 2008, decreasing steadily since then to reach a low of 1.68 per cent, well below the global average of around 3 per cent in 2013. Increases in FDI rates were evident across all four subregions, with the LDCs registering the highest increase (figure 3.11), but rates in 2013 for the Maghreb and GCC countries were well below the global average. A more detailed analysis of FDI is presented in chapter 6.

Domestic investment is also crucial to productivity growth, particularly of small and medium enterprises. A well developed financial sector is essential for the efficient mobilization of domestic savings and allocation of credit. The Middle East<sup>7</sup> ranked lowest among world regions in 2011 in terms of the percentage of adults saving money by any method – and especially low in terms of formal savings (figure 3.12). This restricts investments, which come either from own savings or by borrowing from the savings of others. Adults in the region rarely make use of financial institutions.8 Inward remittances are also important as a source for private investment (e.g. education and housing) and consumption. Egypt is the world's sixth largest recipient of remittances (\$20 billion in 2014). Lebanon is in tenth place (\$9 billion in 2014). The region as a whole is expected to bring in \$53 billion in 2015.

#### 2. Jobs

GDP growth improves the well-being of the population in several ways, most directly




Figure 3.14. Employment in agriculture (percentage of total employment)

by increasing labour earnings, but also by increasing government revenue (for example, tax) that can be used for services (education, health, water and sanitation) and social protection transfers. This section looks at labour earnings. Social protection is addressed in the section on poverty and inequality, and other public services (such as health and education) are discussed in corresponding dedicated sections.

# (a) Employment reflecting the structure of the economy

Employment in industry in the region is about the world average of 24 per cent, and lower still in non-GCC countries. It has fallen in several Arab countries, including Jordan, Kuwait, Morocco, Palestine, Saudi Arabia, and the United Arab Emirates (figure 3.13).

Similarly, employment in agriculture fell significantly in a number of Arab countries, especially in Algeria, Egypt, the Syrian Arab Republic and Yemen. Morocco constitutes a notable exception: employment in agriculture

rose sharply to exceed 39 per cent in the 2000s (figure 3.14).

A feature of the rentier economy and the concomitant social contract between the State and the population is the large share of service jobs in the public sector. In most Arab countries, Governments are the primary employer, accounting for 14 to 40 per cent of the total workforce. Bloated public sectors, including government agencies and Stateowned enterprises, employ 22 per cent of Tunisians, and 33 to 35 per cent of Syrians, Jordanians and Egyptians.

In recent decades, Governments have become unable to guarantee employment, while the private sector has been insufficiently developed to absorb the expanding labour force. Morocco, however, has met with success in addressing the problem (box 3.1). Elsewhere, inadequate labour income, reduced food subsidies, and high unemployment among young graduates were among the chief causes of distress that led to the Arab uprisings.

#### Box 3.1. Lesson learned from civil service reform in Morocco

Civil service reform in Morocco, particularly an act on retirement reform, made it possible to deflate the bloated civil service, provided competencies frameworks for the future, and encouraged retirees to enter business. Faced with excessive centralization, lack of performance, ineffective resource allocation and a rigid civil service structure, the Government initiated, in 2004, a programme aimed at restructuring its civil service, dubbed Intilaka ("the launch"). At the beginning of the programme, 856,000 employees, or 2.3 per cent of the population (relatively low when compared with countries such as Algeria, with 4.2 per cent), made up the civil service, with a wage bill reaching 12.8 per cent of GDP in 2004. The Government aimed to encourage voluntary retirement with financial incentives and planned for almost 59,000 employees to leave service between 2005 and 2011, and 97,000 between 2012 and 2018.

Although initially success was limited, by 2005 the wage bill had dropped from 12.8 per cent to 10.6 per cent of GDP. Competencies frameworks were established and a new system of performance evaluation took into consideration quality of work, innovation, ability to achieve and productivity. As a result, the civil service was cut back, strain was taken off the budget, government effectiveness and management of human capital were improved, and former civil servants were encouraged to enter the private sector. This "positive spillover" of civil service reform, linked to the reform of public financial management, helped to achieve a smaller wage bill, provide new incentives for market entry, develop a new class of entrepreneurs, stimulate the private sector, and ultimately create new jobs and reduce unemployment. Similar models could be applied in other Arab countries, such as Egypt, Lebanon and Tunisia.




Figure 3.15. Employment to population ratio (aged 15+)

### (b) Employment

The ratio of employment to population<sup>12</sup> has remained largely unchanged in recent decades and is the lowest in the world (figure 3.15). The ratio for 2013 was 44.6 per cent, which falls

well below the global average of 59.6 per cent in 2013. <sup>13</sup>

The youth employment-to-population ratio fell by nearly 11 per cent over the two decades from 26.7 in 1991 to 23.7 per cent in 2013, and




Figure 3.18. Youth unemployment rate (percentage of total labour force aged 15 to 24)

was well below the global average of 41.2 per cent in 2013. Declines are evident across all four subregions, with the Mashreq registering the lowest level in 2013, at 20 per cent (figure 3.16). Moreover, better educated youth were more likely to be unemployed than their less skilled counterparts, which highlights challenges faced by young people in making the transition from school to work and meeting the requirements of the labour market.

A large share of the labour force is unemployed, as has been the case consistently since the 1990s. In 2013, the unemployment rate for the region was 11.41 per cent, almost double the global average of 6 per cent (figure 3.17). The unemployment situation is even more challenging for women (a detailed analysis of gender issues is provided later in the chapter).

Youth unemployment in the Arab region has been alarmingly high since 1991 and by 2013 had reached around 30 per cent (figure 3.18), more than double the global average of 14 per cent.<sup>14</sup> In some countries, youth unemployment has structural causes that

would require remedies to encourage private sector investment.

#### (c) Quality of jobs




Figure 3.19. Labour income as a percentage of GDP

The regional economy not only fails to generate sufficient employment: its structure is such that the jobs available are often poorly remunerated and insecure. Low productivity growth has meant low wage growth. Average GDP growth of 4 per cent in the 1990s and 2000s was matched by real wage growth of 1.89 per cent. In other words, the employers and capital-holders have benefitted more from economic growth than workers. In fact, the Arab region is the only one in which real wages have declined in recent years, dropping by 2.7 per cent between 2006 and 2011.15 Labour income as a percentage of GDP declined from 30.5 per cent in 2000 to 27.6 per cent in 2010 (figure 3.19).16

Low productivity growth and limited employment gains have led to an expansion of the informal sector, generally made up of lowly paid, low quality and low productivity jobs. People employed in the formal sector in the

region represent only 19 per cent of the working age population (compared to 27 per cent in Latin America and 40 per cent in Eastern Europe).<sup>17</sup>The share of vulnerable employment (own-account and contributing family workers) in total employment has remained fairly stable over the past two decades.

#### (d) Economic migration

High unemployment and low wages have led to widespread migration. Large numbers of workers in many Arab countries, frustrated by the lack of opportunities at home, have sought employment in GCC countries or left the region. Others, rejecting available low wage and insecure jobs, continue to seek preferable employment (often in the public sector) or leave the labour force.

Jobs refused by nationals in the region's wealthier countries are generally filled by immigrants from poorer Arab countries (such as Egypt, the Sudan and Yemen) or from outside the region (for example, from South Asia, the

Philippines or Indonesia). Thirty-eight per cent of immigrants entering the Arab region originate in other Arab countries (figure 3.20).




Figure 3.21. Inflows to Arab countries from other Arab countries (thousands)

A large number of Arab emigrants (particularly from the Mashreq, Yemen and the Sudan) move to GCC countries, in particular the United Arab Emirates and Saudi Arabia (figure 3.21). In 2010, the Jordanian Ministry of Labour estimated that 350,000 Jordanians worked abroad, mostly in GCC countries and largely in the private sector. Similarly, around 70 per cent of emigrants registered with the Secretariat of Sudanese Working Abroad in 2010 were working in Saudi Arabia. However, labour migrants go to other countries as well, depending on factors such as bilateral links and skill levels. For example, while most Egyptian migrants go to GCC countries, they are also present in significant numbers in Jordan and Libya, and some opt for irregular or regular emigration to Europe. Mauritanian migrants are often found in other West African countries, given their proximity and close links.

Migrants in the Arab region include people of all ages from a variety of social and economic backgrounds. Their experiences, vulnerabilities and needs differ. Women migrants make up an important proportion of migrants in and from the region, although their numbers remain well below the global average. 18

Regulation of the labour market and the flow of migrant labour should be consistent

with the human rights of workers. The kafala (sponsorship) system ties migrant workers legally to their employers rather than to the State, opening the door to abuses. The treatment and conditions of migrant domestic workers in the region, most of whom are women who receive no protection under national labour laws, has been strongly criticized, including by the human rights bodies of the United Nations. They suffer from insufficient remuneration, deprivation of freedom of movement, the withholding of passports and lack of legal recourse. 19

# 3. Poverty and inequality

The above-mentioned social contract, whereby the State provides employment and subsidies in exchange for political acquiescence, has until recently helped to keep poverty and consumption inequality in the region low by global standards.<sup>20</sup> However, the growing incapacity of States to maintain their end of the bargain has stoked frustration, which helped to fuel the 2011 Arab uprisings.

#### (a) Social protection





Figure 3.22. Fossil fuel subsidies, 2011

Social protection in the Arab region has focused on subsidies rather than targeted programmes, including cash transfers. General subsidies, including for fuels and food, account for more than 10 per cent of GDP and at least 20 per cent of total expenditure in the region. Fossil fuel subsidies, in particular, cost GCC countries more than \$200 billion in 2011, around 9 per cent of GDP. Mashreg countries spent \$146 billion, or 11 per cent of GDP, in the same year (figure 3.22). In per capita terms, GCC countries spent the most, with Governments providing subsidies of around \$4,400 per capita in 2011. The LDCs spent the least on fuel subsidies in absolute and relative terms. Total expenditure on fossil fuel subsidies in Arab countries reached over \$423 billion, or \$1,180 per capita, in 2011.

These subsidies put an unsustainable strain on national budgets. Moreover, they are generally not targeted and mostly benefit the non-poor. In the case of fuel subsidies, the wealthiest quintile benefits far more

**Figure 3.24.** Social insurance coverage, latest available year between 2004 and 2012 (percentage of population)



than any other (figure 3.23). There have been some efforts to rationalize subsidies in Egypt, Jordan and Tunisia, but the matter of reform remains contentious and largely unresolved.

Targeted social protection programmes remain minimal, generally limited to employees of the public sector and major companies. Such programmes are potentially very efficient and fair but they require a high degree of administrative capacity and are not suitable for all countries. The coverage of social insurance programmes (contributory programmes to minimize the impact of adverse shocks), except in the case Lebanon, is low (figure 3.24).


Provision of old-age pension and unemployment benefits is the second lowest in the world in the Arab region, after sub-Saharan Africa. Old-age pension coverage in countries of the Middle East

(29.5 per cent) and North Africa (36.7 per cent) is well below the global average of 51.5 per cent. The situation is worse for the coverage of unemployment benefits, which stands at just 3 per cent throughout the Arab region - a quarter of the global average of 11.7 per cent (figures 3.25 and 3.26).

#### (b) Poverty

Poverty as measured by the international poverty line has increased in recent years, notably in countries affected by conflict. Overall, average poverty rates in the Arab region increased by more than a third over the past two decades (based on the international poverty line of \$1.25 per day), reaching 7.4 per cent in 2012. The regional trend was driven mainly by a significant increase in the LDCs and a moderate increase in the Mashreq (figure 3.27).


Poverty rates are higher when measured in terms of nationally accepted standards of

living (figure 3.28). Moreover, armed conflict and instability in the region have driven those levels higher still in some countries in recent years, especially in Egypt, the Syrian Arab Republic and Yemen. Rural poverty is especially high in the LDCs, and significantly higher than in urban areas in Mashreq and Maghreb countries, including Egypt, Iraq and Morocco. Only in Palestine is rural poverty, based on the national poverty line, lower than that in urban areas (figure 3.29).

# (c) Inequality

If the concept of poverty focuses on absolute levels of well-being, inequality measures relative well-being. Indicators of inequality include the Gini Index,<sup>21</sup> quintiles and analysis that also utilizes national accounts data. In terms of the Gini Index, inequality is relatively moderate in the Arab region and has changed little over the past two decades. Gini Index estimates in the 2000s for the Arab region (around 34.3) compare favourably with



other regions, such as Latin America and the Caribbean (51.8), sub-Saharan Africa (44.7), Europe and Central Asia (35.8), South Asia (32.4), and East Asia and the Pacific (34.2).<sup>22</sup>




Figure 3.30. Ratio of income of highest quintile to income of lowest quintile

A comparison of the share in income in the highest and lowest quintiles<sup>23</sup> shows a mixed trend in the Arab region between the 1990s and 2000s. In figure 3.30, higher values

indicate a more unequal distribution of income or consumption, with Morocco and Yemen showing a slight negative trend since the 1990s, while Egypt, Jordan, Mauritania and Tunisia show positive trends.

Although the ratio of income of the highest to lowest quintiles using World Development Indicators data shows a trend of improvement in equality, other studies using different methodologies and data have found high and worsening inequality. Using a combination of national accounts and household survey data to re-estimate the mean consumption of the rich, ESCWA found that in 2011, the average per capita expenditure of the rich in Egypt was over 16 times higher than that of the poor, and 7 times higher than that of the middle class.24 Another recent study suggests that in the period up to 2030, economic growth paths are likely to be associated with higher inequality and a shrinking middle class in Arab countries.<sup>25</sup>

Inequality of consumption is a useful summary measure, but does not fully reflect inequality in terms of other aspects of well-being, many of which (including education, health care, water and sanitation) are addressed in dedicated sections of this report. Before turning to them, however, we present analysis of inequality in several composite measures.

The Inequality-Adjusted Human Development Index (IHDI) attempts to account for inequality across income, health and education. It is based on the Human Development Index (HDI), but discounts the index for inequalities: the IHDI will be equal to the HDI when there is no inequality, but falls below the HDI as inequality rises (figure 3.31). The discount due to inequality averaged 24 per cent in the region in 2013, which is comparable to the global average. In all Arab countries analysed, the discount due to inequality is largely driven by inequality in education, and to a lesser extent by income and health inequality.

#### 4. Gender

Nearly all Arab States have ratified the Convention on the Elimination of all Forms of Discrimination against Women and have

engaged actively with its reporting mechanisms. However, most entered reservations and noted that its provisions would be implemented insofar as they did not contradict the sharia, which is interpreted differently across the world. Reservations mostly pertain to personal status issues such as marriage, inheritance, divorce and the acquisition of nationality. Consequently, there are serious repercussions on the ability of women to participate fully in the economic and political life of their countries. Gender gaps have narrowed considerably in several key areas, but the region continues to rank poorly by international standards.

#### (a) Political participation

The average number of parliamentary seats held by women in Arab countries increased fourfold between the 1990s and 2014, from 2.5 per cent to 13.2 per cent. The world average rose from 13 per cent to 22 per cent (figure 3.32). The sharp increase in the Maghreb subregion contributed significantly to the

regional improvement. There are significant variations from one country to another, especially between countries that opted for affirmative action, such as quotas or reserved seats (Algeria, 27 Djibouti, Iraq, Jordan, Saudi Arabia, Somalia and Tunisia) and those that have not (Kuwait and Qatar). The percentage of seats held by women actually fell in Egypt, Oman and Yemen.

#### (b) Female employment and education




Figure 3.33. Employment-to-population ratio for females aged 15+ years

Moderate improvements were seen in female employment-to-population ratios, which increased by more than 20 per cent over the two decades in the region as a whole, with increases in all subregions except for the Mashreq, where levels stagnated at the lowest in the region at only 14 per cent (figure 3.33). Nevertheless, the regional average of 19 per cent of females employed is well below the global average of around 47 per cent in 2013. Many working women are in vulnerable employment. In fact, the ratio of women

compared to men in vulnerable employment has risen over the last two decades. In 2010, the female-to-male ratio of 177 was higher than in all other developing regions.<sup>28</sup>

Analysis of the gender distribution of national wealth similarly demonstrates women's limited economic participation, as well as lower earnings. In 2013, the mean female-to-male ratio




Figure 3.35. Male and female unemployment rates, 1991 and 2013

of gross national income (GNI) per capita for the region stood at 0.3, the lowest in the world (figure 3.34). There are considerable variations across subregions and countries, with the ratio standing at 0.67 in Bahrain, and not exceeding 0.2 in Algeria, Iraq, Jordan or Palestine.




Figure 3.36. Statutory duration of maternity leave, 2013 (percentage)

Unemployment rates among women in the region are high (figure 3.35), especially in the case of young women, around 48 per cent of whom could not find work in 2013. That was more than three times the global average of 15.7 per cent.<sup>29</sup>

Continued high gender gaps in employment are generally attributed to traditional (sometimes perceived as religious) roles of women and gender-biased economic policies. In addition to the scarcity of social services (such as affordable child and elderly care programmes and culturally appropriate transportation), maternity leave policies make it difficult for women to remain in the workforce. Of 12 Arab States examined in one study, only the Syrian Arab Republic, with 17 weeks of leave, meets the 14-week minimum established under the Maternity Protection Convention, 2000 (No. 183) of the International Labour Organization (ILO).30 The remainder all provide fewer than 12 weeks, and the regional average of 9.2 weeks is the world's lowest (figure 3.36). Morocco is the only Arab State to have ratified the Convention. Whereas in most regions maternity leave is

paid through social security, in the Middle East it is mainly employers who pay, which makes female workers less attractive to them.

Whatever their cause, the continued gender gaps are particularly striking considering that women in the Arab region are relatively well educated, compared to men and in absolute terms (figure 3.37). Indeed, more women than men receive tertiary education in the Maghreb and GCC countries.

#### (c) Gender violence

Gender violence and abuse take many forms, data are not always available for all countries and some cases go unreported. Conflict and displacement exacerbate the incidence of gender violence.<sup>31</sup> We highlight the issues of female genital mutilation and beating in what follows.




Figure 3.38. Prevalence of female genital mutilation/cutting (percentage)

Female genital mutilation/cutting remains widespread in Djibouti, Egypt, Somalia and the Sudan (figure 3.38). Domestic violence is also widespread in the region (figure

3.39). Many girls and women consider that a husband is justified in beating his wife. The rate is as high as 76 per cent in Somalia

and 70 per cent in Jordan, compared to 32 per cent worldwide and 52 per cent in the LDCs.

#### 5. Education

Adult literacy rates in the Arab region increased from 55 per cent in 1990 to 78 per cent in 2013, remaining below the global

average of 85 per cent (figure 3.40). Female literacy improved dramatically by 67 per cent over the past two decades, reaching an average of nearly 70 per cent in 2013, still below the global average of 81 per cent.<sup>32</sup>




Figure 3.41. Net enrolment in primary education (percentage)

Primary school net enrolment rates rose from 79 per cent in the 1990s to 91 per cent in the 2000s, just above the global average of 89.1 per cent in 2011 (figure 3.41). Several countries in the region, such as Algeria, Bahrain, Egypt, Kuwait, Morocco, Oman, Qatar, Tunisia and the United Arab Emirates, are close to universal enrolment, with a net primary enrolment rate above 95 per cent.<sup>33</sup>

Attendance rates, however, are a cause for concern in several Arab countries. Conflict, occupation, bombings, checkpoints, curfews and school closures hamper the ability of students to attend school and focus on learning. For example, in Yemen, armed conflict between 2009 and 2010 led to the closure of 700 schools for five months.<sup>34</sup> In 2011, 73 Yemeni students who participated in protests for political change lost their lives, and 139 students were injured. Education in Iraq, a regional leader in education before the early 1990s, has been devastated by factors such as school closures and the loss of teachers. Palestinian schools and universities are consistently targeted by air strikes, attacked

by Israeli settlers and, in some cases, used by Israeli armed forces as interrogation centres or surveillance posts.<sup>35</sup> During the Gaza war in summer 2014, 244 schools, 6 universities and 5 colleges were damaged by repeated Israeli strikes.<sup>36</sup>

Government expenditure on education as a percentage of GDP shows significant variation across countries, and has declined for the Arab region as a whole from the 1990s to the 2000s. In most cases, expenditure in recent years has been below the global average of 5 per cent of GDP (figure 3.42).





Figure 3.43. Pupil-teacher ratio

The pupil-teacher ratio was better (lower) in the Arab region (20 pupils per teacher) than the world average (24 pupils per teacher) in 2013<sup>37</sup> and has improved in most countries over the past decades, with the exceptions of Morocco and Yemen (figure 3.43).

Although the Arab region generally performs well in terms of quantity of education, there are major concerns about quality. Arab

countries fall far below international averages and benchmarks. Algeria, Egypt, Libya and Yemen have been ranked in one study in the bottom decile in that respect, with Yemen second last and Algeria and Libya ranked at 131 and 132.<sup>38</sup> According to the Trends in

International Mathematics and Science Study (TIMSS) 2011, none of the 14 participating Arab countries reached the international level (figure 3.44).

The problem is still more acute in rural areas, especially in secondary education. A recent study showed that in 6 out of 11 Arab countries, the proportion of young people not learning was at least 10 percentage points higher in rural than in urban areas.<sup>39</sup>

Poor quality education means that many young Arabs are unprepared for work. A recent study found that two thirds of them believed that their education did not prepare them for the job market. 40 The lack of information or assistance provided to students on the nature and availability of jobs, and how to find them, exacerbates youth unemployment. Teaching methods and textbooks in the region often fail to foster critical thinking and rely heavily on "highly didactic, teacher-directed" learning at all levels of education. 41

# B. Access to basic necessities

#### 1. Water and sanitation

Most Arab States suffer from extreme freshwater scarcity, which is exacerbated by population growth and urbanization. Access issues at the individual level are addressed in this section. The broader sustainability issues are examined in the following chapter within the context of sustainable and resilient societies.

The proportion of the population across the region with access to safe drinking water improved only marginally between 1990 and 2014 (figure 3.45), rising from 82 per cent to 84 per cent, still below the global average of 91 per cent (as of 2015).<sup>42</sup> Although progress was made in most of the region, access to safe drinking water did not keep pace with population growth in the LDCs. Moreover, this indicator fails to tell the complete story: many of those with access to improved water

sources receive the service only intermittently and the water received may not be suitable for drinking.




Figure 3.48. Percentage of the population with access to improved sanitation facilities

in 1990, is now lower.<sup>43</sup>The percentage of the rural population with access to improved water sources fell in 5 of the 22 Arab countries, namely Algeria, Palestine,

Somalia, the Sudan and Yemen (figure 3.46). The percentage of the urban population with access to improved water sources is higher than in rural areas, but it slipped slightly




Figure 3.49. Percentage of the rural and urban populations with access to sanitation, 2015

between 1990 and 2015 and is below the world average. 44 The percentage of the urban population with access to an improved water source fell in 8 of the 22 Arab countries: namely Algeria, the Comoros, Iraq, Jordan, Palestine, the Sudan, the Syrian Arab Republic and Yemen (figure 3.47).

Access to water is complicated by conflict and occupation. Palestine is practically deprived of its water resources. After the 1967 war, Israel declared that all West Bank water resources belonged to it and placed them under the control of the army. Israel illegally exploits almost 85 per cent of West Bank water resources and continues to prevent the Arab population from drilling wells. In Gaza, more than 96 per cent of water resources did not meet WHO health standards regarding nitrate concentrations in 2013 and 2014.

Between 1990 and 2014, access to improved sanitation facilities rose across the Arab region, reaching 79 per cent of the population (figure 3.48), well above the global average of 68 per cent (as of 2015).<sup>47</sup> However, nearly 66

million people in the Arab region do not have such access.<sup>48</sup>

The disparity between urban and rural areas is greater for access to improved sanitation facilities than in the case of access to an improved water source. The greatest disparities can be observed in the LDCs, Morocco and Tunisia (figure 3.49).

#### 2. Electricity

Access to electricity is comprehensive across the GCC, Mashreq and Maghreb subregions; more than 97 per cent of the population had access to electricity in 2012 (figure 3.50). The LDC average of only 38 per cent brings the Arab regional average to around 86 per cent. The Arab region average compares favourably with the global average of 84.6 per cent in 2012. <sup>49</sup> There are still pockets of inadequate access in rural areas. In the Sudan, for instance, the access rate to electricity in rural areas was 18 per cent in 2012, compared with 62 per cent in urban areas. <sup>50</sup> Intermittent access is a problem

masked by high access figures (for example in Lebanon).<sup>51</sup>

#### 3. Food

Food security encompasses issues of availability, accessibility and utilization that can be measured in many ways. In this section, only indicators of hunger and malnutrition are analysed. Other aspects of food security are addressed in chapter 4.

Hunger and malnutrition in Arab countries arise from problems relating to the affordability of food. In the past 20 years, there has been a major increase in food availability in the region, primarily due to imports. Based on the daily energy supply and the energy supply adequacy measures, the region is well above the developing country and global averages. The Arab region's daily energy supply was 3,045 kilocalories per capita per day in 2010, well-above the 2,720 kilocalories per capita per day for developing countries and 2,840 kilocalories per capita per day globally. These regional averages,

however, are not representative of the reality in some countries and mask high disparities between subregions.

Fourteen Arab countries (Algeria, Bahrain, Egypt, Jordan, Kuwait, Lebanon, Libya, Mauritania, Morocco, Oman, Qatar, Saudi Arabia, Tunisia and the United Arab Emirates) achieved the MDG hunger target of halving the prevalence of hunger (proportion of hungry people in the total population) by 2015. Kuwait and Oman also achieved the more stringent World Food Summit target of halving the absolute number of hungry people.<sup>52</sup> However, the region as a whole has witnessed a significant setback in the fight against hunger due to conflicts, protracted crises and the rising number of refugees (box 3.2). It is the only region that has seen both an increase in the prevalence of hunger and a doubling in the number of hungry people since the early 1990s.

Stunting among children under the age of 5 stands at 22.4 per cent, of medium severity by WHO standards,<sup>53</sup> and below the global

# **Box 3.2.** Poverty and vulnerability among Syrian refugees living outside camps in Jordan

Two out of three Syrian refugees living outside camps in Jordan live below the absolute national poverty line of \$96/person/month. This is the chief finding of a survey conducted by the Office of the United Nations High Commissioner for Refugees (UNHCR) between January and June 2014 of nearly 42,000 registered Syrian refugee households. Households headed by women, representing around one third of the sample, are worse off still. With outgoings equivalent to 1.6 times their income, families attempt to cope in ways that increase their vulnerability by the day and affect children the most. Around half of the surveyed households live in unsanitary make-shift housing and reported cutting their food intake, and 43 per cent skimped on food quality. Around half the children in the surveyed families were taken out of school.




Figure 3.51. Underweight children (percentage of children aged under 5)

average of 24.5 in 2013.<sup>54</sup> Variations exist between subregions, with the Mashreq registering 20.4 per cent, the Maghreb 15 per cent, GCC countries 8 per cent and the LDCs a very high 43.4 per cent.

Since the 1990s, the percentage of underweight children in the region has decreased to reach 13 per cent, with significant improvements in

the GCC, Maghreb and Mashreq subregions (figure 3.51). The regional average is held back by the growing percentage (around 30 per cent) of underweight children in the LDCs, double the global average of 14.3 per cent in 2014. This is accompanied by the persistence of micronutrient deficiencies in vitamins and minerals, with one third of the population being anaemic.




Figure 3.52. Child obesity (percentage of children aged under 5)

Excessive food intake is also a concern, especially in the wealthier countries. From the 1990s to the 2000s, the obesity rate doubled in GCC countries and rose moderately in the Mashreq. The average regional rate of obesity in children is 11.3 per cent (figure 3.52), well above the global average of 6.1 per cent in 2014.56 Obesity rates among adults in the region are more than double the world rate, standing at 23.6 per cent, compared to the world average of 11.7 per cent. Variations among countries are large, with women consistently experiencing higher levels of obesity than men. Obesity rates for women are over 50 per cent in Egypt, Jordan, Kuwait and the United Arab Emirates.57

#### 4. Health




Figure 3.53. Under-5 mortality rate (per 1,000 live births)

Life expectancy at birth in the Arab region has increased significantly from 65 years in 1990 to 70 years in 2013, close to the global average of 71 years.<sup>58</sup> However, there are wide variations between countries, with the

lowest life expectancy registered in Somalia (55 years) and the highest in Lebanon (79 years) (table 3.1). Significant strides have been made to reduce child and maternal mortality despite the turmoil sweeping across some countries. Under-5 mortality rates dropped by more than half across the Arab region between 1990 and 2015 (figure 3.53) to 36 per 1,000 live births, compared with the global average of 43, and progress was made in all subregions. <sup>59</sup> The tradition of strong family and social support in the region is believed to have contributed to this success. <sup>60</sup>

The disease profile of the region is now similar to that of the United States and countries in Western Europe. Since the 1990s, premature death and disability caused by communicable diseases (except HIV/AIDS), nutritional deficiencies and complications related to childbirth and early childhood has declined dramatically. Non-communicable diseases now represent the major health challenge for the region. Since 1990, heart




Figure 3.54. Contraceptive prevalence (percentage of women aged 15-49)

disease has overtaken lower-respiratory infections as a leading cause of premature death in Arab countries. 63 Smoking continues to be a major cause of morbidity and

mortality. In terms of disability-adjusted life years, non-communicable diseases such as heart disease, musculoskeletal disorders, diabetes and cirrhosis have increased since




Figure 3.55. Slum prevalence, 2014 (percentage of urban population living in slums)

1990. The incidence of HIV/AIDS has also risen substantially. Mental health problems are increasingly prevalent, especially among women and girls. 64

In the Arab region, more than two thirds of births are attended by skilled health personnel, with an increase from 54 per cent in the 1990s to 69 per cent in 2010.<sup>65</sup> This compares favourably with the global average of 67.3 per cent in 2010.<sup>66</sup> However, the LDCs lag behind, with only around 34 per cent of births attended by skilled health personnel, below the 45 per cent average for sub-Saharan Africa. Pregnant women receiving prenatal care in the region averaged 81.1 per cent in 2009, slightly below the global average of 82.5 per cent.<sup>67</sup>

Contraceptive prevalence rates are increasing across all subregions except for the GCC countries, with nearly half of married women now using contraceptives (figure 3.54). The average rate across the Arab region is 46 per cent, well below the global average of 63.5 per cent.<sup>68</sup> Overall,

contraceptive use rates are highest in the Maghreb (62 per cent) and lowest in the LDCs (15 per cent). Use of contraceptives declined by 22 per cent in GCC countries over the last two decades. Adolescent birth rates also declined from 54 to 42 per 1,000 women over the same period.<sup>69</sup>

The impact of conflict and instability on health is a growing source of concern in the Arab region. It is estimated that, for every person killed in conflict, three are left with a permanent disability. Although direct harm in terms of disability-adjusted life years is comparatively limited, the impact of conflict on health extends well beyond direct harm. Conflict causes trauma, depression and anxiety and, in countries such as Iraq, prolonged warfare has even shortened life expectancy. Conflict disrupts health services and makes medicines harder to obtain.

#### 5. Housing


The housing shortfall has been estimated at more than 3.5 million homes across the Arab


region, where land and construction costs are high. The shortage of affordable housing is most acute in Egypt, Iraq, Morocco and Saudi Arabia, although Bahrain, Oman and the United Arab Emirates are also affected. The immature mortgage market limits opportunities for lowand middle-income homebuyers to obtain finance for home ownership.

Between 1970 and 2010, the urban population of the Arab region more than quadrupled. In addition to rural-urban migration, the region's conflicts have been a major cause of urbanization. An estimated 4.1 million Syrian refugees have fled their country in the past few years, most of them to neighbouring countries like Jordan and Lebanon. Some 80 per cent of them live not in refugee camps but in urban areas, increasing demand for housing and


straining infrastructure and public services. To In Palestine, house demolitions are a regular occurrence and have led to a dramatic shelter crisis for families and communities. Between 1967 and 2010, over 24,800 homes were demolished. In the 2014 Gaza offensive alone, 13 per cent of homes (20,000 units) were demolished.

Most countries in the Maghreb and Mashreq subregions have made significant progress towards eliminating slums. However, the proportion of substandard housing varies from country to country. Many urban residents in LDCs live in slums (figure 3.55). In the Maghreb and Mashreq, lower- and middle-income groups often live in decent informal settlements with adequate infrastructure but lacking land title.<sup>77</sup>





# 4. Sustainable and Resilient Societies



Laying the foundations for human dignity and well-being will require making societies sustainable and resilient. Sustainable societies will ensure that the natural resource base upon which human well-being depends is maintained in the long-term. That means providing an ongoing source of water, energy and food security; keeping the environment healthy and promoting sustainable consumption and production patterns. Resilient societies will address risks to their people, assets and infrastructure arising from natural disasters, pollution, natural resource depletion and climate change, and conserve marine and terrestrial ecosystems to achieve a healthy and productive environment.

Such goals pose a particular challenge in the Arab region, where water scarcity is a defining characteristic; food production is limited by numerous constraints; water and energy consumption are increasing at unsustainable rates; marine and terrestrial ecosystems are

facing significant pressures; population is increasing, notably in urban areas, which now host more than half of the total population of the region; and dependence on desalination is high in several countries. Extreme weather events in the region, especially droughts, storms and floods, have become more frequent and intense in the past several decades, and have taken an increasing toll on people and infrastructure. The impact of climate change is already being felt, and the region is likely to experience rising temperatures and a growing variability in precipitation.

On the bright side, efforts have been made to preserve biodiversity in Arab countries, through the expansion of protected areas and measures to reduce emissions; several countries have prepared public statements of their Intended Nationally Determined Contributions. Nevertheless, the increase in per capita greenhouse gas emissions and of the economy's carbon intensity remain a worrying trend.

This chapter is largely based on issues briefs prepared for this report covering the topics of energy, water, food, climate change, industrialization, cities, disaster risk reduction, sustainable consumption and production, marine resources and terrestrial ecosystems.<sup>1</sup>

# A. Sustainable resource base, consumption and production patterns

### 1. Water security

#### (a) Natural water scarcity and increased use

Arab countries account for more than 5 per cent of the world's population, but less than 1 per cent of its freshwater resources.<sup>2</sup> Almost three quarters of the Arab population live under the freshwater scarcity level of 1,000 cubic metres per capita per year, and nearly half live in conditions of extreme scarcity, with access to less than 500 cubic

metres.<sup>3</sup> Rainfall is low and variable, evaporation rates are high and droughts are frequent. Countries in the region, classified as arid and semi-arid, cover 10 per cent of the world's surface area but receive only 2.1 per cent of its average annual precipitation.<sup>4</sup>

In Morocco, the drought cycle has accelerated from one year in every five-year period in the 1990s to one every two years, with droughts in 2012 and 2014. Extended drought in northeast Syria from 2006 to 2009 drove an estimated one million people out of their homes and farms to seek refuge in cities, and thereby reportedly contributed to the popular uprisings in that country. The Horn of Africa is experiencing one of the worst droughts in decades, which in Somalia has caused widespread resource-based conflicts between communities, population migration and recurrent famine.

Annual withdrawal of water as a cumulative total for Arab countries increased from 166




Figure 4.1. Annual water withdrawals (cumulative, billion cubic metres per year)



billion cubic metres per year in the 1990s to 216 billion cubic metres in the 2000s, an increase of 30 per cent (figure 4.1). The fastest rate of growth was observed in the GCC countries (around 50 per cent).


**Figure 4.2.** Water use by sector (percentage of total water use)

Although, as seen in the previous chapter, the demand for drinking water and sanitation in the region has grown significantly since 1990 and is likely to continue to do so, agriculture remains the biggest consumer of water. As figure 4.2 shows, agriculture accounts for 84 per cent of water use, compared to a world average of 70 per cent, and water is often used inefficiently.

Renewable (ground and surface) water is being withdrawn at an alarming rate,<sup>6</sup> averaging well over 1,000 per cent of available water, and increasing by nearly 13 per cent in the 2000s compared to the 1990s (figure 4.3). Reasons for this include: population growth; industrial diversification; poor maintenance of distribution networks, with high prevalence of leakage; and subsidized water pricing that does not reflect real cost (and therefore does not encourage efficiency). Using groundwater resources

beyond their natural replenishment rates has resulted in rapid depletion of aquifer reserves in a number of countries and salinization and deterioration in water quality due to seawater intrusion.7 Groundwater resources in most Arab countries are also threatened by pollution from agricultural, industrial and domestic activities. The growing shortages have increased the frequency of water supply interruptions, to the degree that intermittent supply patterns have become the norm in many countries.8 The Arab Strategy for Water Security in the Arab Region to Meet the Challenges and Future Needs for Sustainable Development 2010-2030, and its associated action plan, are key policy documents adopted by the Arab Ministerial Water Council of the League of Arab States in 2011 and 2014 respectively.




Figure 4.4. Annual per capita renewable water resources (cubic metres)

Rapid population growth over the past decades has caused a dramatic 39 per cent reduction in per capita renewable water resources, from an average of 1,232 in 1992 to an alarming 751 in 2014, below the water scarcity line of 1,000 cubic metres per person per year (figure 4.4).

The world average of 7,525 cubic metres per person per year in 2014 was 10 times more. By 2025, the figure is projected to fall below 500 cubic metres.<sup>9</sup>

In 2014, 18 of the 22 Arab countries fell below the water scarcity line of 1,000 cubic metres per person per year,<sup>10</sup> and 13 are among the world's 19 most water-scarce nations.<sup>11</sup> Per capita water availability in nine countries is already below 200 cubic metres, less than half the amount designated as absolute water scarcity.<sup>12</sup>Thus, around 40 per cent of the Arab population live in conditions of absolute water scarcity, having less than 500 cubic metres per person per year in 2014.<sup>13</sup>

The situation is exacerbated by the fact that more than half of total renewable water resources in the Arab region (about 174 billion cubic metres a year of a total of 315 billion cubic metres) originates from outside the region (water dependency ratio of 55 per cent), 14 with two thirds crossing at least one international border. Water security in the Arab region

thus has a political dimension as it is largely dependent on the effective management of transboundary water resources, between Arab States and between Arab and non-Arab States. Almost every Arab country depends for its water supply on rivers or aguifers shared with neighbouring countries. 15 These include major rivers such as the Nile, Senegal, Tigris and Euphrates. Many smaller rivers are also shared between Arab countries, including the Medjerda and Orontes. However, most of the region's freshwater is from groundwater resources. Most large aguifer systems in the Arab region cross at least one international border, with many shared among Arab countries. Most of these aquifers contain non-renewable groundwater resources and lie deep below the Sahara Desert and the Arabian Peninsula.

The fact that several water basins are shared with Israel further hampers constructive dialogue on shared water resources. The Jordan River basin, for instance, is shared by five riparian countries (Israel, Jordan, Lebanon, Palestine and the Syrian Arab Republic) and control over its water adds to existing regional

tensions. The impact of power asymmetry is clear: Israel is the largest user of water from the Jordan River basin, and the only user of water from Lake Tiberias.

#### (b) Water desalination and wastewater reuse

To meet future increases in domestic demand for water. Arab Governments will either have to divert about 11 billion cubic metres per year from the agricultural sector to meet growing demand, reduce demand or resort to non-conventional water sources, such as desalination and treated wastewater reuse.<sup>16</sup> Although desalinated water contributes only 1.8 per cent of the total supply of water in Arab countries, it accounts for nearly all the water supply in many cities, particularly in the Gulf.<sup>17</sup> lt is estimated that desalinated water will account for 8.5 per cent of the region's total water supply by 2025. This is consistent with global trends; the capacity of desalination plants increased by nearly 60 per cent between 2008 and 2013.18

The increased capacity will be concentrated largely in the hyper-arid GCC countries, where

desalination is the only viable option for supplying water to cities and industry. More than 55 per cent of the water supplied to cities in the GCC comes from desalinated water, used directly or blended with groundwater, and this share is expected to rise as groundwater resources shrink. 19 The GCC countries host nearly half of the global desalination production capacity. Four of the top five countries in terms of desalination capacity are from the Arab region: Algeria, Kuwait, Saudi Arabia and the United Arab Emirates (figure 4.5).

The cost of desalination is falling, but can still be as much as \$1.50 per delivered cubic metre (\$4 in extreme cases) for Governments, in contrast to the subsidized price of 4 cents per cubic metre at which water is sold in some Arab countries. Desalination raises energy security concerns and energy consumption creates a larger carbon footprint, although in GCC countries it takes place mostly in thermal-powered co-generation stations that produce both water and electric power, thereby improving energy efficiency and cost effectiveness.<sup>20</sup> Countries around the Arabian Gulf are also increasingly concerned about the threat to marine life and ecosystems posed by water discharged from thermal desalination plants.21

Arab countries produce an estimated 10.8 billion cubic metres per year of wastewater. Around 60 per cent of collected wastewater is treated and only 20 per cent of generated wastewater (2.17 billion cubic metres per year) is reused in agriculture, landscape irrigation and industrial cooling. In some countries, treated wastewater is also used for groundwater recharge. Egypt, Saudi Arabia, the Syrian Arab Republic and the United Arab Emirates account for more than 75 per cent of total reused wastewater in the Arab region. Irrigation for landscaping and golf courses is increasing in GCC countries and the Maghreb.<sup>22</sup> For example, 28 per cent of treated wastewater in Bahrain is used for irrigation. Concerted efforts, supported by regional and international organizations, will be needed to

overcome economic, institutional, health and environmental obstacles in order to increase the volume of treated water that is reused.

### 2. Food security

The previous chapter highlighted challenges facing a number of Arab countries in fighting hunger and malnutrition. This section addresses food availability.

The issue of food security is intimately tied to the issues of water scarcity, arid climate and population growth. The region relies heavily on food imports, with dependency on cereal imports reaching 56.2 per cent compared to the world average of 57.6 per cent. Although the value of annual food production per capita for the Arab region (\$191.4) is well below the world average of \$311, local agriculture will remain important to protect countries of the region against international price volatility.<sup>23</sup> Domestic agriculture is also an important means of livelihood for the rural poor, many of whom are women. Increased efficiency and reduced waste along the entire food chain can maximize the region's scarce resources.

Nearly 90 per cent of the region lies within arid, semi-arid and dry subhumid areas, and is prone to drought. Despite the evident water scarcity, achieving food self-sufficiency at any cost was the prevailing policy goal during the 1960s and 1970s. The costs of this policy were high. Mismanagement of water resources, inefficient irrigation practices, logging and overgrazing contributed to desertification, soil erosion, salinization, and loss of biodiversity. Increased land degradation and desertification have occurred in Iraq, Jordan, the Syrian Arab Republic and most countries in the Arabian Peninsula over the past decade.<sup>24</sup> Around 15.3 million hectares of the region's crop lands have been affected by land degradation, with 42 per cent classified as slightly degraded and 12 per cent as severely to very severely degraded.<sup>25</sup> Rangelands and forests have also suffered, which is affecting livestock and

# Box 4.1. National gene banks, genetic resources conservation and sustainable use: Tunisia

Aware of the magnitude of the problem of genetic resources erosion, Tunisia has ratified the United Nations Convention on Biodiversity, Framework Convention on Climate Change and Convention to Combat Desertification. It was also among the first signatories to the International Treaty on Plant Genetic Resources for Food and Agriculture. The inauguration of the Tunisian National Gene Bank (www.bng.nat. tn) in November 2007 was an important step towards the conservation and evaluation of plant, animal and micro-organism biodiversity. It has stocked more than 200,000 accessions since its creation and played a key role in coordinating operators in the area and promoting conservation activities and sustainable use of genetic resources at the national, regional and international levels.

Political commitment and clear legislation are needed to sustain a national gene bank. A key to success for the Tunisian Gene Bank was networking with all stakeholders (research institutions, universities, development agencies, farmers and non-governmental organizations) within the framework of nine thematic groups. They were all involved in the bank's programme planning and implementation and benefited from capacity-building activities.

However, the failure by some international agencies to work with the bank and their continued work with individuals or parties outside its network somewhat undermined the bank's mandate.




Figure 4.6. Total arable and permanent crop land area (million hectares)

biodiversity, and increasing the potential for landslides. Biodiversity loss has reduced the productivity of ecosystems, jeopardizing the basis for sustainable livelihoods. However, efforts are being made to establish national gene banks (box 4.1).

Total arable land and cropped area in the region decreased slightly between 1990 and 2013 to 64.53 million hectares (figures 4.6 and 4.7), or 4.1 per cent of total land area. That was less than half the global average of 10.9 per cent in 2013. The regional average is around 0.17 hectares of arable land per person, which is close to the global average of 0.2 hectares in 2013. Values vary across the region, ranging from 0.01 (Palestine and the United Arab Emirates) and 0.04 (Egypt) to 0.29 (Libya) and 0.36 (the Sudan).

Demand for new cropland faces competition from continued urbanization and the expansion of infrastructure. Another threat may come from a new rush for land as highlighted in box 4.2.

Agricultural productivity of cereals in the Arab region increased by 38 per cent between 1990 and 2013 (figure 4.8), registering a slightly higher rate of increase relative to the world (34 per cent) over the same period.<sup>29</sup>

However, the Arab regional yield for 2013 of approximately 1,950 kilogram per hectare was half the global yield of 3,851 kilogram per hectare. Livestock production increased from 23.4 million tons in 1961 to 144 million tons in 2012, with an average annual growth rate of 9.9 per cent. This is double the worldwide average annual growth rate for livestock production (4.48 per cent).<sup>30</sup>

The scarcity of water places natural limits on developing domestic food production. As the population has grown, food self-sufficiency has declined and food imports have increased. Reliance on imports exposes Arab countries to volatility in international food prices, as they found during the 2007-2008 global food crisis. The escalating food import bill (\$30 billion in 2008 for main food commodities) has caused large trade deficits and strained public budgets where subsidies are provided. It is estimated that the food import bill for the region will reach nearly \$100 billion by 2030. 22

# Box 4.2. International food prices and the new rush for land: Responding to future needs

Although agricultural land area worldwide has been increasing by 1.8 to 4 million hectares per year, international prices reached unprecedented levels in 2008, due to grain production shortages and increased cargo costs. Countries dependent on grain imports were alarmed. In response, the Arab Organization for Agricultural Development has focused increasingly on the potential for grain production in East African countries, particularly the Sudan, abundant in land and water.

GCC investment in those countries (and some Asian countries) is booming. According to an Oxfam report, up to 227 million hectares were sold or leased between 2001 and 2011, with the bulk of the acquisitions occurring in the latter years of that period. A 2010 World Bank report found that investors expressed interest in around 56 million hectares of land in 2009 alone, with about two thirds of investments taking place in sub-Saharan Africa. The Global Land Project estimated that between 51 and 63 million hectares of land were either part of finalized land deals or under negotiation in 27 African countries in 2009. However, not all the land has been converted to farmland and many of the deals have had undesirable effects.

On average, 37 per cent of the region's population was engaged in agriculture in 2006, down from 48 per cent in the 1990s.<sup>33</sup> Although agriculture's average contribution to GDP in 2005 was a low 12.5 per cent (ranging from 0.3 per cent in Kuwait and Qatar to 34 per cent in the Sudan),<sup>34</sup>

many of the poorest people in rural areas continue to rely on agriculture for their livelihood.

The chances of maximizing food selfsufficiency and supporting the region's farmers depend on reversing the trend of degradation

of available agricultural resources, and in using them efficiently and productively. Water and irrigation efficiency, promoting water reuse in agriculture and reducing food loss and waste along the value chain have therefore become policy priorities.<sup>35</sup>

The issue of food loss and waste reduction, in particular, has become a regional and global priority, and is a pillar of the United Nations Secretary-General's Zero Hunger Challenge. The annual blue water footprint (including surface and groundwater resources) of food losses and waste in the North Africa/Western Asia/Central Asia region has been estimated at 40 billion cubic metres, or 90 cubic metres per capita, which represents 17 per cent of the global figure, despite having only 7 per cent of world's population.<sup>36</sup> Roughly 44 per cent of food losses and waste occur during handling, processing and distribution, while waste at the consumption stage is estimated to be 34 per cent, of which most is generated in urban areas.37 Post-harvest and pre-consumer food

loss scores for selected Arab countries ranged between 7.1 in Yemen (best) and 18.7 in Egypt (worst) (figure 4.9). Arab Governments have adopted a regional strategic framework for reducing food loss and waste by half by 2024.<sup>38</sup>

### 3. Energy security

The energy sector plays a vital role in the development of Arab countries, especially those endowed with large hydrocarbon resources. The GCC countries are among the largest fossil fuel producers in the world, and the Arab region as a whole accounted for 16 per cent of world gas production in 2013 (behind the United States and the Russian Federation).<sup>39</sup>




Figure 4.10. Primary energy production and consumption (billion tons of oil equivalent)

Domestic consumption of energy resources has risen faster than production in the Arab countries: the ratio of consumption of oil and gas compared to production rose from 23 per cent in 1990 to 35 per cent in 2013 (figure 4.10).





Figure 4.11. Energy consumption per capita, 2012 (kilogram of oil equivalent)

Regional per capita energy consumption stood at 1,843 kilogram of oil equivalent (kgoe) in 2012, slightly below the global average of 1,898 kgoe.<sup>40</sup> However, while consumption in the LDCs, Maghreb (except Libya) and Mashreq was well below the global average in 2012, in GCC countries it was much higher - as much as 10 times the global average in Ωatar (figure 4.11).

More than 35 per cent of total primary energy is consumed in electricity generation (96 per cent of which comes from oil and gas) due to changing consumption and production patterns, according to the Arab Union of Electricity. Between 1971 and 2011, electricity consumption grew at an average of 9.2 per cent, far outpacing population growth of 2.6 per cent or GDP growth of 3.4 per cent over the same period. While economic growth has multiplied by a factor of 5 during that period, electricity and energy consumption have multiplied by factors of 35 and 12 respectively (figure 4.12).

The amount of energy the Arab countries use to generate \$1,000 of GDP (in constant 2005 United States dollars) increased by 23 per cent from 0.34 to 0.42 tons of oil equivalent between 1990 and 2011 (figure 4.13),<sup>41</sup> in contrast to all other regions, where energy intensity is decreasing. The global average energy intensity was 0.25 tons of oil equivalent per \$1,000 in 2011, down from 0.29 tons in 1990.<sup>42</sup>The global average reflects improved energy efficiency and an increasingly service-focused economy in China, the Russian Federation, India, the European Union and the United States.<sup>43</sup>

The high consumption rates of oil and gas in parts of the Arab region are largely attributable to widespread energy subsidies. Six of the world's 10 largest energy subsidizers are in the Arab region. It is widely believed that energy subsidies primarily benefit the rich,<sup>44</sup> as discussed in chapter 3.

Despite the region's rich endowment in renewable energy resources, the share



in electricity generation remains limited (figure 4.14). Renewable energy other than hydroelectric power contributes less than 1 per cent of electricity generation in the region and is almost exclusively limited to the Maghreb and Mashreq. At the end of 2014, solar (photovoltaic and concentrating solar power) energy was contributing 0.12 per cent of electricity and wind power 0.36 per cent.

Installed renewable energy capacity totals approximately 11 gigawatts, mostly in the form of hydroelectric power (88 per cent in 2014), and concentrated in Egypt, Iraq, Morocco, the Sudan and the Syrian Arab Republic (table 4.1 and figure 4.15). The use of renewables in the region falls below the global average of 8.7 per cent of total energy use provided by alternative energy sources (including hydro and nuclear) in 2011.<sup>45</sup>

Progress is being made on increasing installed capacity (figure 4.16). Twenty Arab countries have announced renewable energy targets that would total around 106 gigawatts of installed power capacity in Arab countries by 2032 (32 gigawatts photovoltaic, 38 gigawatts


concentrating solar power, 30 gigawatts wind, 3.7 gigawatts biomass, and 2.2 gigawatts geothermal). 46 Development is being guided by regional plans such as the Pan-Arab Strategy for the Development of Renewable Energy 2030 and the Arab Renewable Energy Framework.



#### 4. Waste and transport

Vehicular use and waste generation are also important indicators of sustainable

consumption and production patterns and are analysed below. A comprehensive analysis of sustainable consumption and production cannot be conducted due to




Figure 4.18. Passenger cars per 1,000 people

significant gaps in data on waste recycling, treatment and disposal (including hazardous waste).

Over the past two decades, changing lifestyles and inadequate public transport have led to a substantial increase in the number of vehicles per kilometre of road in several Arab countries (except in Egypt, which shows a small decrease). In most countries for which data are available, the number is far higher than the global average of 32 as of 2009 (figure 4.17). The greater numbers of cars in circulation is associated with increased fuel consumption, greenhouse gases emissions and traffic congestion. The number of passenger cars per 1,000 people ranges from under 30 in the Comoros to around 450 in Kuwait (figure 4.18). In some cases, the number of passenger cars per 1,000 people has decreased. In Saudi Arabia, the number dropped in 2012 to a third of its value in the early 2000s.

The overall generation of waste per capita decreased between 2000 and 2006, particularly in the Maghreb and Mashreq

(figure 4.19). It is unclear, however, to what extent this is due to an absolute reduction in waste or to rapid population growth.

Science, technology and innovation can contribute to building sustainable and resilient societies. Promising research and development in green sectors is being undertaken in the Arab region (box 4.3) and efforts are being made to green sectors (box 4.4). Tangible progress, however, results only when institutional, regulatory, human resource and financial constraints are addressed simultaneously.

# B. Sustainable and resilient societies, cities and human settlements

#### 1. Disaster risk reduction

The Arab region is prone to weather volatility, and the frequency of natural disasters, probably as a result of climate change, has increased over the past two decades (figure 4.20). Coupled with a low level of disaster




Figure 4.19. Generation of solid waste (kilograms per person per day)

# Box 4.3. Research and development in green sectors: Examples from the Arab region

Important research and development initiatives in green sectors are taking place in the Arab region. In the field of energy, the Clean Combustion Research Center (http://ccrc.kaust.edu.sa/Pages/Objectives-and-Approaches.aspx) of the King Abdullah University of Science and Technology and the Saudi Arabian Oil Company are working to improve combustion technologies by enhancing efficiency, reducing pollutants and capturing carbon emissions.

The Kuwait Institute for Scientific Research (www.kisr.edu.kw/en/research/water) is developing safer and more cost-effective methods of water desalination and treatment, including through the use of advanced membrane technologies, and the Oman-based Middle East Desalination Research Center (http://www.medrc.org/?q=research-initiatives/habs) is applying remote sensing, modelling, and forecasting techniques to manage harmful algal blooms resulting from desalination operations.

In the field of agriculture, the Arab Center for the Studies of Arid Zones and Dry Lands (http://www.acsad. org/index.php/en) is promoting the transfer and use of techniques that combat desertification and the degradation of rangelands, and the International Center for Biosaline Agriculture (http://www.biosaline.org) in the United Arab Emirates is developing nutritious salt, heat and drought tolerant crop varieties that can be planted in degraded and marginal lands.

preparedness, this has led to a substantial increase in the number of lives lost, mainly in the LDCs (figure 4.21). Deaths reported due to

disasters were nearly 275 per cent higher in the period 2006-2015 than in the years from 1990 to 1999.<sup>47</sup>

# Box 4.4. Greening production in the Arab region

National Cleaner Production Centres (NCPCs) have been established in five Arab countries with donor funding and the technical support of the United Nations Industrial Development Organization (UNIDO) and UNEP. The centres are helping industries to identify and implement technological solutions to address their environmental impact. In Jordan, the NCPC has cooperated with food producers to identify and implement simple, low-cost production methods that have resulted in sizeable energy and water use savings. In Tunisia, 10 hotels benefited from the NCPC, deploying water accounting systems that led to a reduction in water use of up to 70 per cent. Since 2012, ESCWA has supported the establishment of six Green Help Desks in Egypt, Jordan, Lebanon, Morocco, Oman and Tunisia (see www.escwa.un.org/sites/gps/index.asp). They complement the work of NCPCs through awareness-raising activities, specialized training and information services to industries wishing to benefit from green economy opportunities.

Financial mechanisms have also been set up in recent years to support the deployment of environmental technologies. In Lebanon, potential investors in green technology (especially in the energy sector) can now benefit from low-cost loans subsidized by the Central Bank (see http://banqueduliban.gov.lb/files/tabs/FinanceUnit.pdf).

Many "green" initiatives in the region are driven by international organizations and need to be expanded at the national and regional levels to make their impact more tangible. Their sustainability is yet to be tested.




Figure 4.20. Disaster occurrences, 1990-2015




Figure 4.22. Disaster occurrences, Arab region, 1990-2015

The increase in reported occurrences of disasters is most pronounced in the case of flooding (figure 4.22), although the number of people affected by disasters has risen most as a result of drought. Earthquakes cause the greatest physical damage. Damage

to infrastructure, housing and livelihoods between 1990 and 2015 was estimated at more than \$18 billion, including \$6.8 billion related to earthquakes, \$5.6 billion related to floods and \$5.4 billion related to storms (table 4.2).

The types and impact of disasters vary depending on geography and population concentrations. Large groups in Somalia and the Sudan have been affected by alternating periods of drought and flooding. Earthquakes in Algeria and storms in Oman have been among the most costly disasters in financial terms. Data are, however, missing for damage in several cases, especially in the LDCs.


## 2. Climate change

## (a) Impact and adaptation measures

Due to factors such as elevated solar radiation and heat-absorbent soils, the Arab region is

considerably more likely than others to be affected by the rising temperatures predicted under climate change scenarios. Through the Regional Initiative for the Assessment of the Impact of Climate Change on Water Resources and Socioeconomic Vulnerability in the Arab Region (RICCAR), the Swedish Meteorological and Hydrological Institute has generated temperature and rainfall distribution projections for the Arab region up to the year 2100, which predict a general rise in average temperatures during the period 2081-2100 of 1 to 3 degrees Celsius in the medium-case scenario and 2 to 5 degrees Celsius in the worst-case scenario, relative to the baseline 1986-2005. The areas with the highest expected

increases are in the Sahara in North and East Africa, including Morocco and Mauritania (figure 4.23).


**Figure 4.24.** Changes in the number of summer days (Tmax > 35°C) in 2081-2100 relative to the baseline 1986-2005 for RCPs 4.5 and 8.5

The RICCAR climate projections show an increase in the number of hot summer days (annual number of days when maximum temperature -Tmax > 35°C) expected by the end of the century throughout the Arab region (figure 4.24). The results indicate a significant warming trend reaching up to 80 days in the southern Arabian Peninsula in both scenarios and on the west coast of Africa in one of them. The projected increase in summer days will have a major impact on water supply, the health of vulnerable communities, and the duration of peak

energy demand periods needed for cooling purposes.

The projections indicate that precipitation in the period from 2081 to 2100 will exhibit greater variability than temperature. In general, average monthly precipitation will fall, particularly in the Atlas Mountains (where the worst-case scenario foresees a drop of up to 10 mm in average monthly rainfall) and in the upper Nile and Euphrates and Tigris river catchments, which is likely to further strain transboundary water cooperation in those basins by the end of the century (figure 4.25).

Changes in precipitation will have a major impact on agricultural communities (box 4.5).





The effects of drought have already been felt throughout the region. In the 1950s, drought led to the death of most rangeland animals in the northern and eastern parts of the Arabian Peninsula.<sup>48</sup>

Dense urbanization and socioeconomic development of coastal areas make the Arab region especially vulnerable to rising sea levels and coastal flooding caused by extreme weather events. Concentrated urban areas, often with poor infrastructure, line the coasts of the Mediterranean Sea, Red Sea, the Atlantic and Indian Oceans and the Gulf. Such coastal communities are thus directly threatened by climate change, as is low lying agricultural land near the coast.

Much work has been done at the regional level to build resilience to climate-related hazards. The Arab Climate Resilience Initiative aims to promote integrated regional responses

to climate change.<sup>49</sup> RICCAR is assessing the impact of climate change on freshwater resources across the Arab region.

It would be beneficial for Arab Governments to integrate climate change measures into national policies and strategies, along with environmental and disaster risk reduction mainstreaming. To be effective, resilience and adaption strategies need to be supported by improved education, awareness-raising and building human and institutional capacity on climate change mitigation, adaptation, impact reduction and early warning.

## (b) Greenhouse gas emissions and mitigation measures

Arab States are not bound by the Framework Convention on Climate Change to reduce greenhouse gas emissions. Nevertheless, 10 of them prepared statements of their intended voluntary actions (Intended Nationally

# Box 4.5. Climate change migration

Climate change can have a direct impact on people's lives and livelihoods. A clear example is the migration induced by climate change in the Syrian Arab Republic in recent years. Between 2006 and 2011, nearly 60 per cent of the population suffered the worst drought and crop failure in the country's modern history. By 2009, more than 800,000 Syrians had lost their livelihood as a result of drought and, by 2011, almost one million more had become exposed to food insecurity. In 2010, an estimated 200,000 people migrated from their farms to urban areas. What has occurred in the Syrian Arab Republic could well repeat itself elsewhere in the region, as farmers, dependent on rain and scarce water resources, are increasingly placed before the difficult choice of fight or flight.




Figure 4.26. Total emissions of greenhouse gases (1,000 metric tons of CO<sub>2</sub>)

Determined Contributions) ahead of the twenty-first Conference of Parties (COP21) to the Convention in December 2015.<sup>50</sup>




Figure 4.27. Emissions of greenhouse gases per capita (metric tons of CO<sub>2</sub>)

Total greenhouse gases emission increased by more than 140 per cent in the Arab region between 1990 and 2011 (figure 4.26). To some extent, the increase can be attributed to population growth. Nevertheless, even in per capita terms, emissions increased by more than 50 per cent between 1990 and 2011 (figure 4.27). The regional average of 5.29 metric tons of CO<sub>2</sub> per capita exceeded the global average of 4.9 in 2011.<sup>51</sup> There are large subregional variations: at 20.89 metric tons per capita in 2011, the average for GCC countries is around four times the global average, while Mashreq and Maghreb countries emit about two thirds of the global average. The LDCs are well below regional and global averages, with per capita

emissions less than one eighth of the global average.

By sector, carbon dioxide emissions are primarily attributable to electricity generation,

followed by transport, industry and construction, and public and private buildings (figure 4.28). In GCC countries, electricity generation, industry and construction (mainly in relation to refineries and oil derivatives)




Figure 4.29. Emissions of greenhouse gases per dollar of GDP (kilograms CO<sub>2</sub> per \$1 GDP PPP)

are the larger carbon dioxide emitters (67 per cent). Electricity generation and transport are the main culprits in LDCs (58 per cent).

The carbon intensity of the region's economy is worsening. In all subregions except the Maghreb, increases can be observed between the 1990s and 2011, with those in the LDCs being the most noticeable in relative terms (figure 4.29).

Improvements in some Arab countries may be attributed in part to mitigation efforts, such as: commercialization of wind energy in Egypt; widespread use of solar heating in Palestine, Tunisia and Morocco; the introduction of compressed natural gas as a transport fuel in Egypt; the first concentrated solar power projects in Algeria, Egypt, Morocco and Tunisia; the first two Arab green building councils in the United Arab Emirates and Egypt; Masdar, the first zero-carbon city in Abu Dhabi; and the pioneering carbon capture and storage project in Algeria. Although these efforts remain scattered as individual initiatives, they are a step in the right direction. There remains a lack

of overarching policy that would ultimately ensure best climate practices.

## 3. Marine ecosystems

The Arab region includes five main regional bodies of water. For each of these seas or oceans there is a regional conservation organization or programme. All face challenges regarding misuse and/or degradation of marine resources.<sup>52</sup>

The Mediterranean Sea suffers from eutrophication<sup>53</sup> of shallow waters as a result of discharges from agriculture, and the more than 200 petrochemical and chlorine plants and energy installations located along its coast. Fish production statistics indicate a relatively stable catch in the Mediterranean since the 1980s. Recently, native species (especially in the eastern Mediterranean) have been threatened by exotic Red Sea species entering through the Suez Canal.

The Red Sea and Gulf of Aden region is directly threatened by human activities such




Figure 4.30. Percentage of the population living in coastal areas (at five metres or less above sea level)

as the disposal of domestic and industrial effluent, the unsustainable use of non-living resources and the growing tourism industry. This body of water is particularly sensitive, having some of the highest temperatures and salinity levels in the world. Coral bleaching has already been observed in some areas. Regional cooperation on fisheries is limited and no formal regional stock assessment has been conducted.

The Gulf and Oman Sea area is under exponentially increasing stress due to the high concentration of fossil fuel-related activities, including large numbers of offshore installations, tanker loading terminals and tanker traffic. Several fish species, including kingfish, groupers and shrimp, have been listed a source of concern by FAO.

The Atlantic Ocean and the southwest Indian Ocean are a significant source of fish. For countries such as the Comoros, Mauritania, Morocco, Somalia and Yemen, the fisheries sector is important for food security. Fish production in Somalia and the

Comoros seems to have stagnated over the past decades, but no assessments of stocks have been made. Mauritania and Morocco, member countries of the Commission for Eastern Central Atlantic Fisheries, have implemented fisheries management measures in accordance with recommendations of various stock assessments.

In 2000, only 9 per cent of the Arab population resided in coastal areas below five metres above sea level, a slight decrease since 1990 (figure 4.30). Although the proportion of the population has remained stable, the total population in such areas has increased, placing greater stress on sensitive coastal environments.




Figure 4.31. Average annual fish catch (thousand metric tons)

Average annual fish catch rates for Arab countries increased by more than 180 per cent in 2013 compared with 1990, putting stress on fish stocks in marine bodies in the region (figure 4.31). The annual catch of 795,000 metric tons in the Mashreq countries that year represented an increase of more than 300 per cent since 1990. In the LDCs, the




Figure 4.32. Fish catch trends, by body of water (thousand metric tons)

rise between 1990 and 2013 was nearly 128 per cent. The catch in the Atlantic increased from around 600,000 metric tons in 1990

to 1.56 million metric tons in 2012 (160 per cent increase), representing by far the largest production in the region (figure 4.32).

Increases were also witnessed across other regional bodies of water, including rises of 59 per cent in the Red Sea and Gulf of Aden, 28 per cent in the Mediterranean, and 27 per cent in the Arabian Gulf and Sea of Oman.

## 4. Terrestrial ecosystems

Extremely arid, the Arab region is dominated by steppe and desert rangelands that constitute more than three quarters of the region's terrestrial ecosystems. Nevertheless, there is great diversity of plant and animal life well adapted to the conditions.

The three phytogeographical regions (Mediterranean, Irano-Turanian and Saharo-Arabian) contain a diverse collection of woody and herbaceous plants, especially annuals and geophytes.<sup>54</sup> Plant biodiversity is greatest in Algeria, Lebanon, Morocco, Somalia, the Sudan, the Syrian Arab Republic and Tunisia, where more than 3,000 species thrive.55 Plant density is estimated at 1,000-2,000 plant species per 10,000 square kilometres in Jordan, Lebanon, Morocco and the Syrian Arab Republic, and less than 1,000 per 10,000 square kilometres for the remaining Arab countries. There is a density of 21-50 animal species per 10,000 square kilometres in Egypt, Iraq, Jordan, Morocco, the Sudan, the Syrian Arab Republic and Tunisia, 51-100 in Lebanon, and fewer than 20 in the other countries.56

Biodiversity degradation in the Arab countries appears to match international trends. According to the International Union for Conservation of Nature and Natural Resources (IUCN), the total number of threatened species in the region stands at over 1,000, with a majority classed as "critically endangered". Of these, 24 per cent are fish, 22 per cent birds and 20 per cent mammals. Djibouti, Egypt, Jordan, Morocco, Saudi Arabia, Somalia, the Sudan and Yemen are host to many threatened species – up to 108 in Egypt.<sup>57</sup> In Yemen, 250 endemic species are threatened with extinction. In Oman, 136

plant species and 46 per cent of all native species are endangered.<sup>58</sup>

Invasive species are a key threat to the region's ecosystems. A total of 551 invasive species have been reported in the region, of which 35 per cent are classified as alien and nearly 51 per cent as native.<sup>59</sup>




Figure 4.33. Average vegetation coverage (percentage of land area)

The average vegetation cover as a percentage of land area in the Arab region declined from 3.68 per cent in 1990 to 2.84 per cent in 2013 (figure 4.33). That 23 per cent reduction was due in large part to a 33 per cent decrease in the LDCs, while other subregions witnessed relatively small increases.

Rangelands have been affected by overexploitation, with a major change in species composition over the past few decades. According to FAO,60 severe to very severe human-induced degradation affects up to 30 per cent of the total area of North Africa and 38 per cent of the Arabian Peninsula. Furthermore, between 1970 and 1990 rangelands decreased by 10 per cent in Morocco and Tunisia and 14 per cent in Algeria.61 Overgrazing remains the major factor in rangelands degradation.




Figure 4.34. Terrestrial and marine protected areas (percentage of total territorial area)

Arab countries have made efforts to preserve their biodiversity, including through the expansion of protected areas (box 4.6). As a percentage of total territorial area, protected areas grew from 3.21 per cent in 1990 to 9.28 per cent in 2012, an increase of around 190 per cent (figure 4.34). Despite that increase, protected areas in the Arab region remain below the global average of 14 per cent in 2012. A regional assessment of biodiversity and ecosystem services is urgently needed if the Arab countries are to strengthen the link between science and policy when it comes to conservation and the sustainable use of biodiversity.

ESCWA and other United Nations bodies could, in conjunction with the Intergovernmental

# Box 4.6. Integrating conservation with development in the Dana Wildlands in Jordan

In the mid-1990s, Jordan, with funding from the World Bank and the Global Environment Facility, launched the project on Conservation of the Dana Wildlands and the Azraq Oasis and Institutional Strengthening of the Royal Society for the Conservation of Nature. It was designed to improve management of the Dana Biosphere Reserve and pioneered the concept of community engagement in protected areas. Through an incentive-based approach, traditional livelihood options such as goat grazing were replaced with opportunities in industries such as ecotourism. The project was successful in generating income, and was gradually welcomed by the local population. The Dana project set the bar for biodiversity protection efforts by demonstrating the significance of integrating socioeconomic factors in conservation projects to ensure their acceptability and long-term sustainability.

Platform on Biodiversity and Ecosystem
Services (www.ipbes.net), develop a capacitybuilding programme for national stakeholders.
It would focus on conducting national
ecosystems assessments, in addition to pilot
and demonstration projects that benefit from
local knowledge. The Arab region could also
benefit from thematic assessments of marine
and coastal ecosystems, and land degradation

and restoration, such as have been carried out in other regions.

A regional assessment of biodiversity and ecosystems could help to mobilize multidisciplinary teams from regional and national research institutions, build partnerships with institutions in developed countries, contribute to knowledge

generation and sharing, and ensure access to data and information. It would be instrumental in determining a sustainable development baseline and examining the contribution of ecosystems to sustainable development.

# 5. Peace, Governance and Institutions

# 5. Peace, Governance and Institutions



The achievement of peace, good governance and effective institutions is a critical component of the 2030 Agenda for Sustainable Development. They are addressed specifically by SDG 16 (SDG 17 also partly addresses institutional issues) but have a key role to play in the achievement of the other goals. None of the SDGs can be achieved where there is violence, the people have no voice, Governments cannot be held to account, societies are unfair and the justice system does not work.

The importance of those issues in the Arab region, plagued by political instability, internal conflicts, war and ongoing occupation, has become clearer still in recent years. A former United Nations Secretary-General, Mr. Kofi Annan, once said: "Humanity will not enjoy security without development, it will not enjoy development without security, and it will not enjoy either without respect for human rights".

In 2015, the Arab region ranked as the least peaceful part of the world, suffering as it does under the Israeli occupation of Palestine and the dramatic worsening of conflicts in Iraq, Libya, the Syrian Arab Republic and Yemen.

There have been improvements in some areas of governance in some Arab countries, such as the holding of free and fair elections. However, in other respects, such as freedom of expression, matters have worsened. The record on fairness and justice is mixed and the matter of legal identity remains of particular concern.

Several countries provide good examples of capacity to implement strategies with broad ownership, harmonize short-term actions with long-term priorities, coordinate across ministries, and make full use of evidence. Regional mechanisms are being established and strengthened in order to support national stakeholders in this work.

This chapter is largely based on expert reports on governance, human rights and institutions for sustainable development.<sup>1</sup>

# A. Peace and security

Violence and instability are becoming the greatest obstacles to achieving sustainable development in the Arab region. In fragile States and those affected by conflict and violence, people are twice as likely to be undernourished than in other developing countries and the number of children not in school is three times as high. Conflict sets back GDP growth, in some cases by decades, and can add another 20 per cent of the population to those living below the poverty line.<sup>2</sup> If occupation and insecurity persist, sustainable development will be impossible.

## 1. Occupation

The Israeli occupation of Palestinian and other Arab lands is the only remaining case of military occupation in the world today. For decades, Israel has repeatedly, and with almost total impunity, violated international humanitarian and human rights laws, including the denial of the Palestinian people's rights, particularly their right to freedom and self-determination. Israeli practices have severely curbed their right to development, causing in fact a process of "de-development" (reversal of development gains). This is not to mention the regional repercussions of the occupation and the resulting wars that have affected the entire Arab region. Achieving the 2030 Agenda in Palestine will be impossible until Israel ends its occupation, an independent Palestinian State is established and the right to return of Palestinian refugees is recognized. The role of the international community in enforcing international law and supporting development in Palestine is crucial.

## (a) Occupation and de-development in Palestine

Israeli violations of international humanitarian law and human rights law are widely documented.3 The Israeli blockade and repeated offensives against Gaza are a stark example of such violations (box 5.1). Although Israel is party to the Fourth Geneva Convention relative to the protection of civilian persons in time of war, its forces have used excessive force against Palestinian civilians, killing more than 10,000 Palestinians since 1987. Between 2000 and 2014, 1,918 Palestinian children were killed by Israeli forces and settlers. Israeli security forces have used torture and various forms of illtreatment against detainees. It is reported that 125 Palestinian prisoners died due to torture or ill-treatment up until 2013. Minors are not spared, with the United Nations Children's Fund (UNICEF) documenting 107 cases of illtreatment of Palestinian children in 2013, 11 of whom were under the age of 14.

Forced displacement of Palestinians and the destruction and confiscation of their property by the Israeli authorities continue. Some 135,000 Palestinians have been evicted from their homes since 1967 and, until 1993, around 250,000 Palestinians had their residency permits revoked, leading to their de facto exile. Between 1967 and 2010, some 24,800 buildings were demolished in occupied Palestinian territory. Successive Israeli Governments have continued to build settlements on expropriated Palestinian lands in the occupied territory since 1967. By mid-2014, the number of Israeli settlers in the West Bank, including East Jerusalem, was estimated to have reached 700,000, quadrupling since the Oslo Accords.4 Israeli policies regarding the settlements in the occupied Palestinian territory have resulted in the emergence of dual legal regimes that discriminate between people living within a single territory based on religion. 5 Barrier zones surrounding some settlements have created additional restrictions on the mobility of Palestinians, which is already severely constrained due to the separation wall, Israeli checkpoints and other obstacles and administrative and military measures.

The Israeli occupation has hampered access by Palestinians to water, food, health and education, which are among the basic human rights. Since 1967, Israel has controlled all shared water resources in the West Bank (surface and groundwater) and exploited 85 per cent of them. The destruction in 2014 of the only power plant in Gaza left 1.5 million residents without access to adequate water supplies. In 2013, one in every three households in the occupied Palestinian territory was considered to be food insecure, and more than half the population of Gaza depends solely on humanitarian food distribution.7 Palestinians are frequently denied access to adequate medical care. Pregnant women are particularly affected, with more than 67 Palestinian mothers giving birth at Israeli checkpoints during the past 15 years. There is a shortage of educational facilities in the West Bank and those that exist are inadequate. Around 10,000 Palestinian students attend makeshift "schools" under tents or in tin shacks. In East Jerusalem, 2.200 more classrooms are needed to accommodate students.

Economic development in Palestine is hampered by "frequent military strikes and the destruction of infrastructure, isolation from global markets, fragmentation of domestic markets and confiscation and denial of access to national natural resources."8 Following the 2014 military offensive in Gaza, the Palestinian economy suffered once more: per capita GDP shrank by 3.3 per cent, unemployment increased by 3 per cent and the fiscal deficit widened. During the first quarter of 2015, Israel withheld clearance revenue - the largest source of public revenue for the Palestinian Government thus aggravating an already bleak economic situation. Forced dependence on electricity

and water imports from Israel further saps Palestinian resources. This process of "dedevelopment" undermines donor support, which is already insufficient and in decline.<sup>9</sup>

## (b) Impact of the occupation beyond Palestine

The occupation of Palestine has created a protracted refugee situation. More than three million Palestine refugees (out of a total of 5.2 million Palestinian refugees in the world), registered with the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA), live in dire conditions in camps in Lebanon, Jordan and the Syrian Arab Republic. 10 A socioeconomic survey of Palestinian refugees in Lebanon<sup>11</sup> reported that two thirds of them are poor, one third suffer from chronic illnesses, and 15 per cent are severely food insecure. They face social and economic exclusion and unemployment among them exceeds 50 per cent (higher still for women). Eight per cent of children aged 7-15 years do not attend school and only half those aged 16 and above do so. Fighting in the Syrian Arab Republic has damaged most Palestinian camps and severely affected the 560,000 refugees living there. Many of them have been displaced, either within the country or abroad.

The Israeli occupation and ensuing wars have had a profound effect on the region as a whole, hindering regional integration and sustainable development by diverting resources away from development, and weakening governance. Partly as a result of the Israeli occupation and related conflicts and instability, the Arab region spends more on weapons (4.15 per cent of GDP) than any other in relative terms, placing a great strain on public finance. 12 Some scholars believe that occupation and the resulting wars have hindered the promotion of democratic governance in several Arab States and fuelled religious extremism, giving them an excuse to "prioritize" resistance against Israel and the containment of extreme religious elements at the expense of granting their own people basic human rights.<sup>13</sup>

# Box 5.1. Blockades and repeated offensives cripple Gaza

The 1.7 million Palestinians in Gaza have lived under blockade since 2007, with severe socioeconomic consequences. Three military offensives since 2009 have taken a heavy human toll. More than 1,700 civilians were killed in the 2009 offensive and almost 1,500, including 500 children, in the 2014 summer offensive. In 2009, almost half of the health facilities in Gaza were damaged or destroyed. During the 2014 offensive, 17 hospitals, 56 clinics and 32 ambulances were damaged, and 16 medical workers lost their lives while on duty. The education system was similarly crippled, with 26 schools destroyed and 122 damaged, 69 of them run by UNRWA. The pace of reconstruction has been extremely slow for a number of reasons, including Israeli restrictions on the import of construction material.

The impact on the economy is substantial. Unemployment in Gaza reached 44 per cent in 2014, the highest level on record. The middle class is effectively non-existent and most households depend on humanitarian aid. The United Nations Conference on Trade and Development (UNCTAD) estimates that the cost of the three offensives to Gaza is in the order of three times its annual GDP. Including indirect costs lifts the estimate considerably. In 2012, the United Nations predicted that Gaza could be "unliveable" by 2020 if current trends continued, a view restated by UNCTAD in 2015.

#### 2. Conflict and war




Figure 5.2. Incidence of conflict (percentage of countries suffering from at least one internal conflict between 2009 and 2014)

The Arab region is the least peaceful in the world, according to the Global Peace Index (figure 5.1). Topping the list of least peaceful countries in the world in 2015 was the Syrian Arab Republic, followed by Iraq, Afghanistan, South Sudan, Central African Republic, Somalia and the Sudan. According to ESCWA, 11 out of 22 Arab countries have suffered at least one internal conflict since 2009 (figure 5.2).





Figure 5.3. Global Peace Index domain scores, 2015

The Global Peace Index considers three main categories: militarization, safety and security, and ongoing conflict. The Arab region and North America are the most militarized regions in the world (figure 5.3). In terms of ongoing conflict, South Asia is still considered worse than the Arab region as a whole, although the Syrian Arab Republic, the Sudan, Somalia and Iraq are among the 10 worst countries globally in that category.

The situation in the Arab region deteriorated in 2015 across many subindicators because of the dramatically worsening situations in Iraq, Libya, the Syrian Arab Republic and Yemen, where challenges to central Governments have been complicated by internationalization of those conflicts, sectarian divisions and the expansion of the so-called Islamic State group (figure 5.4). Libya and Djibouti were among the top five countries with the most dramatic increases in violence in 2015.

According to the Global Terrorism Index report for 2014, the Arab region has undergone a steep increase in recent years in the Maghreb and Mashreq, while the level of terrorism in LDCs remained relatively high (figure 5.5). 16 From 2000 to 2013, about half the world's suicide attacks took place in the Arab region (more than 45 per cent of them in Iraq and the Syrian Arab Republic). Citizens of the Arab region also suffer from the violence associated with occupation and brutality against non-violent political protesters.

Conflict and political violence in the region have taken a heavy toll in fatalities and caused massive displacement. The Global Peace Index estimates conflict-related fatalities for 2014 at 71,667 in the Syrian Arab Republic, 18,489 in Iraq, 3,836 in Yemen, 3,060 in Libya, and 360 in Lebanon. Millions have been forcibly displaced as refugees and

internally displaced persons (IDPs), which has resulted in a loss of productivity (as in most cases they are unable to work), and has placed great strain on host countries in terms of natural resources and the environment, infrastructure, social conflict, and the financial cost to host Governments of providing services.




Figure 5.6. Refugees and IDPs by country of origin, 2014





As of 2014, refugees from the region exceed 11 million persons (figure 5.6 (a)). This represents 58 per cent of the global total (27 per cent from

Palestine, 20 per cent from the Syrian Arab Republic, 6 per cent from Somalia, 3 per cent from the Sudan and 2 per cent from Iraq).

At 15 million (figure 5.6 (b)), IDPs in the region account for 46 per cent of the world total (24 per cent in the Syrian Arab Republic, 11 per cent in Iraq, 7 per cent in Somalia and 4 per cent in the Sudan).

At the end of 2014, there were around 3.9 million Syrian refugees, with more than

630,000 registered in Jordan – almost 10 per cent of the population – and more than 1,170,000 registered in Lebanon – more than a quarter of the population.<sup>17</sup> UNRWA reports 5.1 million registered Palestinian refugees.<sup>18</sup> Figure 5.7 shows the trends in the Arab region between 1997 and 2014. The refugee crisis continues to affect mostly the Mashreq




Figure 5.8. Internally displaced persons

subregion, and most refugees appear to remain in the region.

More than 7.6 million Syrians and 3.6 million lraqis were reported to be IDPs, making the Mashreq the subregion with the highest figures worldwide, followed by the LDCs, with 2.2 million Sudanese and 1.1 million Somali IDPs. Figure 5.8 shows the trends in the Arab region between 1997 and 2014. In line with the 1951 Convention relating to the Status of Refugees and the human development goals of UNRWA, host countries should work more closely with national, regional and international aid agencies and allow them to implement their programmes.

# B. Governance

Arab States are often referred to as rentier systems - sharing rents with the people in exchange for political acquiescence. Some have been able to maintain stability through revenue redistribution but the question remains whether the system is sustainable.

One common rent-sharing mechanism is the provision of civil service jobs, with limited expectations for performance. <sup>19</sup> The civil service thus becomes a means of avoiding the need for government accountability rather than for the provision of quality public services. Such systems are also characterized by unfair pay scales, over-staffing and rigid hierarchies.

What the United Nations Development Programme (UNDP) termed the "deficit of freedom and good governance" in its 2004 Arab Human Development Report needs to be addressed if the region is to achieve sustainable development. Good governance is a key SDG and a necessary enabler of all of the other goals.


Measuring governance is challenging and a plethora of indicators for doing so have emerged over the past two decades. Some focus on rules and procedures, some on their implementation and still others on the economic, social, environmental and other impacts of governance. Indicators can provide valuable information but they can also be misused, skewed to favour a certain ideology, behaviour, policy or institutional

# Box 5.2. ESCWA framework for monitoring governance

In its *Arab Governance Report: Governance Challenges in Countries Undergoing Transition* (E/ESCWA/ ECRI/2013/4), ESCWA defines democratic governance as a system of collectively binding traditions, rules and policies that regulate a society and that are created, modified and controlled by its members through participative and representative arrangements, based on respect for human rights and equal rights and obligations. Contestation, inclusiveness, the division of powers and institutional capacity are crucial for democratic governance.

The main building blocks of democratic governance are: clear constitutional and human rights principles; political stability and the absence of violence; institutional effectiveness and accountability; inclusiveness and transition-related reforms; and economic governance and effective service delivery. These are rendered operational through the eight pillars depicted in the figure below.

Each country defines its priorities and chooses among the pillars and subcategories those that require urgent attention. The resulting framework will thus be adapted to national priorities and help to identify policy actions that could improve governance. It is expected, however, that many essential variables will require the collection of primary data.



design. When many variables are combined into one broad indicator, the composite indicator is often vague. ESCWA has proposed a comprehensive framework for monitoring democratic governance, focusing on regional specificities and priorities (box 5.2).

The remainder of this chapter highlights governance issues referred to in SDG 16 and which are of special relevance to the Arab region.

# 1. Rule of law and justice

Rule of law and justice include a range of issues. Three are highlighted here: corruption, legal identity and the functioning of the justice system.

## (a) Corruption

Corruption hinders sustainable development by shifting government priorities and

financial resources towards the private interests of the powerful. It has been asserted that corruption in Arab countries that underwent uprisings is exemplified by "the ruling elites, including extended family and select cronies, who captured both the polity and key segments of the economy [...] to control the accumulation and distribution of resources and jobs to perpetuate their power and amass illicit wealth." 20 Many studies have examined the costs of corruption. One revealed that, between 2002 and 2006, an average of \$111 billion per year flowed illicitly out of the region due to corruption, crime and tax evasion.<sup>21</sup> Studies also show that the poor pay the heaviest price due to those losses.<sup>22</sup>

Transparency International's Corruption Perceptions Index (CPI) shows that the Middle East and North Africa area is widely seen as corrupt. Some countries rocked by the 2011 uprisings had the worst scores on the index prior to the uprisings. Similarly, the Arab region as a whole scores 3.5 out of 10 for separation of powers on the Bertelsmann Stiftung Transformation Index (BTI)<sup>24</sup> – far below the global average of 5.3.

Unclear and overly complex non-standard bidding documents, lengthy procurement processes, bribery and other opportunities for corruption abound in the region. Systems of checks and balances are needed in the public sector to prevent corrupt individuals from taking advantage of positions of power. Civil servants need to be schooled to serve the public fairly and equitably in accordance with the law. Action must be taken against those who do not. In many Arab countries, this does not occur. A United Nations study of six Arab countries noted "a significant gap between policies and practices, particularly for reporting on and investigating wrongdoing".25

The Global Competiveness Index provides rates for three specific aspects of corruption

- favouritism in decisions of government officials, diversion of public funds and irregular payments and bribes. Among the 15 Arab countries included in the 2014-2015 Global Competiveness Index survey, nine scored better than the worldwide mean score in terms of favouritism and diversion of public funds, and eight scored better than the worldwide mean score in terms of irregular payments and bribes. However, in all three categories most Arab countries have seen a deterioration since 2010.

#### (b) Legal identity

Denial of citizenship is widespread in the Arab region and affects several groups including Palestinians, the Bidun and children whose fathers are not citizens of the country concerned. For example, the Citizenship and Entry into Israel Law of 31 May 2003 suspended the possibility of Palestinians from the occupied Palestinian territory of obtaining Israeli residence permits or citizenship in Israel, including through family reunification. The effect of this discriminatory law is that thousands of Palestinian families must separate, emigrate or live illegally in Israel under constant threat of arrest and deportation. The Bidun ("those without" nationality) group is concentrated in the Gulf countries. During the 1980s, many had their rights revoked by law and have consequently been unable to work, travel, receive education or health benefits, register marriages or, in most cases, even obtain a driver's license. Improvements have been made since 2000 and several thousands have been granted citizenship.<sup>26</sup>

Thirteen of the 27 countries around the world in which men and women do not have an equal right to pass citizenship on to their children (or spouse) are in the Arab region. UNHCR distinguishes various categories. Countries that allow some safeguard against the child's statelessness (for example, if the father is unknown or stateless himself) include

Bahrain, Iraq, Jordan, Libya, Oman, Saudi Arabia, the Sudan, the Syrian Arab Republic and the United Arab Emirates. Countries that provide no (or extremely limited) exceptions include Kuwait, Lebanon, Qatar and Somalia.<sup>27</sup>

### (c) The justice system

In addition to the fairness of laws, the administration of justice must be effective so that people may resolve grievances in a peaceful manner. Effectiveness refers to the system's capacity to investigate, adjudicate and enforce judgments in a timely and impartial manner. Accessibility includes general awareness of available remedies, the availability and affordability of legal advice and representation, and the absence of excessive or unreasonable fees and hurdles.

The World Justice Project's Rule of Law Index provides ratings for only six Arab countries: Egypt, Jordan, Lebanon, Morocco, Tunisia and the United Arab Emirates. The United Arab Emirates and Jordan score highest on civil and criminal justice (two of the index factors). The United Arab Emirates scores well on enforcement of civil justice, but much lower on access to affordable civil justice. By contrast, Egypt scores significantly higher on access to affordable civil justice than on enforcement (figures 5.9 and 5.10).

Access to justice typically is limited for people in situations of vulnerability, among them migrant workers (box 5.3).

The role of the police and armed forces in law enforcement and security also warrants special attention in the Arab region,

particularly in countries affected by conflict and terrorism. Their activities are well defined under international law, including the human rights treaties and the Code of Conduct for Law Enforcement Officials, 28 and are based on the need to respect fundamental rights of people under all circumstances, including when placing them under arrest and during interrogation. Suspicion must be based on tangible evidence. Torture is strictly prohibited.

This is particularly important within the Arab region where many countries are in conflict or post-conflict situations and suffer directly from terrorism. Bypassing the rule of law and violating human rights in an effort to restore order and confront terrorism is counter-productive, and may have the unintended consequence of driving victims of such violations into the arms of terrorism. Counter-terrorism measures adopted by a number of Arab countries have included the implementation of broad and vague antiterrorism laws that have adversely affected whole populations by legalizing undefined periods of pretrial detention, the death penalty, curbs on freedom of expression, and telephone tapping.<sup>29</sup>

# **Box 5.3.** Access to justice by vulnerable groups: Migrant workers

Regulation of the labour market and migrant labour is a prerogative of the State, but legislation governing employment must be consistent with human rights. In many Arab countries, that is not the case. The sponsorship system applied in some countries ties migrant workers legally to their employers and is thus open to abuse. The system gives employers excessive liberties to "protect their investment", including by holding workers' passports.

The situation of migrant domestic workers in the region, the vast majority of whom are women, has been heavily criticised, including by United Nations' human rights bodies. Domestic workers are often not covered by national labour laws and face difficult working conditions, such as low pay, deprivation of freedom of movement, the withholding of passports and lack of legal recourse.<sup>a</sup>

# Box 5.4. Nascent independent government bodies

Several independent bodies are mandated to monitor and investigate government conduct in some Arab States. They include: the Independent Election Commission and the Anti-Corruption Commission in Jordan; the Commission of Integrity in Iraq; the Instance Nationale de la Lutte Contre la Corruption in Tunisia; the Instance Centrale de la Prévention de la Corruption in Morocco and the State Audit Institution in the United Arab Emirates, which is mandated to ensure that public funds are used in compliance with federal law and oversees the effective management of the State budget. Such institutions are still in their infancy and they are often criticized for being independent more in name than in practice.




Figure 5.11. Selected Worldwide Governance Indicators, 2014

## 2. Transparency and accountability

Transparency in policymaking is essential for citizens to know what their leaders are doing. In this regard, the situation in the region, as deducted from the Global Competitiveness Index, is mixed. While half the Arab countries have improved transparency in recent years, the other half have slid backwards.<sup>30</sup>

In terms of budget accountability and comprehensiveness, the Middle East and

North Africa (MENA) area rates better than the average for low income countries but not as well as middle-income countries (box 5.4). Based on the Public Expenditure and Financial Accountability Index, the region's public financial management systems are roughly comparable to those of other countries at similar income levels, although the region's deficiencies are evident in areas such as credibility of the budget and accounting, recording and reporting.<sup>31</sup> Similarly, the International

Monetary Fund (IMF) Budget Institutions Index finds that, although the MENA area ranks comparatively well overall, there are deficiencies with regard to budget implementation, sustainability and credibility, and transparency.<sup>32</sup> In the Open Budget Index of 2015, most of the 11 Arab countries considered ranked as providing minimal or no budget transparency (only Jordan, with a score of 55 out of 100, and Tunisia, with 42, ranked as having "some" transparency).

The region's poor ranking cannot be explained by lack of technical competence. Figure 5.11 shows that, while the MENA area ranks lowest in the world in terms of voice and accountability, its rankings are close to world averages in terms of the competence-related indicators of regulatory quality and government effectiveness.


In addition to government accountability and technical competence, the BTI assesses the extent to which policymaking addresses environmental sustainability. Somalia has the lowest score possible and in the cases of Jordan, Morocco and the Syrian Arab Republic, performance has declined since 2006. All Arab countries score below 5 out of 10, reflecting a lack of integration of environmental concerns into economic policy (figure 5.12).

## 3. Participation in decision-making

Voice and accountability are associated with higher levels of development. In the Arab region, this association has tended to be weak. Although the level of development in Arab countries varies widely in terms of per capita GDP, all are below global averages in terms of voice and accountability (figure 5.13). Furthermore, popular dissatisfaction in that regard has been among the primary causes of often violent political instability.

According to article 21 of the International Covenant on Civil and Political Rights, all citizens have the right to participate

in public affairs, generally understood as participation directly or through representatives chosen in fair and free elections. However, democratic participation equally encompasses the notion of the right to express views on policy. Participation broadens the legitimacy of policies, development plans and projects, and ensures that priorities reflect the needs of a given region or locality. It also implies that all competing interests are represented. While not all of those interests may be met in the end, open debate contributes to the public perception that the interests of the broadest possible majority take priority.


The benefits of participation extend to the implementation of plans. For example, efforts to deal with pollution, climate change and water scarcity cannot succeed without the involvement of civil society. In addition to raising public awareness of environmental issues, they can encourage

people to engage in preventing pollution, recycling and conserving water. Their participation is crucial if State policies are to bear fruit.

In the uprisings of 2011, people in a number of Arab countries expressed their demand for a greater say in political decisionmaking. In some cases, those demands have resulted in positive change, but in others matters have only become worse. According to the BTI, most Arab countries have seen improvements with regard to the holding of free and fair elections. However, the figures are open to interpretation. Improvements were recorded in Tunisia and Libya, but the two cases could not be more different from one another. The score of Libva increased between 2006 and 2014 because its elections were well administered, despite the fact that participation was low and armed conflict ensued afterwards. Some countries continue to hold the lowest score possible. The index is less clear with regard to changes in the role of civil society. While the extent to which the Governments allow civil society to participate in the political process has improved, there was a general deterioration in terms of "civil society traditions" (social capital and the number of actively engaged civic associations).

In the Arab region, legislation on free expression is generally vague and draws red lines around criticism of policy and the Head of State. Human rights reports frequently contest the legality of arrests and trials of people for alleged crimes under such laws.

Although the rights of association and assembly have been bolstered in most Arab countries since 2006, they remain at the lowest possible levels in Saudi Arabia, Somalia and the Syrian Arab Republic (figure 5.14).<sup>33</sup> In fluid situations such as those prevailing in a number of

Arab countries, assessments can change dramatically over short periods of time.

# C. Institutions

The SDGs need to be included in national development planning if they are to be achieved. Regional institutions also play an important role in consolidating national efforts, disseminating information and facilitating peer learning. Adequate follow-up and review mechanisms will be key at all levels.

# 1. National institutions for sustainable development

National development planning in Arab countries has rarely focused on sustainable development. Box 5.5 provides a selected list of recent documents and presents some of the lessons learned from national experiences. Recent assessments of national planning experiences have highlighted the importance

of broad ownership, strategic prioritization, coordination across ministries, and the full use of evidence. Sustainable development requires a balance between its various economic, social and environmental objectives, which in turn necessitates continuous dialogue among representative and credible actors.

## (a) Ownership

National ownership is fundamental. National development strategies require a country-driven process promoting partnerships between government, domestic stakeholders and development partners. Taking into account the views of different institutions, interest groups and non-governmental organizations (NGOs), from various parts of the country increases the quality of strategies and policies and encourages support for them when they are carried out.

Mechanisms for enhancing stakeholder consultation can come in the form of national councils or advisory bodies, or less structured forums, ad-hoc advisory groups, expert panels and focus groups. Sustainable development experts tend to prefer the creation of dedicated national councils,<sup>34</sup> made up of representatives of government, civil society, academia and business. However, a range of different approaches may be most useful for involving stakeholders in strategic planning with a view to obtaining the outcomes that citizens

most care about. Consultations can constitute an independent review function to ensure accountability and to recommend corrective or adaptive actions.<sup>35</sup>

In the Arab countries, ad-hoc dialogues, forums, intersectoral consultations and workshops are common. Unfortunately, they have largely been characterized by a lack of

# Box 5.5. Examples of recent national development strategies and lessons learned

Notable examples of national development strategies in Arab countries in recent years include:

- Development Strategy of the New Tunisia (2012); National Sustainable Development Strategy 2016-2020 (2014); Guidance note for the strategic development plan 2016-2020 (in preparation)
- Iraq's National Development Plan 2010-2014 (2010)
- Egypt's Strategic Framework for Economic and Social Development to 2022 (2012)
- Algeria's National Strategy for the Fight against Poverty (2005-2015) and Five-Year Plan (2010-2014)
- The Sudan's Interim Poverty Reduction Strategy Paper (2012)
- Djibouti's Poverty Reduction Strategy Paper (2009)
- Morocco's National Sustainable Development Strategy (2015)

### A number of lessons learned can be distilled from these experiences:

- Linking national strategies to international goals is helpful in increasing the volume of development aid received, but no single set of policies is applicable in all countries. Attention needs to be paid to specific national issues.
- Broad ownership of plans increases their effectiveness and can be enhanced through extensive consultations.
- Sustainable development requires a long-term strategy and short-term action planning. The sequencing and speed of reforms, in particular, affects success. Sustainability requires an intergenerational view.
- It is essential to coordinate planning and implementation between ministries and sectors. Clear
  institutional arrangements are important to provide ministerial accountability and coordination.
  High-level leadership is essential.
- Plans benefit from evidence during strategy development and perhaps even more so implementation, to allow policymakers to monitor progress against indicators, modify plans as needed and allow for accountability.

sustained engagement with stakeholders or understanding of key sustainable development issues by the stakeholders themselves, and by their poor communication and negotiation skills. However, Tunisia has made strides towards stronger participation and ownership (box 5.6) and in Morocco, an economic, social and environmental council (www.cese. ma), with representatives from the public and private sectors, NGOs and academic institutions, has been set up.

## (b) Strategic prioritization




Figure 5.15. BTI: Government's record of setting and maintaining strategic priorities

The Arab countries have varying capacity for setting and maintaining priorities in planning (figure 5.15). Perhaps one of the biggest challenges is to align a long-term vision with short-term, sector-specific action plans. Such "multi-tiered" planning is essential and a good example from the region is Qatar's

planning framework (box 5.7). Morocco's National Sustainable Development Strategy was developed through a participatory process and is based on four main principles (box 5.8).

Countries affected by conflict encounter particular difficulties. Lebanon has embarked on the formulation of a national sustainable development strategy despite the prevailing climate of political instability and spillover effects from the civil war in the neighbouring Syrian Arab Republic. The strategy contains clear objectives (box 5.9).

#### (c) Coordination

Consistency between sectors and ministries is essential. During the planning phase, trade-offs and synergies among sector plans need to be identified and negotiated. Implementation must

# Box 5.6. Participation and national sustainable development planning in Tunisia

Since the early 1990s, Tunisia has pioneered the establishment of institutions for sustainable development. The National Commission for Sustainable Development headed by the Prime Minister was created in 1993. Three years later, the national Agenda 21 action plan was developed and subsequent five-year development plans included considerations of sustainability. Those endeavours were largely State-led and development policies still had shortcomings. Since the transition that ensued after the 2011 uprising, the role of civil society has become more prominent. The new Constitution adopted in January 2014 explicitly enshrines the principles of sustainable development and the economic, social and environmental rights of citizens.

A new sustainable development strategy was prepared between 2012 and 2014 in a context of acute political, social and economic challenges, wide regional disparities, and a growing demand for real participation by citizens and stakeholders. Creation of the strategy comprised four steps: (a) a draft strategy document was prepared by national consultants, under the Ministry of Environment; (b) workshops were held in various regions to discuss it; (c) national consultations took place involving experts and consultants from public administrations, academic institutions, civil society and the private sector; and (d) a national conference on the "foundations of sustainable development" (Les Assises Nationales du Développement Durable) was organized in early October 2014.

The conference resulted in the adoption of the strategy, which addresses six priority areas (production and consumption patterns; management of natural resources, ecosystems and adaptation to climate change; quality of life and pollution control; land use planning, the city and transportation; education, innovation and knowledge management; and environmental governance for sustainable development). The findings of the conference and the final version of the strategy will be incorporated into the next development plan (2016-2020).

# Box 5.7. Qatar's multi-tiered planning process

Qatar has laid out a long-term planning framework (National Vision 2030), a medium-term action plan (National Development Strategy 2011-2016) and medium-term sectoral strategies. The vision sets clear long-term goals concerning four specific pillars. The national strategy aims to coordinate sectoral and enterprise strategies and contains priority development plans for 14 sectors, with corresponding targets to be achieved by 2016. The targets of the national strategy are themselves a subset of those contained in 14 comprehensive sector strategy reports. The annual budget is the Government's main instrument for short-term economic management and the strategy lends the budget a forward-looking and results-based orientation, aligning major investments with the country's overarching development goals.

# Box 5.8. Morocco's National Sustainable Development Strategy

Morocco's National Sustainable Development Strategy was developed through broad consultation with the public sector, private businesses and civil society. It has four main principles:

- Efficient economy: An efficient economy is a driving force for sustainable development. Sectoral
  strategies and proactive policies should be consistent with economic development objectives.
  Obstacles to competitiveness need to be removed through systematic intersectoral convergence
  and better integration of social and environmental considerations. A circular economy can be
  truly green.
- Human development and social cohesion: Policies are required to reduce disparities with regard
  to access to health care and free and quality education for all. Poverty reduction plans should
  target the most deprived sectors of society, including rural populations who protect natural
  resources such as water reserves and forests, and prevent desertification.
- 3. The environment: Environmental matters should not be addressed in emergency situations alone. Environment initiatives can help to foster sustainable growth and green jobs.
- 4. Culture: Promotion of national culture will make it possible to maintain traditional social specificities. All segments of the population, including people living in remote areas, can help to promote the development of their cultures.

# Box 5.9. Lebanon's national sustainable development strategy

The Ministry of Planning in Lebanon began work on its first national sustainable development strategy in March 2015. The country already had strategies for key sectors such as social development, territorial planning, industrial development and human rights. They were studied and objectives were identified for a national strategy, in alignment with the SDGs. Those objectives include:


- Development of human capital and a labour force of international standards
- Consolidation of social cohesion
- Provision of everyday necessities
- · Promotion of economic growth
- Preservation of natural and cultural heritage
- Good governance
- Repositioning of Lebanon on the Arab, Mediterranean and international maps

Three key challenges to the eventual success of the national strategy were identified:

- Ensuring ownership and the commitment of key stakeholders to the strategy
- Enhancing existing institutions responsible for aspects of sustainable development, such as coordinating, mainstreaming, monitoring and reporting on progress
- Mobilizing the required funding and support of international partners for implementation of the strategy



be coordinated in order to ensure accountability and avoid overlaps or gaps in ministerial mandates. On planning and implementation, Somalia, the Sudan and the Syrian Arab Republic score particularly poorly among the 15 Arab countries included in the BTI study (figures 5.16 and 5.17). The United Arab Emirates scores particularly highly on policy coordination.

# Box 5.10. Jordan's Higher National Committee for Sustainable Development

The Higher National Committee for Sustainable Development in Jordan was formed in 2002. It is chaired by the Minister of Planning and International Cooperation, whose deputy is the Minister for the Environment. It includes representatives from 22 government and non-government institutions and meets quarterly. The Committee is mandated to:

- Participate in setting national priorities and ensure planning consistency
- Mainstream environmental concerns into national plans and sectoral strategies
- · Endorse action and financing plans, and local development and decentralization frameworks
- Approve policy documents and enhance the application of good governance principles
- Review and amend legislation in line with sustainable development requirements
- Review and endorse national reports on progress in sustainable development

Three subcommittees on economic, social and environmental issues prepare concept papers and periodic progress reports, contribute to awareness-raising campaigns and propose executive action plans. However, the role of the Committee could be bolstered as part of Jordan's drive to transform itself into a green economy.

A comprehensive planning process requires a cross-ministerial coordination mechanism linked to budgetary processes in order to make decision-making effective and to foster timely implementation. Such a mechanism could come in the form of an interministerial steering or oversight committee, a planning commission, or some kind of national sustainable development body. The most successful examples are overseen by the Head of State, involve high-level representation from a wide range of ministries, include subnational or local government representatives, and are tasked with the drafting and carrying out of a national development strategy. Coordination mechanisms require strong and technically capable secretariats or planning departments. Jordan provides a good example (box 5.10).

National Governments may set countrylevel goals and the mandates to support them, but it is often local governments that are responsible for implementing them. Devolution of decision-making to the local level can be encouraged through subnational and local plans that are linked to centralized economic planning.

## (d) Use of evidence and the science-policy interface

Evidence is needed to provide an objective basis for policy and any subsequent modifications, and to ensure accountability. On its own, evidence guarantees nothing, but the exchange of knowledge between experts (scientists) and policymakers aimed at enriching decision-making is increasingly seen as a critical aspect of governance.

A precondition for evidence-based policy is the availability of sustainable development data, which in turn requires national statistical capacity and a willingness by policymakers to be innovative and flexible. This is covered in chapter 6.

A wide range of evidence-based analytical approaches, models and tools have been developed to support robust policy design. Scenario analysis is increasingly used in

# Box 5.11. Examples of evidence-based analytical approaches

#### Scenario modelling for MDG simulations in Arab countries

The World Bank's Maquette for MDG Simulations (MAMS) is a dynamic CGE model that has been extended to cover the generation of outcomes in terms of growth, MDGs, and the educational make-up of the labour force, as well as the interaction of these outcomes with other aspects of economic performance. It also uses methodologies at the microlevel to identify determinants of MDG achievement and to quantify effects on poverty and inequality. The modelling is based on a social accounting matrix for each country, which is designed to form a consistent and comprehensive accounting framework for addressing alternative MDG strategies. ## Saudi Arabia - CGE modelling and dashboard monitoring tool

ESCWA and other United Nations agencies are helping the Ministry of Economy and Planning in Saudi Arabia to lay out its tenth national development plan. Assistance is being provided to formulate indicators and scenarios that connect national goals and sectoral objectives to enable effective follow-up. The Ministry will be provided with a CGE model for formulating development policies and a dashboard tool to monitor progress.

combination with quantitative modelling. In the Arab region, computable general equilibrium (CGE) modelling is being used by Saudi Arabia for its national development strategy. CGE modelling and bottom-up simulation models have been used in the United Arab Emirates to support its Green Growth Plan. A dynamic CGE model has also been used in Egypt, Morocco, Tunisia and Yemen (box 5.11).

The extensive work done at the country level provides examples of evidenced-based analytical approaches. They include national assessment reports prepared in the lead-up to Rio+20 in 2011-2012, voluntary presentations under the Annual Ministerial Review mechanism of the United Nations Economic and Social Council, national MDG progress reports, environmental performance reviews, investment policy reviews, trade policy reviews, trade sustainability impact assessments, national reports on multilateral environment agreements, capacity needs assessments, technology needs assessments,

development policy reviews and World Bank MAMS reports, national human development reports, United Nations development action frameworks and common country assessments, Intergovernmental Panel on Climate Change national communications, country strategy papers (for example, of multilateral development banks) and Human Rights Council universal periodic reviews. Annex IV provides an inventory of major global and Arab regional assessments, publications and databases relating to each of the 17 SDGs.

It is important to monitor implementation progress and consider modifications in plans along the way.<sup>36</sup> Monitoring and reporting has improved significantly in the region in the context of the MDGs. Most Arab countries have produced regular national MDG progress reports and some, including Iraq, Morocco, Saudi Arabia and Tunisia, also prepare occasional sustainable development reports. However, national statistical capacity remains heavily reliant on international organizations. That said, some countries have

# Box 5.12. Monitoring and reporting

#### **United Arab Emirates**

The United Arab Emirates National Agenda and the United Arab Emirates Vision 2021 include a set of clear, quantitative targets and indicators across six goals: the competitive knowledge economy; sustainable environment and infrastructure; public safety and a fair judiciary; cohesive society and preserved identity; world-class health care; and first-rate education. The agenda provides a concise visual framework for monitoring progress and accountability.

#### Tunisia

The National Observatory for Environment and Sustainable Development is in charge of environmental statistics and sustainable development monitoring. The country's first indicator report was published in 2003 with 36 indicators. The 2014 report includes 46 indicators organized into 9 sustainable development challenges.

#### Iraq

Since 2010, the Iraqi Central Statistics Organization has published annual environment and sustainable development indicator reports. The 2013 version comprises 69 environmental indicators.

#### Morocco

In Morocco's fourth sustainable development indicators report, issued in 2014, 56 indicators across 14 themes cover economic, social and environmental issues. For each indicator, the report highlights trends and progress in past decades and provides analysis of key actions needed.

done commendable jobs on monitoring their national plans (box 5.12).

The Abu Dhabi Global Environmental Data Initiative is a world-class project to improve environmental monitoring data using remote sensing techniques, mobile phone records and other modern technologies. Another example of modern technology use is Geographic Information Systems, which has been integral in the development of spatial master plans in countries such as Algeria and Bahrain.

# 2. Regional institutions for sustainable development

Progress on sustainable development goals is reviewed above all at the country level. At

the regional level, the focus is on identifying regional trends, obstacles, commonalities, best practices and lessons learned.

Institutions in the Arab region that may participate in the review process include: the League of Arab States; ESCWA, the Economic Commission for Africa (ECA), the UNDP Regional Bureau for Arab States, the UNEP Regional Office for West Asia and other United Nations agencies coordinated by the Regional Coordination Mechanism. NGOs can also make an important contribution (box 5.13). Subregional institutions that fall wholly or partially within the Arab region, such as the Gulf Cooperation Council, African Union, and Union for the Mediterranean promote regional integration for development (box 5.14).

# Box 5.13. Development and environment NGOs

- Arab NGO Network for Development (ANND): a regional network of NGOs working in 10 Arab countries and with 23 members advocating for social and economic rights in the Arab region. It works in three main areas: (a) development policies; (b) social and economic reform agendas and the role of international and regional organizations; and (c) economic and trade liberalization and its social and economic implications.
- Centre for Environment and Development in the Arab Region and Europe (CEDARE): an
  intergovernmental organization established in 1992 to advocate for sound governance in the interests
  of the environment, by building human resources and institutional capacity, advancing applied
  research and environmentally friendly technologies, and acting as a catalyst for joint action between
  the Arab region, Europe and the international community.
- Arab Forum on Environment and Development (AFED): a regional NGO that prepares independent
  periodic reports on the state of the environment in Arab countries, with several major reports issued
  to date, most recently on energy, food security and sustainable consumption.
- Arab Network for Environment and Development: network of NGOs focusing on the integration of
  environment and development. It opened the door to NGOs to attend the Council of Arab Ministers
  Responsible for the Environment meetings after obtaining observer status in the League of Arab
  States in 1995.

# **Box 5.14.** Subregional organizations

- The Gulf Cooperation Council (GCC) was established in 1982 and is considered the most successful
  example of integration in the Arab region. Its six member countries (Bahrain, Kuwait, Oman, Qatar,
  Saudi Arabia and the United Arab Emirates) have focused on harmonization of regulations in
  economic and trade affairs (GCC Customs Union and Common Market), joint projects in education,
  science and technology, and cooperation in security and other political affairs.
- The Arab Maghreb Union (AMU) was founded in 1989 by Algeria, Libya, Mauritania, Morocco and Tunisia, with the aim of promoting the movement of goods, unifying customs systems and gradually liberalizing the movement of goods, services and factors of production. However, its efforts have been hampered by political problems.
- The African Union includes several North African Arab countries. It works on sustainable development through the African Union Commission, the New Partnership for Africa's Development (NEPAD), and the African Monitoring of the Environment for Sustainable Development (AMESD).
- The Mediterranean Strategy for Sustainable Development (MSSD) provides a regional response to the sustainable development agenda and SDGs for Mediterranean countries.

In addition to these institutions, a multitude of regional and subregional partnerships, funds, networks and organizations work on aspects of sustainable development. Some have been listed in chapter 6.

#### (a) The League of Arab States

The League of Arab States was established as a regional intergovernmental organization in 1945 and is the only such institution

#### Box 5.15. The Bahrain Document

The Bahrain Document contains recommendations on implementing the SDGs in accordance with the priorities of the Arab region. It was submitted by ESCWA as the regional input to the third session of the High-level Political Forum on Sustainable Development in New York in July 2015. Occupation, lack of peace and security, poverty, extremism, terrorism and refugee flows were identified in the document as key stumbling blocks in the region. It reaffirmed the intent of the Arab States to end the Israeli occupation of all Arab lands, working with the international community to achieve peace, security and inclusive sustainable development. It stressed the need for the international community to shoulder its share of responsibility and help refugee host States to maintain their development gains and care for refugees. It called for the development of effective institutions, the mobilization of resources and improved statistical capacities. The need to manage natural resources efficiently and adopt measures to reduce risks caused by natural hazards was also underlined

comprising all 22 Arab countries. Its aim is to "draw closer the relations between member States and coordinate their political activities with the aim of realizing a close collaboration between them, to safeguard their independence and sovereignty, and to consider in a general way the affairs and interests of the Arab countries."

The League holds summits for Heads of State once a year. The League Council is its main executive body and is composed of representatives (usually foreign ministers) of all member States. There are 13 specialized ministerial councils and a General Secretariat, which conducts administrative and executive work. A permanent Arab Parliament has recently been developed, with members drawn from the parliaments of member States.

Despite technical, political and financial constraints, the League has notched up important accomplishments, including several related to sustainable development. In 2002, the Council of Arab Ministers Responsible for the Environment adopted the Sustainable Development Initiative in the Arab Region. It was recently updated

to incorporate the results of the 2012
United Nations Conference on Sustainable
Development (Rio+20), with a new Arab
Strategic Framework for Sustainable
Development (2015-2025). Sessions of the
Arab Economic and Social Development
Summit have been held every two years
since 2009 and have led to the establishment
of a \$2 billion fund to finance small and
medium enterprises and the adoption of an
Arab Strategy for the Development
of Renewable Energy Applications (20102030).

#### (b) The United Nations in the Arab region

The work of United Nations bodies in the Arab region is coordinated by the Regional Coordination Mechanism (RCM). RCMs were established in line with resolution 1998/46 of the Economic and Social Council of 31 July 1998, and the United Nations regional commissions act as their secretariats. The first meeting of the RCM in the Arab Region was convened by ESCWA in 1999. Since then, meetings have been held once or twice a year. The participation of the League of Arab States in its meetings since 2006 effectively extended the mandate of the RCM to all 22


Arab States.<sup>38</sup> Six thematic working groups were set up, focussing on the MDGs (and, subsequently, the transition to the SDGs), food security, climate change, statistics, the Annual Ministerial Review, and migration.

Representatives of the United Nations
Country Office in Lebanon may attend RCM
meetings as observers. Meetings are also
open the Economic Commission for Africa
and multilateral institutions like the World
Bank and the International Monetary Fund.
The Islamic Development Bank and other
regional financial institutions are also
invited.

ESCWA has worked hard with regional partners to coordinate a united position on the SDGs and implement the conclusions of Rio+20, including the development of a "green economy road map".

#### (c) Arab Forum on Sustainable Development

The recently established Arab Forum on Sustainable Development, which has held two sessions (in 2014 and 2015), is designed to create a regional link between the global High-level Political Forum on Sustainable Development and implementation at the national level. As well as coordinating with international and regional bodies, it will engage with ministries and a broad range of non-State actors, including civil society. Its multi-stakeholder engagement distinguishes it from other formal regional institutions, which are primarily intergovernmental. At its May 2015 session, the Forum debated the status and financing of sustainable development in the Arab region, implementation challenges and institutional frameworks. It culminated in the release of the Bahrain Document (box 5.15).39





# 6. Means of Implementation and Partnerships for Sustainable Development



Achieving sustainable development will require the mobilization of significant financial resources, science and technology in order to spur economic growth and employment. States will have to hone their capacity to adapt new scientific findings and technology, just as the international community will have to facilitate knowledge transfer. Intraregional and international trade will be a key to reaping the benefits of comparative advantages and economies of scale. Statistical capacity is crucial to enabling policymakers to make full use of data and monitoring to formulate evidence-based policies.

The Arab countries will need to bridge a large financing gap through tax and subsidy reforms and by rationalizing military expenditure. International flows, including official development assistance (ODA), foreign direct investment (FDI), intraregional investment and remittances, constitute a sizeable source of finance for several Arab countries. However,

the general downwards trend over the past several years raises questions about the extent to which they can continue to rely on such flows. Green finance offers opportunities that only few Arab countries have fully tapped. Trade can be an engine of development, but the region's share of global non-oil exports remains modest and the region is the least economically integrated in the world.

In spite of efforts to develop science, technology and innovation in the Arab region, it remains mostly a user of technology. The little knowledge generated does not benefit industry because the region's economies are weak and undiversified. Statistical capacity is limited and many Arab countries were unable to report fully on the 45 MDG indicators using official national data.

The 2015 Addis Ababa Action Agenda encapsulates the need for a new framework for mobilizing the resources required to achieve the 2030 Agenda.¹ It complements the means of implementation targets included under SDG 17 and identifies seven action areas: domestic public resources; domestic and international private business and finance; international development cooperation; international trade as an engine for development; debt and debt sustainability; systemic issues; and science, technology, innovation and capacity-building. The Agenda also contains recommendations on three specific initiatives: a technology facilitation mechanism (discussed later in this chapter); a global infrastructure forum; and a follow-up and review mechanism.

This chapter is largely based on background papers and issues briefs prepared for this report on the subjects of technology, financing, statistical capacity and trade.<sup>2</sup>

# A. Financing sustainable development

The full range of national and international public and private sources of finance must be mobilized in a coordinated and optimal fashion and the financing itself – not just what is being financed – needs to be sustainable.

## 1. Financing needs and financing gaps

The funding requirements of sustainable development and resource gaps can be estimated in various ways and depend on the particulars of each case. ESCWA estimates that \$3.6 trillion will be required for selected Arab countries to achieve sustained economic growth between 2015 and 2030.³ Resources will also be needed to repair past and ongoing environmental and conflict-related damage. The cost of environmental degradation in the region has been estimated at 5 per cent of GDP,4 and that of conflict at more than 2 per cent of foregone GDP in each year of internal conflict.5

Shorter-term investment estimates prepared by the McKinsey Global Institute<sup>6</sup> and the

International Energy Agency (IEA)<sup>7</sup> accord special priority respectively to infrastructure and energy (with a focus on energy efficiency and renewable energy). According to McKinsey, the Arab countries need to spend between \$110 billion and \$150 billion a year in the coming five years on investments in nonenergy infrastructure. In the energy sector, the IEA estimates that \$105 billion will be needed in the Middle East during 2014-2020.<sup>8</sup>

In preparation for this report, two scenarios were developed in an ESCWA commissioned document9 to estimate the financing gap in the Arab region for the period 2015-2016. Scenario I depends on the latest forecasts provided by the World Economic Outlook Database and published by the International Monetary Fund in October 2014. It includes forecasts for the current account balance and GDP for most Arab countries, including LDCs. Scenario II is based on the Economist Intelligence Unit forecasts as of December 2014 and January 2015, more accurately reflecting the impact of falling oil prices. Table 6.1 shows the estimated financing gap for the Arab countries in 2015 and 2016 for both scenarios.<sup>10</sup>

Between 13 and 15 Arab countries are expected to have a financing deficit for 2015 and 2016 and the total financing gap is estimated to range between \$80 billion and \$85 billion annually. The second scenario, based on more recent oil price projections, results in a lower financing gap given that it is experienced mainly by net oil importers that stand to benefit from a drop in oil prices. In contrast, the total surplus in scenario I exceeds \$250 billion, and drops sharply to around \$100 billion in scenario II.

That upper middle-income countries should have a higher financing gap than their lower middle-income counterparts or LDCs (figure 6.1) can be explained by the fact that higher development requirements are not necessarily a spending priority in



LDCs, where the pursuit of less ambitious development objectives is likely to continue. This is an important limitation of the analysis, which also does not reflect the financing needs associated with post-conflict reconstruction. The determination of the

additional anticipated growth in needed finance - above the current forecasts - should be done on a country-specific, non-arbitrary basis, depending on prioritized sustainable development goals to arrive at a more accurate estimate. Another limitation is the

unavailability of forecast data on Somalia and Palestine. Accounting for those factors would yield a still higher financing gap estimate for Arab countries. However, other factors could lower the estimate. Synergies between sectors could lead to more efficient use of resources in the achievement of more than one sustainable

development goal. The estimates provided here are thus purely indicative.

# 2. Sources of finance for sustainable development

All possible sources of finance will need to

be mobilized. Major public sources include taxes and tariffs, public debt and ODA. Private sources include foreign direct investment and remittances.

#### (a) Public sources of finance





Figure 6.2. Tax effort, 2013

Domestic revenue collection can be raised significantly by improving tax systems, fighting tax evasion, reforming subsidies, correcting inequalities and combating corruption. The IMF estimates that many Arab countries present low "tax effort", 11 signifying the need for tax reform (figure 6.2). The estimate is based on a comparison between the country's tax revenues with a peer average (countries with similar per capita income) and the maximum tax receipts that other countries with similar characteristics have achieved (called the tax capacity). 12 The difference between the collected tax revenues and the tax capacity points to technical inefficiencies in tax collection and administration and deliberate policy decisions, such as allowing for tax exemptions.13 Noticeable differences between countries can be observed. Some lower middle-income Arab.

countries, including Morocco and Tunisia, have worked to increase their tax effort and perform better than the world average for middle-income countries. High-income Arab countries have done much less compared to the world average.

Inefficient tax collection and administration sometimes indicates significant illicit cash flows and a large informal sector. A recent study found that firms in Tunisia connected with the old regime evaded at least \$1.2 billion in import duty between 2002 and 2009.<sup>14</sup> Moreover, about one third of the region's GDP is undeclared.<sup>15</sup>

Fuel subsidies and military expenditure represent a serious drain on State budgets in the region and a high opportunity cost in the form of lost returns from spending on sustainable development.

To assess the opportunity cost of fossil fuel subsidies, figure 6.3 compares expenditure on them with public capital spending, and expenditure on education and health as a

percentage of GDP. Spending on fuel subsidies in most GCC countries, Algeria, Iraq and Jordan exceeds or almost matches capital spending, indicative of allocation inefficiencies and disincentives to switch to cleaner energy. In Bahrain, Lebanon, Yemen and, especially, Egypt, subsidies dwarf other key budgetary allocations. In net oil/gas importing countries, they represent a drain on budgets and foreign exchange reserves and pose a threat to debt repayment sustainability. In Egypt, the \$20.3 billion energy subsidies were greater than the \$19.2 billion fiscal deficit in 2010. In 2013, the Government initiated a series of energy price increases. Conversely, Djibouti, Mauritania, Morocco, the Sudan and, to a certain extent, Tunisia were able to reduce their subsidies significantly when compared to capital spending and social sector allocations.

A growing number of Governments (particularly in GCC countries) is looking at replacing across-the-board subsidies that strain budgets, distort market signals and benefit mainly middle to higher income brackets with targeted subsidies.

Morocco, for instance has one of the lowest energy subsidies relative to GDP (2.3 per cent of GDP for fuel products) in the region and is embarking on a green growth path.

Military expenditure in the Arab region amounted to 6.84 per cent of GDP in 2014 (figure 6.4). This is higher than the military expenditure in all other world regions and around three times the global average. While military expenditure appeared to have dropped sharply between 1991 and 2009, the more recent trend is upwards. This directs much needed resources away from socioeconomic development, environmental protection and reversing environmental degradation.




Figure 6.5. Public debt-to-GDP ratio (percentage)

Public debt is a prime source for funding budget deficits. Average public debt to GDP in the Arab region (excluding the LDCs, Iraq and Palestine) was 31.2 per cent in 2014, <sup>16</sup> compared with the 26.4 per cent world average for developing countries. Public debt to GDP is increasing in most Arab countries (figure 6.5) and is unsustainable in several cases.

Figure 6.4. Military expenditure (percentage of GDP)

Support from other Governments and international organizations is another major source of development financing. However, the target of 0.7 per cent of donor countries' gross national income (GNI) in ODA for developing countries, including 0.15 to 0.20 per cent for LDCs,

has not been achieved. Global interdependence is a strong argument for international cooperation on sustainable development, including its funding and policy coordination. In reality, ODA patterns reflect a combination of interdependence, need and political interests.

Figure 6.6. ODA received, 2013





Figure 6.7. Net ODA received per capita, selected Arab countries, 2013 (United States dollars)





In 2013, the Arab region received \$22 billion in ODA (figure 6.6), of which \$5.5 billion went to Egypt, the most received by any country in the world. On a per capita basis, the region received \$60 in the same year, more than any other region of the world and around three

times the global average. Palestine received \$626 per person, the seventh highest figure in the world (figure 6.7). However, recurrent military offensives and destruction of infrastructure mean that the aid has not resulted in development. Moreover, it is estimated that

the majority of international aid intended to support Palestinians, effectively benefits the Israeli economy.<sup>17</sup> Elsewhere in the region, conflicts are also undermining the efficacy of donor support and diverting resources from development to humanitarian causes.

ODA to countries in the Arab region in 2013 was showing an upwards trend (figure 6.8), having fallen from a peak in 2005 (channelled mainly to Iraq).

Some Arab countries, in particular Kuwait, Saudi Arabia and the United Arab Emirates, are donors (figure 6.9). Their donations exceeded 0.7 per cent of GNI between 1975 and 2010. Aid, a sizeable portion of it to other Arab countries, has been routed through national and regional development funds (box 6.1).

Despite their significant role in financing development in the Arab region (especially infrastructure projects in energy and transport), the share of Arab development funds in total ODA going to Arab countries

# Box 6.1. Selected Arab and Islamic development funds

- Arab Gulf Programme for Development (AGFUND; http://agfund.org): a non-profit organization that supports sustainable human development efforts targeting the needlest groups, especially poor women and children, in developing countries. It cooperates with development organizations, NGOs and other institutions, and channels financial assistance through 17 United Nations specialized agencies.
- Arab Fund for Economic and Social Development (www.arabfund.org): focuses on funding public
  and private investment projects and providing grants and expertise. Based in Kuwait, the fund also
  promotes closer cooperation between Arab countries by funding regional projects.
- Organization of Petroleum Exporting Countries (OPEC) Fund for International Development (www. ofid.org): fosters social and economic development, particularly in poor countries, and advances South-South cooperation by providing concessional loans for investment projects, programmes, and balance of payments and budget support.
- Islamic Development Bank (www.isdb.org): participates in equity capital and grant loans for productive projects and enterprises, and provides financial assistance to member countries and Muslim communities worldwide.
- Kuwait Fund for Arab Economic Development (www.kuwait-fund.org): supports economic development in Arab and other developing countries through loans, guarantees and technical assistance, and contributes to regional and international institutions.

has been highly volatile, often as a result of political considerations and oil price swings.<sup>19</sup> Overall, there has been a downward trend since the 1970s, with noteworthy spikes in 1990 and 2008.<sup>20</sup>

#### (b) Private sources of finance

Private means of finance include FDI, remittances, portfolio investments and domestic savings. Portfolio investment accounts for less than 1 per cent of GDP in the Arab region and will not be discussed in detail.

Domestic savings and other aspects of the financial system are discussed elsewhere in this report.

FDI inflows can be particularly beneficial when accompanied by new technologies and production techniques. In the Arab region, however, most FDI has been in low technology sectors that generate few new jobs: oil, real estate and construction.<sup>21</sup>

In 2013, the United Arab Emirates and Saudi Arabia received the highest FDI in absolute



terms, which tallies with their high ranking in terms of ease of doing business. Djibouti and Mauritania received high FDI relative to their GDP, despite ranking poorly in terms of their business environment (table 6.2).

According to the World Development Indicators, FDI as a percentage of GDP is relatively low in the Arab region – about 1.7 per cent of GDP, compared with 2.9 per cent worldwide. As a share of total inflows to developing economies, FDI levels in the


region rose from around 4 per cent (\$1.3 billion) in 1990 to a peak of 17 per cent (\$97 billion) in 2008, only to drop back to 6 per cent (\$44 billion) in 2014 - the sixth consecutive decline since 2008 (figure 6.10). Inward investment to the Arab region has declined substantially since 2008, initially triggered by the financial crisis of 2008 and subsequently due to increased political and social instability in the region. By contrast, FDI to other developing country regions reverted to an upward trend following the recessionary dip.

Intraregional direct investment grew from \$2.5 billion in 2001 to \$35 billion in 2008, but then dropped thereafter (figure 6.11). Arab intraregional investments remain meagre, not exceeding 11.2 per cent of total investments


by Arab sovereign funds outside the region, which are estimated at around \$1,600 billion.<sup>22</sup>

Tax and other incentives designed to attract FDI should be viewed with caution, as they

are sometimes used at the expense of generating public revenue. Their overall cost benefit should be analysed and a consistent policy on investment followed in order to foster a climate of stability. Rather than such incentives, emphasis should be

placed on long-term measures that do not involve forgoing revenue, such as fighting corruption, facilitating the establishment of businesses and creating a friendly regulatory and even-handed judicial environment.<sup>23</sup>

Net FDI, which nets out inflows from foreign investors against FDI by the country to the rest of the world, is negative for most Arab economies in 2013 (figure 6.12). Competitiveness in the region's countries thus needs to be improved urgently in order to curb the outflow of domestic capital.

Remittances play a key role in the Arab region, both as a source of private sector income and in terms of outflows. Egypt, the world's sixth largest recipient of remittances, received \$20 billion in 2014, while Lebanon, in tenth place, received \$8 billion (figure 6.13). The region as a whole is expected to bring in \$53 billion in 2015.<sup>24</sup> Remittances generally support private investment (such as education and housing) and consumption.

#### (c) Other financial flows




Figure 6.14. Private sector participation in infrastructure in developing countries, 1990-2013

Public-private partnerships (PPP) traditionally involve private-sector funding of government-sponsored projects, allowing for risk-sharing and the possibility of benefiting from the private sector's management skills, expertise, innovation and efficiency. Under a PPP

structure, efficiency gains can arise through competitive pressure on procurement, operation and maintenance costs when undertaken by private operators. PPP are relatively infrequent in Arab countries (figure 6.14), but it should be noted that data for the GCC countries were unavailable.

Data for developing Arab countries reveal a certain bias, in comparison with the world norm, towards use of PPP in certain less strategic and less regulated sectors that are more profitable for the private sector, thereby enabling the application of market or close-to-market rates, as in the case of energy, which is a rewarding industry from the perspective of the private investor (figures 6.15 and 6.16). Investment in transportation (box 6.2) and telecommunications also constituted a substantial share of the total during 1990-2013 (in terms of both the number and value of projects). By comparison, private-sector participation in the water and sewage sectors is limited.

In view of the growing impact of climate change on the region, Arab countries can and are already benefiting from multilateral

# Box 6.2. Queen Alia International Airport project: A regional first

The \$900 million project to overhaul Queen Alia International Airport in Jordan involved construction of a new terminal with capacity to handle 12 million passengers a year and operation of the airport. The challenges of being the first full airport concession in the Middle East and the first PPP finance deal compliant with sharia law, and foreign exchange risks, were considerable. They were surmounted by a well-prepared structure allowing for a project finance mechanism, asset security to all lenders through an inter-creditor agreement, and a pre-set formula for revenue adjustment in case of foreign exchange devaluation. The project achieved the highest revenue-sharing percentage among similar projects around the world, resulting in an increase in passenger traffic by 42 per cent in 2011 over 2007 and the creation of additional jobs. The project was awarded the PPP Gold Award for the Middle East and North Africa in 2013.

■ Water and sewage



climate-related funds, within and outside the United Nations Framework Convention on Climate Change (UNFCCC). Morocco and Egypt appear to have benefited the most in value terms and number of projects, while Jordan, Lebanon, Tunisia and Yemen have benefited from a relatively high number of smaller-scale projects (table 6.3).

Funds operating within the UNFCCC include several trust funds under the Global Environment Facility, which was established by the World Bank, the United Nations Development Programme (UNDP) and the United Nations Environment Programme (UNEP):

 The Global Environment Facility (GEF) Trust Fund (www.thegef.org) is the largest public

climate change fund. Arab countries have received financial support for 52 projects totalling \$217 million, or 23.8 per cent of the fund's climate change allocation since 1992. Egypt and Morocco are the largest beneficiaries, with \$79.7 million and \$58.5 million respectively.

- The Least Developed Countries Fund (www. thegef.org/gef/LDCF) supports climate change adaptation activities in developing countries that are party to the UNFCCC and facilitate technology transfer. Yemen has received \$15.2 million since 2002.
- The Special Climate Change Fund finances climate change mitigation and adaptation activities that are complementary to the GEF and other bilateral and multilateral funding. Five Arab countries (Egypt, Jordan, Lebanon, Morocco and Tunisia) have received a total of \$43.4 million from the fund since 2001.
- The Adaptation Fund (www.adaptationfund.org) was established in 2009 to support adaptation projects in developing countries that are vulnerable to climate change. Egypt and Lebanon have received

a total of \$14.8 million for agriculture and food security projects since 2009.

The World Bank operates two trust funds in collaboration with multilateral development banks:<sup>25</sup>

- The Clean Technology Fund (www-cif. climateinvestmentfunds.org/fund/ clean-technology-fund) promotes the demonstration, deployment and transfer of low-carbon technologies in middleincome countries. It focuses on large infrastructure in a small number of countries, aiming to reduce technology costs, stimulate private-sector participation and promote replication in other countries. Egypt has received a \$300 million grant and concessionary loans to establish a 250-megawatt build-own-operate wind energy project in the Gulf of Suez (\$140 million) and a transport modal shift for developing new bus and rail infrastructure (\$160 million). Morocco has received \$388 million in grants and concessionary loans to develop wind and solar energy, including the Noor Ouarzazate Concentrated Solar Power Plant Project.
- The Strategic Climate Fund (www. climateinvestmentfunds.org/cif/node/3) has provided \$40 million to Yemen to scale up renewable energy.

# B. Science and technology

The role of science, technology and innovation in spurring economic development and employment is widely acknowledged. It is reaffirmed in the SDGs: explicit reference is made to science, technology and innovation in 10 of the 169 SDG targets, including three targets under goal 17 on means of implementation.

The Arab countries have gone some way towards developing science, technology and innovation, by striving to improve their education systems and acquire foreign expertise and technologies. However, the impact on industry has been limited due to an unfavourable business environment and weak links between science and industry. The Arab countries continue to be users, rather than generators, of technology. Technologies need to be deployed to foster more diversified economies. Unless a 'demand-pull' for technology is created through a vibrant economy, 'supply-push' will only lead to unemployment and brain drain. Instability in the region is an added impediment to achieving this supply-demand balance.

The following sections provide a brief analysis of the current situation. Note, however, that science, technology and innovation statistics for the region are hard to come by and may be outdated.

#### 1. National science and technology capacities




Figure 6.17. Mobile cellular subscriptions per 100 population

The use of modern technology has expanded quickly in the Arab region. The number of Internet users and mobile cellular subscriptions rose significantly between 2000 and 2014, by which time there were 109 mobile telephone subscriptions for every 100 persons in the region, well above the global average of 96. In GCC countries, there are 179 subscriptions per 100 persons (figure 6.17).

Internet use (34.4 per cent of the population) for the region is below the global average (40.7 per cent) in 2014. It was higher than world average in the GCC countries only (72.3 per cent). Some Arab countries lag behind significantly: Somalia (1.6 per cent); Comoros (7 per cent); Mauritania and Djibouti (10.7 per cent).26 Online government services are well developed in the Gulf countries, which score relatively well on the e-Government Development Index (GCC average of 0.65, compared with the global average of 0.49).<sup>27</sup> Morocco, Saudi Arabia and the United Arab Emirates, whose Governments strongly support the generation of Arabic digital content, account for 58 per cent of all web pages in Arabic. Egypt,

Oman, Qatar and others are striving to digitize Arabic and Islamic cultural heritage.

In other areas, technological progress in the Arab region has been disappointing. What little

manufacturing the region has tends to be low-technology.<sup>28</sup> Information and communications technology contributes a meagre percentage to exports from Arab countries, with Tunisia being the sole exception at 7 per cent of total




Figure 6.20. Scientific and technical journal articles published per million inhabitants, 2011

exports. The share of business to consumer e-commerce in the region in 2013, estimated at 2.3 per cent of total trade, was very modest compared with the Asia-Pacific, European and North American regions.<sup>29</sup>

The capacity of the region to participate

in modern science and technology will depend on human capacity and government incentives. Education systems in the region often fail to provide the basic skills needed for science and technology, and Governments and business pay scant attention to research and development.

At only 0.2 per cent, average gross domestic expenditure on research and development in the region was one fifth of average spending by developing countries and 12 per cent of the global average (figure 6.18). Research and

development spending tends to be dominated by the public sector in the Arab region.

Similarly, the average of 373 full-time researchers per million inhabitants in the

Arab region is below the global average for developing countries (580) and one third of the world average (1,081) (figure 6.19).<sup>30</sup>

Research and development output lags similarly. Around 7,800 scientific and technical journal articles were published in 2011 in the Arab region, amounting to 1.3 per cent of the world's total. On average, 22 articles were published per million inhabitants, compared with a global rate of 117 (figure 6.20). Similarly, 5,765 patent applications were filed in 2013 in 13 Arab countries, representing a mere 0.2 per cent of world applications (figure 6.21).<sup>31</sup>

The Arab region is handicapped by the inadequacy of links between universities, industry and the labour market. According to the World Economic Forum's Executive Opinion Survey for 2013/2014, Arab countries scored between 2.1 and 5.5 on a scale of 1 to 7 with respect to the level of university/industry research collaboration (figure 6.22). For most Arab countries, the score is below the global mean of 3.75.

# 2. Global and regional partnerships in technology

Progress on the transfer of environmentally sound technology has fallen short of the commitments made by the global community in the wake of the 1992
Rio Declaration on Environment and
Development. To address this shortfall, the
2015 Addis Ababa Action Agenda provides
for the establishment of a "technology
facilitation mechanism". Moreover, the
SDGs include targets regarding the said
mechanism and the creation of a technology
bank for LDCs in order to enhance science,
technology and innovation cooperation
(box 6.3).

Regional cooperation in the field of technology can help countries to tackle common challenges (especially those related to environmental degradation and natural resource scarcity) with fewer resources. However, the lack of regional cooperation between researchers is a serious handicap. Egypt, Jordan and Saudi Arabia maintain research partnerships between themselves and with countries outside the region, but other Arab countries appear to have done little to develop significant research partnerships.32 The Arab Scientific Community Organization lists 126 scientific societies in various disciplines, of which only eight are regional. Efforts to mobilize renowned Arab researchers in the diaspora are multiplying and could be promising in the long term. One example is the Zewail City of Science and Technology in Egypt, inaugurated in 2011.33

# **Box 6.3.** Global technology facilitation mechanism and a technology bank for LDCs

General Assembly resolution 66/288 of 27 July 2012, on "The future we want", calls for the creation of a "facilitation mechanism that promotes the development, transfer and dissemination of clean and environmentally sound technologies". It was concluded at the Third International Conference on Financing for Development, held in July 2015 in Addis Ababa, that such a mechanism would require a United Nations inter-agency task team on science, technology and innovation for the SDGs to enhance coordination of capacity-building initiatives, a multi-stakeholder forum on the subject and an online platform with information on available initiatives and programmes. Moreover, the Secretary-General of the United Nations appointed a high-level panel (see http://unohrlls.org/technologybank) in November 2014 to study the feasibility of a technology bank for LDCs and define its functions.




Figure 6.23. Arab region's share in global exports (percentage)

# C. Trade

The Arab region's share of world exports remains modest but doubled between 1995 and 2013 to reach 7.3 per cent (figure 6.23). That increase applies equally to fuel and other exports: the region's share of non-fuel exports increased from 1 per cent to 2 per cent between 1995 and 2013. Moreover, several Arab States have acceded to the WorldTrade Organization over the past two decades, while others have observer status and are negotiating accession.<sup>34</sup>

Several intraregional trade agreements operate. In 1957, members of the League of Arab States signed the Economic Unity Agreement. Commitment to Arab economic integration was renewed in 1980 and 1981 through the Charter for National Economic Action, the Strategy for Joint Arab Economic Action, and the Inter-Arab Trade Facilitation and Development Agreement. Other trade agreements include the Greater Arab

Free Trade Area (GAFTA, 2005), the Gulf Cooperation Council Common Market (2008), and the Agadir Agreement (2004). The Arab Maghreb Union was established in 1989. Nevertheless, the Arab region remains one of the least economically integrated in the world, due in large part to the limited range of Arab country exports and weak and similar economic structures in most Arab countries (figure 6.24). Intraregional exports did not exceed 9 per cent of total exports in the region in 2012. Levels of intraregional trade in the Arab Maghreb Union and Gulf Cooperation Council are even lower in comparison with intraregional exports in the European Union (62 per cent of total exports) and the North American Free Trade Agreement zone (49 per cent).


Non-Arab developing countries represent the fastest growing market for Arab exporters (figure 6.25). Since 1995, Arab exports to other developing countries have grown by a factor of 15, followed by exports to developed countries (factor of about 6), and exports to other countries in the Arab region, which grew by a factor of just 5. Indeed, many Arab countries

have been quicker to conclude preferential arrangements with non-Arab parties than with each other, engaging in the deep economic commitments imposed by those arrangements and accepting commercial provisions that often surpass WTO requirements. As of January 2015, Arab States were parties to some 750 separate investment bilateral and

international agreements.35

Recognizing that tariff reduction and elimination alone was ineffective in boosting intraregional trade, the League of Arab States announced in 2009 that a pan-Arab customs union and common market would be launched in 2015 and 2020 respectively. The long-term

goal is to build new trade and investment partnerships in the Arab region by eliminating all forms of trade restrictions and quotas, and restrictions on residence, employment, and transportation between Arab countries.

Negotiations on the customs union have been postponed until further notice. It would be a natural second step after GAFTA, but first the impact of such a union on Arab economies, taking into account the specific characteristics and trade ties of each Arab economy, needs to be closely examined. ESCWA is preparing several reports on the challenges and opportunities associated with the union.

The failure to integrate trade and other economic policies, especially on investment, in the region has hampered the full development of trade. Institutions are failing to address intellectual property rights, standards and environmental regulations. The lack of regional coordination and inadequacy of human capacities have prevented the Arab States from presenting a strong and sound collective position in WTO negotiations. Arab countries have not benefited enough from aid for trade.

Capacity-building for parliamentarians, academics and the media in trade issues is needed, and a regional meeting should be held annually to develop a common approach to WTO trade talks.

# D. Data and monitoring

High quality national statistics and flexibility in policymaking are critical for policy planning. Sound indicators will be a key to implementing the SDGs, measuring progress and ensuring accountability.

Statistical capacity in Arab countries remains weak, as illustrated by their inability to compile many of the MDG indicators. A review of the data contained in the global MDG database for six Arab countries reveals that they could only compile 42 per cent of the 45 MDG indicators that could be expected to be compiled by national Governments using their own official statistics. Of the remaining 58 per cent, statistics could be compiled from international agencies for some countries (24 per cent) or not at all (34 per cent). None of the selected countries produces official statistics for more than 27 of the MDG indicators. Many of the time series contain data points for only a few years between 1990 and 2014, limiting capacity to assess trends in the indicator. Based on these findings, it is possible to conclude that the evidence base and national capacity for monitoring the MDGs in the Arab region was modest at best.36 That in turn points to one of

# Box 6.4. Tunisia tackles statistical capacity issues in its MDGs report

Tunisia's 2013 MDGs report noted that the country's statistics system needed to provide more relevant and disaggregated data. The Tunisian National Statistics Council had already set up a working group on statistics reform with a view to improving reporting on MDGs as part of its National Statistics Programme for 2007-2011. The programme recommended that Tunisia adopt international definitions and methods and that statistics be compiled on specific MDGs, such as those related to sanitation.




Figure 6.26. Data gap analysis for 44 League of Arab States sustainable development indicators




Figure 6.27. Level of statistical capacity, 2015

the main challenges for improving the use of evidence in policymaking.

All countries in the region (except the Comoros and Libya) produced national MDG progress reports at least twice. They generally say

little about statistics for monitoring and evaluation and the degree to which difficulties are discussed varies greatly. Some reports make no mention at all of such difficulties, while many confine themselves to general




Figure 6.28. BTI: Extent to which Government is innovative and flexible in policymaking

statements of the need to improve statistics. Tunisia constitutes a noteworthy exception (box 6.4).

Data availability in the Arab region for 44 sustainable development indicators developed by the League of Arab States was assessed for the period from 1990 to 2015.<sup>37</sup> The review included United Nations and World Bank databases in order to provide a broad overview of data availability, which was assessed for the Arab region and four subregions, and across all indicators.

The gap analysis (figure 6.26) shows that, for the Arab region as a whole, 83 per cent of indicators have sufficient data to enable the calculation of a basic trend (at least 2 data points). Of the remaining 17 per cent, data was either insufficient (6 per cent) or non-existent (11 per cent). Gaps are evident in all subregions. In the LDCs, 26 per cent of indicators had no data or a single data point. Data availability was highest in the Maghreb and Mashreq, with Egypt, Jordan, Morocco, Oman and Tunisia showing the highest levels

(80 per cent or above).

International indices of the statistical capacity of Arab States and their policy innovation and flexibility show mixed results. Statistical capacity in the Arab countries, as reflected by the Statistical Capacity Indicator in 2015, varies between 20 in Somalia and 91 in Egypt (figure 6.27).<sup>38</sup>

The Arab countries' track record on policy innovation and flexibility, based on the Bertelsmann Stiftung's Transformation Index (BTI), is relatively poor (below 5 for all Arab countries), with a noticeable decline in some countries between 2006 and 2014 (figure 6.28). Innovation in policymaking often comes through learning from past experiences (effective monitoring and evaluation), observation and knowledge exchange (good practices, international cooperation) or consultancy (academic experts and practitioners). Flexibility refers to a Government's ability to adapt to and take advantage of developmental opportunities inherent in a given political

situation. Assessments of several Arab countries find that States are "not particularly flexible or innovative, a fact that results more from an unwillingness to learn than from incapacity".39


Arab social development experts have identified several concerns about the region's monitoring experiences. One is that processes for compiling and reporting sustainable development indicators in Arab countries are not fully integrated into national and regional institutional structures. For example, each time a new indicator report is compiled, project teams must be created anew in both the agency responsible for the report and those that provide data. This limits opportunities for "learning-by-doing" and increases the burden of reporting. Access to data is another problem. Some data are simply unavailable, while in other cases data that are collected are not made available. Government agencies may, for a variety of reasons - including simple reluctance to share information – withhold information from citizens and even from other government agencies. Obliging users to pay for data

is another impediment to access and may reflect a veiled desire to keep data secret. Strengthening laws governing access to information could help to resolve such problems.

In order to enhance data capacity and collection in the Arab region, the role of national statistical offices should be strengthened, and transparency of information enhanced to the fullest extent possible. A smaller set of the most relevant, or "headline", sustainable development indicators for the Arab region should be agreed upon and maintained over the years to allow for the identification of trends. In order to improve environmental data, a system of environmental-economic accounts<sup>40</sup> should be promoted in the Arab region. Following the Mediterranean example,<sup>41</sup> a regional partnership in the form of an observatory on sustainable development data, bringing together government and non-government stakeholders, could be established to fill knowledge gaps.







### 7. Achieving the 2030 Agenda for Sustainable Development in the Arab Region

The Arab region today is marked by conflict and instability. Amid the turmoil, it is difficult to focus on the long-term planning and investment required for sustainable development. Nevertheless, it would be a grave mistake to think that meeting pressing needs and planning for sustainable development are mutually exclusive. On the contrary, sustainable development strategies will be successful only if they address the root causes and effects of the instability, including its at times irreversible impact on cultural heritage and ecosystems, or the consequences of long-term displacement. The 2030 Agenda for Sustainable Development provides an opportunity to envisage a future for the region that is free from poverty and based on human rights, equality and sustainability, to embark on the road of sustainable development and peace, dignity and well-being for all.

Governments will need to provide equal access to the basic necessities of life and opportunities for all to contribute to, and benefit from, economic development.

Particular efforts must be devoted to tackling poverty and unemployment, reducing gender disparities and addressing inequalities within and between countries. Quality education that is relevant to the labour market is a high priority. Special consideration should be given to vulnerable groups, especially refugees and internally displaced persons, the number of whom increases by the day.

Achieving sustainable and resilient societies will require policies and investments designed for tomorrow as well as today, especially in terms of natural resources and in order to address inherent risks. The Arab countries face increasingly dangerous water, food and

energy issues that pose a threat to societies and development gains made to date. Consumption and production patterns need to be brought to sustainable levels. Cities and infrastructure must be made resilient to natural hazards and climate change. The opportunities opened up by technology for dealing with such issues have yet to be grasped in the Arab region.

Governments in the region need to acknowledge that peace, good governance and effective institutions are linked to one another, and that they are the prerequisites for, and guarantors of, sustainable development. The Arab countries need to work with the international community to enforce international humanitarian and human rights laws, and the right to self-determination. Good governance and effective institutions presuppose the unfettered participation by all in political life and the guarantee of safety from all forms of violence. That depends on the capacity of Governments to build consensus on a national vision and goals, engage stakeholders, and steer a process of major reforms while ensuring transparency and accountability. Sustainable development ultimately depends on the political will of those at the highest levels of the decision-making process.

Public and private investment will be needed to boost productive capacity while addressing environmental degradation. All the region's resources will need to be mustered. The capacity gap, including with regard to national statistics systems, needs to be resolved. Since bridging such gaps in means of implementation is beyond the capacities of any one Arab country, regional integration and a global partnership for sustainable development should be scaled up.

Achieving the SDGs will require urgent institutional action at the national, regional and global levels. Several crucial actions, common to all Arab countries, have been highlighted throughout the analysis and consultations for this report. The issues outlined in the following sections are general in nature and applicable to all Arab countries. Sectoral recommendations are beyond the scope of this report, but subsequent editions may look at specific subregions or thematic issues.

#### A. National action is at the core

In times of crisis, the State is the solution.
To achieve the ambitious goals of the 2030
Agenda, national Governments are in the
driver's seat. That said, the role of other
development partners cannot be discounted.
Parliamentarians, civil society, academia,
the private sector, media and others can
all contribute. Strong commitment and
unwavering political will are critical. Actions
need to be guided by the vital interest of
peoples. The following action areas are crucial
for achieving the 2030 Agenda:

Good governance: Governance deficits are a root cause for development failures worldwide. In the Arab region, they have proved to be existence-threatening. The impotence of Arab societies in the face of emerging challenges raises fundamental questions about governance in government, the private sector and civil society. Democratic, humanistic and moral governance models are essential in all sectors for coping with ongoing transformations. In Governments, they are especially needed in order to build trust in, and the legitimacy of, the State and its capacity to carry out the crucial tasks of shaping the future.

**Integrated planning:** Arab countries will need to translate the long-term SDGs

into medium and short-term plans and initiatives. National strategies and policies need to be re-aligned and institutional coordination mechanisms improved. Countries need to build decision-support tools to enable integrated analysis, monitoring, accountability and follow-up. A shift from traditional policy assessment tools to sustainable development assessment instruments and modelling tools is already taking place in some countries. The systematic use of those instruments and regional exchange of experience and good practice could multiply the benefits. Multi-stakeholder engagement in sustainable development planning and implementation can be strengthened to ensure ownership at the national level. Periodic follow-up and review will help to ensure that plans and desired outcomes are aligned.

#### Aligning finance with sustainable

development requirements: Financing needs for sustainable development are sizeable in the Arab countries. While domestic public finance remains the central resource, all sources, including foreign direct investment, remittances and publicprivate partnerships, need to be mobilized to bridge the financing gap. Official development assistance will remain a significant source of funding for some Arab countries, especially in a highly volatile and unpredictable political environment that limits economic opportunities and deters private investment. Global sources of financing, such as climate finance, need to be tapped more consistently.

#### Enhancing data capacity and collection:

Countries need to set their own baselines and SDG targets, and strengthen their national statistical systems and review frameworks. To be most useful, national baselines and targets should be in harmony with the global indicators. Data quality, timeliness, disaggregation, accessibility

and availability will require enhancement in many Arab countries to allow Governments to make informed decisions and improve transparency and accountability. International technical and financial support will be needed to develop statistical capacities, modernize and interconnect systems in the region.

#### Human resources capacity for effective

public institutions: Credible and effective institutions thrive on the talent and values of public employees and the quality of their attitude, knowledge and skills. Entry to the civil service, especially at decision-making levels, should be on the basis of merit. It should not be used as a means of alleviating unemployment or to buy alliances. Investment in skills, leadership and management capacity is crucial. Developing strong financial management capacity and oversight is critical for the successful reform of public finances, which is a prerequisite for all other reforms.

#### **Knowledge for sustainable development:**

Knowledge is a global good as well as an essential input in the modern economy. Quality education for all, improved research and development, and the ability to use scientific evidence in policymaking are central to moving towards a knowledge society. In order to bridge the knowledge-generation gap, and prevent it from broadening further, countries in the region will need to build on their own knowledge foundations and be open to global knowledge exchange opportunities.

#### **Communication for sustainable development:**

Preparing a generation of youth educated and trained in the values and culture of sustainability should be a priority. This would involve a serious revision of school curricula and pedagogy, as well as capacity development of the media. Civil society can play a major role in disseminating knowledge and best practices.

#### B. Regional and global action to implement the 2030 Agenda

The Arab countries have much in common in terms of language and culture. In many ways, they are in the same boat, facing similar challenges. In others, they are different, and those differences offer room for complementarity. Both differences and similarities present a strong rationale for knowledge exchange, joint action and regional integration in the pursuit of sustainable development. In an interconnected and globalized world, where risks and opportunities are supranational, the Arab region cannot thrive in isolation. To strengthen its internal and external ties, it needs to embrace diversity and engage in open dialogue with other civilizations.

It is in the interest of the Arab region to advance a more effective global partnership that will help bridge its technology, finance and capacity gaps. The Arab countries can benefit from international cooperation on trade, halting illicit financial flows (and retrieving stolen assets), trade facilitation, climate change mitigation and climate finance, capacity development and green technology transfer. The global partnership must be harnessed in favour of the rule of international law, and to end the illegal occupation of Palestinian and other Arab lands.

Issues requiring collective action and cooperation include: security (and its spillover manifestations, such as refugees and terrorism); economic migration; water, energy and climate change; biodiversity, trade; transport; labour; and technology and knowledge. While the global institutional framework for sustainable development has been taking shape over the past few years, the time has come to build an effective regional institutional framework for sustainable development that addresses past challenges and weaknesses experienced with the MDGs. The following action areas are important elements for such a framework:

## Regional follow-up and review mechanism for the 2030 Agenda: By boosting regional integration and promoting national action, a review mechanism can support implementation of the 2030 Agenda. Its legitimacy, coherence and accountability can be reinforced by:

- Developing an Arab 2030 Vision: A consolidated, long-term regional vision for sustainable development would allow the region to identify its own targets and means of implementation, and provide a basis for assessing progress, identifying lessons learned, highlighting common challenges and solutions, and promoting peer learning. The Arab Strategic Framework for Sustainable Development would need to be revisited in order to provide an umbrella for sectoral strategies in the region. The regional vision could also guide national strategies.
- Agreeing on a joint approach to measuring sustainable development: To allow for regular, long-term monitoring of progress, the sustainable development indicators developed for the Arab region need to be harmonized with those of the 2030 Agenda, thereby reducing the reporting burden and allowing for comparability.
- Institutionalizing the Arab Sustainable Development Report: The report should be seen as a tool for enhancing evidence-based policymaking, following the model of the Global Sustainable Development Report.
- Leveraging the Arab Forum on Sustainable Development: The forum is a central platform for regional consultations and voluntary reviews of progress, both horizontal and thematic, and at all levels. It supports regional preparations for the yearly sessions of the High-level Political Forum on Sustainable Development and mirrors

its themes in its structure.¹ Future sessions of the Arab Forum should maintain its multi-stakeholder character and continue to bring together high-level participants representing economic, social, environmental and human rights concerns.

Regional financial cooperation: Despite the current conflicts, regional economic and financial cooperation can play a major role in supporting sustainable development. To be relevant to the 2030 Agenda, Arab financial institutions will need to adopt sustainable investment policies and focus their support on the countries that are most in need. A regional assessment of financing needs for achieving the SDGs in the Arab region will facilitate the identification of options for addressing those needs through existing or new initiatives and partnerships. Complementary strategies and initiatives, including a regional financing strategy, could be considered. The establishment of a regional bank for reconstruction and development needs to be further researched.

Regional technology cooperation: The region needs to grasp global opportunities, including those offered through the technology facilitation mechanism and the planned technology bank for LDCs. Transition of the Arab region to a knowledge economy requires the renegotiation of existing cooperation modalities for technology transfer, including North-South and South-South partnerships, to reduce the region's dependence on global markets. This should be complemented by a commitment to regional horizontal solidarity for sciences, technology and innovation, as well as knowledge-sharing between Arab countries. A regional research mechanism providing a vision for Arab research institutions is also highly recommended.

#### Annex I. Preparatory Process

The Arab Sustainable Development Report is a joint publication of the United Nations Economic and Social Commission for Western Asia (ESCWA) and the United Nations Environment Programme (UNEP). Sister United Nations organizations and agencies, members of the Regional Coordination Mechanism for the Arab Region, and a range of regional and international experts and Governments have contributed. The names of the core team members and contributing authors are listed in the acknowledgements section.

The report has been informed by a wide range of documents as detailed below, including several expert reports on enablers and means of implementation for sustainable development, a suite of issues briefs on priority themes, national sustainable development assessment reports, statistical analyses (including on data gaps and trend analysis), and additional desk research. #### 1. Regional expert and statistical reports

Expert and statistical analysis reports were prepared by regional and international consultants (table A.1). Several were discussed at an expert meeting organized by ESCWA in December 2014 in Beirut.

#### 2. Issues briefs on priority thematic issues

A key component of the report is the review of progress and trends across priority thematic issues contained in the SDGs. United Nations bodies and specialized agencies were therefore invited to prepare 15 short issues briefs on selected themes (table A.2).

#### 3. National assessments

In addition to the top-down regional analysis, a bottom-up component was

contributed in the form of several national assessments, which were undertaken in three phases: (a) a stocktaking report; (b) a multistakeholder meeting; and (c) preparation of a synthesis report. The research was undertaken by expert consultants under the guidance of a government focal point and with the support of ESCWA. The assessments focused on: sustainable development priorities, institutions and strategies; key obstacles to implementation; innovative success stories and best practices; and lessons learned and recommendations for building capacity. Assessments were commissioned for Jordan, Lebanon, Morocco, Tunisia and Yemen.

#### 4. Regional consultations, expert meetings and review process

Internal and external consultations and expert workshops helped to shape the report. They included: scoping sessions and interdivisional coordination meetings with ESCWA focal points and experts; review of the concept note and draft report by the ESCWA Publications Committee; presentation and discussion of the approach at the Arab Consultative Meeting on an Accountability Framework for the Post-2015 Agenda (Tunisia, 15-16 September 2014); an expert group meeting to review draft issues briefs, expert reports and national assessments (Beirut, December 2014); and consultations in Arab countries as part of the national assessments.

A wide variety of stakeholders and experts from ESCWA and other United Nations

agencies, Arab Governments, non-governmental organizations, academics and other experts reviewed the methodology and content of the report. Their contribution was essential. A technical summary of the report was presented at a side event of the Arab Forum on Sustainable Development (Manama, 5-7 May 2015). The final version of the report was subjected to formal peer review by selected experts, as well as internal review by ESCWA and United Nations agencies through the Regional Coordination Mechanism and the ESCWA Publications Committee.

#### Annex II. Statistical Methodology

#### 1. Selection of indicators included in the snapshot

A set of sustainable development indicators was needed for the snapshot analysis (chapter 2). The Arab Sustainable Development Indicators (ASDIs) framework, adapted from global indicators established by the (now defunct) Commission for Sustainable Development and reworked under the Sustainable Development Initiative for the Arab Region by the League of Arab States, UNEP, ESCWA and the Abu Dhabi Global Environmental Data Initiative (AGEDI), is the most relevant set of indicators. It was agreed initially that implementation of the full set would be voluntary. Due to a lack of implementation, the set was subsequently reduced to a subset of 44 indicators that would be compulsory for all countries in the region. Although no country in the region regularly produces all of them, this short list was deemed an appropriate starting point.

The list was cross-checked against the 17 SDGs, a process that highlighted indicator insufficiencies in goals relating to issues such as gender, employment, peaceful societies, food security and climate change. Twelve more indicators were added to the short list in order to address those gaps. Terminology used in several indicators was adjusted slightly in order to account for differences in data sources. Some indicators were included under an SDG that is different from the theme under which they are categorized in the Arab list, where this was deemed to better suit the SDG framework.

#### 2. Data collection and trend analysis

Based on this framework, and while acknowledging the limitations of non-

nationally sourced statistics, data were then collected for the 22 Arab countries¹ from a range of official databases, mainly from the United Nations system (table A.3). Data covered the period from 1990 until 2015. Country official data were not sourced directly from national statistics offices due to issues regarding the availability of time series and comparability in most of the 22 countries.

The purpose of this report is to assess trends and progress in the Arab region over the past two decades across a selected set of sustainable development indicators. The aim of the data analysis was to establish a trend for each indicator based on two data points over two decades (approximately) at the regional level and subregional levels (GCC countries, LDCs, the Maghreb and the Mashreq). The evaluation of each indicator was based, as far as possible, on the evolution of the indicator between 1990 and the latest year of data available for the Arab region. For many indicators, data were available only for a few years, often without overlap between countries. In such cases, if data are available for at least two years, the analysis is made with reference to the earliest and the latest years for which data are available, as long as there is a minimum difference of five years between data points. Evaluations do not include projections.

Indicators used for analysis had at least one data point in the 1990s (base year of most of the indicators) and at least one in the 2000s (last year). The first data point was used as a proxy of the 1990s baseline and the last one available in the 2000s as a proxy for the current status. To establish a regional or subregional average for any indicator, at

least 50 per cent of the population had to be represented in both years, regardless of the number of countries for which data are available. For example, availability of data for Algeria, Egypt, Iraq and the Sudan would be sufficient to establish a regional trend as the sum of their populations is more than half that of the Arab region as a whole.

Each indicator was then graphically represented to show its trend for the Arab region and each of the four subregions. The values calculated for each indicator are weighted averages, obtained by using the corresponding weighting factor specified in the United Nations Statistics Division (UNSD) metadata for MDG indicators<sup>2</sup> or, failing that, by a corresponding weighting factor. For example, for "access to improved water source (percentage of population)", a weighting factor of total population was used, as the indicator reflects a trend over the entire population for each country; whereas for the indicator "FDI net inflows as a percentage of GDP", GDP in constant 2005 United States dollars was used as the weighting factor. For some indicators, it was more intuitive to calculate a simple average. For others, cumulative totals were calculated rather than (or in addition to) weighted averages (for example, for total arable land and total number of displaced persons). The report indicates where cumulative totals were used rather than weighted or simple averages.

The formula used to calculate the regional and subregional weighted averages is the following:

For the 1990s:

 $\underline{\sum}$ (1990s value of indicator x 1990s weight value)  $\underline{\sum}$ (1990s weight value)

For the 2000s:

 $\underline{\sum}$ (2000s value of indicator x 2000s weight value)  $\underline{\sum}$ (2000s weight value)

Thus, the weighted average for "fixed telephone line subscribers (percentage of population)" in the Maghreb in 1990 is the sum of the values of the indicator for that year for each country multiplied by the corresponding weighting value for the same year for each country. The result is then divided by the sum of the weighting values for the same countries in 1990. The end result of this division is the corresponding weighted average of the Maghreb subregion in 1990. The regional average was also calculated for the Arab region overall using the same corresponding weighting factors and formula.

All decimal values were rounded to the nearest hundredth. Two average values represented each subregion, one reflecting the 1990s and another reflecting the 2000s results. The values for 1990s and 2000s were then used to plot a trend across the region for each indicator in the form of a clustered bar graph.



#### Annex III. Alternative Frameworks Considered


Analysis in the report, rather than simply addressing the 17 SDGs one by one, is framed in such a way as to group related issues together, thereby facilitating interpretation of results. The framework builds on the idea that sustainable development requires convergence between the three aspects of economic development, social equity and environmental protection (with governance often added as a fourth aspect).

The framework for the report is presented in chapter 1. Others that were caonsidered and which had an impact on the framework finally adopted included: the nested people-to-nature approach; the capital-based approach; the social foundations and environmental ceiling approach; the driver-pressure-State-response approach; and the "six elements" recently proposed by the Secretary-General (box A.1).

In September 2015, Governments worldwide adopted the 2030 Agenda for Sustainable Development, including 17 wide-ranging Sustainable Development Goals (SDGs). The authors of the Arab Sustainable Development Report attempt to answer the following questions: Where does the Arab region stand with respect to these global goals? What have been the trends over the past two decades? How can the region successfully implement the Agenda?

The report examines progress on securing human dignity and well-being in the Arab countries and looks at the complex factors shaping the region: the occupation of Palestinian and other Arab lands; ongoing conflicts; governance, human rights and institutional deficits; and shortcomings in terms of financing, science and technology, trade and statistical capacity. It underscores the need for urgent action at the national and regional levels, and for long-term, evidence-based planning and investments that address the root causes of the region's instability.
