Preparatory Meeting on the UN Ocean Conference
UN Headquarters, New York
February 15 – 16, 2017**

quality, environmental management, environmental education and information, safety and services. Several of its initiatives concern monitoring of bathing water quality, conservation of biodiversity and coastal ecosystem, safeguarding swim.

The program prevents and reduces marine pollution, minimizing the impacts of ocean acidification and promoting the minimum release of softeners in the aquatic environment. It encompasses to increase water-use efficiency through capturing and using rainwater. Through several criteria set, Blue Flag spreads the voice to save water and keep it clean, minimizing the environmental footprint and promoting good practices that raise awareness for cleaning beaches and marinas and for increasing recycling. Moreover, Blue Flag supports green fishing communities, the protection of fishery nursery habitat as well as sea turtles and other endangered species.

FEE is totally committed to the SDG's and supports the themes proposed as they address all targets of Goal 14. We are eager to support and seek ways of collaboration in the efforts the Ocean Conference pursues in benefit of the health of our oceans and enhance the role of marine biodiversity.
