Excellency,

I wish to refer to General Assembly resolution 73/292 of 9 May 2019 by which the Assembly decided to convene the 2020 United Nations Conference to Support the Implementation of Sustainable Development Goal 14: Conserve and sustainably use the oceans, seas and marine resources for sustainable development. The conference is now scheduled to take place in Lisbon from 2 to 6 June 2020.

As part of the preparatory process, the Assembly requested the President of the General Assembly to convene a two-day Preparatory Meeting in February 2020, at the United Nations Headquarters in New York. The meeting will be chaired by the two co-facilitators, with interpretation services subject to availability, to consider the themes of the eight interactive dialogues and the elements of a brief, concise, action-oriented and an agreed intergovernmental declaration, focusing on and highlighting, science-based and innovative areas of action to support the implementation of Goal 14.

I am pleased to inform you that, in consultation with the co-facilitators, H.E. Ms. Ngedikes Olai Uludong, Permanent Representative of Palau, and H.E. Mr. Martin Bille Hermann, Permanent Representative of Denmark, I have decided to convene the Preparatory Meeting on 4 and 5 February 2020. The Meeting will be held in conference room 4.

In this regard, I attach the letter from the co-facilitators appointed to oversee the preparatory process and conclude the intergovernmental consultations on the declaration, which provides the proposed Programme of Work for the Preparatory Meeting. Further information related to the meeting will be provided in due course.
