Civil Society Ecosystem of Cyprus

- Progress capacity to address SDGs initiatives related to awareness, education and social justice
- Extensive European Networks for programs implementation
- CSOs are young and inexperienced in global campaigns (progress only after EU accession)
- Grass roots activities and direct access to local citizens
- Improved participation in decision making process
- Programs oriented/funded



Government – CSOs synergies

- European Year for Development 2015, a milestone of collaboration
- MFA led the build up of synergies with the Ministry of Education and Culture and NGOs platform
- Public Dialogue on SDGs (use of surveys)
- Inclusive Decision Making on new SDGs Initiatives
- Agenda 2030 was introduced to the Parliament
- Corporate Social Responsibility (CSR) is a medium for the private sector to be engaged in SDGs (motives provided by the Cyprus Government)



SDGs through the Civil Society

- Ministry of Foreign Affairs support and collaboration
- EU Funded programs
 - Upcoming: "Developing capacities together. European CSO-university networks for global learning on migration, security and sustainable development in an interdependent world (Inter-Cap)" (to be leaded by the Cypriot NGO, CARDET)
- Raise awareness vertically and horizontally towards other CSOs and stakeholders and local citizens
- Cover a wide range of SDGs via training and education activities, targeting mainly "agents of change"



SDGs related programs, initiatives and campaigns

- Social and Solidarity Economy as an alternative approach to Development (SUSY - Sustainable and Solidary Economy) -EuropeAid
- Schools for Future Youth (SFYouth) (Erasmus+)
- GlobaLab project 6 Steps to Global Citizenship
- Global Learning for Change in EYD2015 and Beyond: European Youth Engagement from School Gardens to Sustainable Food Systems
- Advocacy and policy activities to promote global citizenship education







Looking ahead – Challenges and Opportunities

Challenges

- Institutionalization of CSOs. Both governmental departments and CSOs need to deepen their collaboration and mutual support.
- Establishment of a dedicated Government Authority for Sustainable Development.
- Expansion of capabilities: CSOs need to continually invest in new capabilities to be able achieve a social shift.





Looking ahead – Challenges and Opportunities for SDGs

Opportunities:

- Creating awareness and informed global citizens that become agents of change and create a robust counter-weight to the self-narrow interest of specific stakeholders
- Developing tools and Educational resources through innovative teaching methodologies
- Encouraging and supporting alternative methods of economic organizations like cooperatives or Social and Solidarity economy initiatives (SSE)
