Excellency,

In accordance with the letter dated 4 February 2021 of His Excellency Munir Akram, President of the Economic and Social Council, appointing us as co-facilitators to lead consultations on the Ministerial Declaration of the High-level Segment of the 2021 Economic and Social Council and the high-level political forum (HLPF) on sustainable development, convened under the auspices of the Council, we have the honour to transmit herewith the outline of the timetable for the negotiations of the Ministerial Declaration. As outlined in the timeline, we intend to start the process in March and conclude the negotiations by the end of June to allow for sufficient time to reach consensus.

To start the process, we would welcome the opportunity to consult with regional groups in the first week of March to hear initial views on expectations for the process and outcome of the negotiations. We are also available for any delegation or group who would like to share advice or preliminary views. Notwithstanding these informal conversations, we are committed to conduct an open, inclusive and transparent consultation process.

We will rely on your support and cooperation in working together to achieve an ambitious outcome of the 2020-21 ECOSOC cycle and 2021 HLPF, with the focus on recovering better in the Decade of Action and Delivery.
