## **Introduction**

*On behalf of the Women's Major Group, the Children and Youth Major Group, the Workers and Trade Unions Major Group and the NGOs Major Group*

- Add to paragraph 2:

We recognize that **a universal, rights-based and people-centered framework that realizes poverty eradication, changing unsustainable and promoting sustainable patterns of consumption and production and protecting and managing the natural resource base for economic and social development by enabling an economy that operates within planetary boundaries, and leads to ending inequality and upholding and advancing human rights for all** are the overarching objectives of and essential requirements for sustainable development.

- Add to paragraph 3:

**We recall as well our commitments in the outcomes of all the major United Nations conferences and summits in the economic, social and environmental fields, including the United Nations Millennium Declaration, the 2005 World Summit Outcome, the Monterrey Consensus of the International Conference on Financing for Development, the Doha Declaration on Financing for Development: outcome document of the Follow-up International Conference on Financing for Development to Review the Implementation of the Monterrey Consensus, the outcome document of the High-level Plenary Meeting of the General Assembly on the Millennium Development Goals, the Programme of Action of the International Conference on Population and Development, the key actions for the further implementation of the Programme of Action of the International Conference on Population, the Dakar Framework for Action and the Beijing Declaration and Platform for Action and their subsequent reviews.**

- Add to paragraph 4 (or 5):

We further reaffirm the importance of freedom, peace and security, respect for all human rights, including the right to development and the right to an adequate standard of living, including the right to food, **education**, the rule of law, **protection from violence**, good governance, gender equality, women **and girl's** empowerment and the overall commitment to just and democratic societies for development. **We recognize the urgent need to halt the race to the bottom created by our global trade, investment and migration conditions.** We reaffirm the **importance centrality** of the Universal Declaration of Human Rights, as well as

other international instruments relating to human rights and international law, **including the International Covenant on Civil and Political Rights, the International Covenant on Economic, Social and Cultural Rights, the Convention on the Elimination of All Forms of Discrimination against Women, the Convention on the Rights of the Child, the Convention on the Rights of Persons with Disabilities, the International Convention on the Elimination of All Forms of Racial Discrimination, the United Nations Declaration on the Rights of Indigenous Peoples and the International Convention of the Protection of the Rights of All Migrant Workers and Members of their Families, which should be the basis of and mainstreamed across the SDGs framework. We emphasize the responsibilities of all States, in conformity with the Charter of the United Nations, to respect, protect and promote human rights and fundamental freedoms for all, without distinction of any kind as to race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth, disability, age, sexual orientation, gender identify, migration status, or any other status. We reaffirm that climate change is one of the greatest challenges of our time, and we express profound alarm that emissions of greenhouse gases continue to rise globally.[...] In this regard we emphasize that adaptation to climate change represents an immediate and urgent global priority. Further, we underscore that the global nature of climate change calls for the widest possible cooperation by all countries and their participation in an effective and appropriate international response, with a view to accelerating the reduction of global greenhouse gas emissions.**

- Add to paragraph 5:  
**We further recognize that the needs of adolescents and young people must be integrated across all dimensions of sustainable development. Children, Adolescents and youth should be involved in the development, implementation, monitoring and evaluation of programs that impact their lives.**
- Changes to paragraph 6:  
We recognize that people are at the centre of sustainable development and, in this regard, we strive for a world that is just, equitable and inclusive, and we commit to work together to ~~promote~~ **transform the current growth-based development model by committing to sustained integrating sustainable** and inclusive economic growth ~~development~~, **equitable benefit sharing**, social development and environmental protection **within planetary boundaries** and thereby to benefit all.
- Add to paragraph 6:  
**We recognize that gender equality, the human rights of women and girls, and their effective participation are important for effective action on all aspects of sustainable development, that must be guaranteed including through the repeal of discriminatory laws and the removal of formal barriers, ensuring equal access to justice and legal support, the reform of institutions to ensure competence and capacity for gender mainstreaming and the development and adoption of innovative and special approaches to address informal, harmful practices that act as barriers to gender equality. We reaffirm our commitments to ensure women's equal rights, access and opportunities for participation and leadership in the economy, society and political decision-making. In addition to a stand-alone goal, the human rights and empowerment of women and girls and gender equality must be mainstreamed across the SDGs framework and its monitoring.**  
**The participation of citizens, including children and youth, in participatory processes to design, monitor and implement the post-2015 agenda at the national level will be essential**

to the achievement of long-term, sustainable gains, both for societies and communities as a whole, as well as specifically for youth.

We agree to develop a comprehensive framework and process for implementing the SDGs, Targets and Indicators that focuses on achieving all of the other sustainable development agreements at the same time. We are linking each of the Goals, Targets and Indicators with the international agreements dealing with the same issue areas, so that we can tell the world's people what is expected of everyone. The SDGs can provide a foundation for further developing and implementing local and national sustainability strategies. A global process is being established to ensure they are used to help in achieving the Targets and Goals. A full reporting system will be established under the High Level Political Forum to ensure that the Post 2015 agenda is implemented everywhere in a fully inclusive, coherent and integrated manner.

- Add to paragraph 8:  
We reaffirm all the principles of the Rio Declaration on Environment and Development, including, inter alia, the principle of common but differentiated responsibilities, as set out in principle 7 thereof; **and thus commit to using the Rio Principles as the fundamental basis for making a rapid transition to complete sustainability**

education”

### **End poverty in all its forms everywhere**

Amendments to targets:

- 1.1 by **2020**, eradicate extreme poverty by bringing the number of people living ~~on less than \$1.25 a day~~ **below the poverty lines** to zero, **with a focus on structural barriers faced by women and the most marginalized groups**
- 1.3 by **2020**, fully implement nationally appropriate **universal** social protection measures including **setting** floors **for public care services, work, housing, education, water and sanitation and health care**, with a focus on coverage of the poor, **including** the most marginalized **groups** and people in vulnerable situations
- 1.4 by 2030 achieve equal access to **safe, non-discriminatory**, productive employment, **livelihoods** and decent work for all, ~~including~~ **with a particular focus on** the poor, persons with disabilities, and other people in vulnerable situations ~~as well as including~~ women and young people
- 1.5 by 2030 ensure **equal economic and** development opportunities for all men and women, including secure rights to ~~own~~ land, property and other productive resources, and access to financial services, with particular focus on the poor, the most marginalized and people in vulnerable situations
- 1.6 ~~by 2030 strengthen early warning and disaster risk reduction systems and related capacities with the aim of building resilience and protecting the poor and those in vulnerable situations from disasters and shocks, including climate-related extreme events~~ **by 2030 reduce losses for and build the resilience of poor and vulnerable people to disasters and shocks**
- 1.7 pursue ~~sustained~~ **sustainable, equitable** and inclusive economic ~~growth~~ **development** as a key enabler for achieving poverty eradication

## **Proposed goal 2.**

End hunger, achieve food security and adequate nutrition for all, and promote sustainable agriculture

Rewording of goal to: End hunger, achieve food security and adequate nutrition for all, and ~~promote~~ **shift** sustainable agriculture

Amendments to targets:

- 2.1 end hunger and ensure that all people have access to adequate, safe, affordable, nutritious, **diverse and GMO-free** food all year round by **2020, and achieve food sovereignty and the progressive realization of the right to food**
- 2.4 by 2030 **secure rights to land and other productive resources**, achieve access to adequate inputs, knowledge and productive resources, **veterinary services**, financial services and markets **across the rural-urban continuum**, especially for small and family farmers, pastoralists, and fishers, with a particular focus on women **and indigenous peoples**
- 2.5 by 2030, **implement** ~~develop~~ food systems that are more productive, sustainable, **diverse**, resilient and efficient, **maintain and regenerate natural resources and ecosystems**, and ~~minimize adverse human and environmental impacts without compromising food and nutrition security~~ **and eliminate use of highly hazardous pesticides, as well as reduce intensity of use of synthetic fertilizers**
- 2.7 by 2030 reduce by 50% production and **post-production, including** post-harvest food losses ~~and those along food supply chains~~
- 2.8 by 2030, fully implement agricultural **and agro-ecological** practices that strengthen resilience and adaptation to extreme weather, drought, climate change and natural disasters, in particular for small-scale farmers, **women, pastoralists and fishers**
- 2.9 achieve by 2030 protection and sustainable use of agricultural biodiversity **and forests**, including through enhanced use and application of indigenous practices and local and traditional knowledge, and through ~~agricultural~~ research and development related to agro-biodiversity and diversity of food
- 2.11 by **2020** fully implement measures that curb excessive food price volatility and ensure proper functioning of markets

Targets to be added:

- **concentration and misappropriation of land and their social and environmental negative impacts are halted is prevented and productive lands are redistributed**

Move target 6 under proposed goal 15 to proposed goal 2:

- by 2030 **restore an annual amount of degraded land equivalent to the annual amount of land degraded** ~~halt and prevent land degradation~~, reclaim land affected by desertification and drought, and improve land productivity and soil quality

Rewording of paragraph 4 of introduction to include the **right to health** after the right to food.

- 3.5 ~~by 2030~~ increase healthy life expectancy for all by ~~x%~~ **at birth and at age 60**
- 3.6 achieve universal health coverage (UHC), including **strengthening health systems, and ensuring access to essential health services, a well-trained health workforce, and financial risk protection including zero impoverishment due to health expenses and zero catastrophic out of pocket expenses**, with particular attention to the most marginalized and people in vulnerable situations
- 3.7 by 2030 ensure universal availability and access to safe, effective, quality **and** affordable essential medicines, vaccines, **immunizations** and medical technologies, **including health and assistive technologies, treatments and services, including essential surgical care, anaesthesia, and rehabilitation** for all
- 3.8 **by 2030**, ensure universal access to **high quality, comprehensive, equitable and integrated** sexual and reproductive health ~~for all~~ **services, information and education, and respect, protect and fulfil all human rights in this regard, with a particular focus on adolescents and young people**
- 3.9 by 2030 decrease by ~~x%~~ **two-thirds** the number of deaths and ~~illnesses~~ **disability adjusted life years (DALYS)** from ~~indoor and outdoor air~~ **pollution of air (indoor and outdoor), soil and water**
