The meeting will include three discussion sessions:

- 1. Existing knowledge-sharing mechanisms for multi-stakeholder partnerships working towards sustainable development
- 2. Multi-stakeholder partnerships: Sharing and building knowledge and expertise among and within the sustainable development goals
- 3. Designing a knowledge-sharing framework for multi-stakeholder partnerships in the post-2015 era: Empowering stakeholders and improving implementation through transparency

Format

Each **panelist** will make a brief presentation of seven minutes maximum, which should focus on the subject of the individual session and be informal and frank. They should avoid long descriptions of issues or policies and, instead, identify things such as a key lessons learned, policy implications, and challenges at hand. Panelists are encouraged to use a few PowerPoint slides to illustrate their presentations. **Please send any presentation material you wish to use as soon as possible, but no later than 15 June 2015**.

Following these presentations, the moderator will invite each **discussant** to make comments and raise substantive questions about the issues of the session. Interventions should be limited to four minutes, and as with panelists, we urge them to be informal, focused, and frank.
