


THE DEVELOPMENT OF THE NATIONAL ACTION PLAN TO IMPLEMENT THE 2030 AGENDA IN VIET NAM




PRINCIPLES TO DEVELOP THE NATIONAL ACTION PLAN

- □ Based on the 17 goals and 169 targets of the UN 2030 Agenda for Sustainable Development to identify the appropriate goals and targets for Viet Nam
- □ Based on the practical conditions, capacity and development priorities of Viet
 Nam
- □ Builded upon the current key national development strategies, policies, programs, specifically:
 - > The Strategic Orientation for sustainable development in Viet Nam (Vietnam Agenda 21)
 - > The Vietnam Sustainable development Strategy for the period 2011-2020
 - > The Socio-economic Development Strategy 2011-2020
 - > The Vietnam National Green Growth Strategy
 - > The National Strategy on Climate Change



METHODS OF DEVELOPMENT OF THE NATIONAL ACTION PLAN


- ☐ The National Action Plan has been developed through the review of the current development strategies, policies, programs and plans
- □ Mobilize all the stakeholders to participate in review of the 17 SDGs and national current strategies, policies
- □ Applying both bottom-up and top-down approaches in policy review and the development of the Action Plan
- □ Conducting the consultation workshops on the review results and the Draft of Action Plan
- ☐ The Draft of Action Plan is developed based on the input information from the policy review results and the consultation with all stakeholders



MAIN CONTENTS OF NAP ON 2030 AGENDA IMPLEMENTATION


The Draft of National Action Plan on SDG implementation proposes

- □ 17 sustainable development goals (VSDG) and 115 targets for Viet Nam
- □ Major tasks/activities for the period 2017-2020 and 2021-2030
- □ Responsibilities of all stakeholders in implementation, monitoring, and evaluation
- □ Solutions, means of implementation, including appropriate mechanism, financial resources to implement the VSDGs




ROADMAP FOR SDGs IMPLEMENTATION

- ☐ The Draft of the National Action Plan (NAP) is being finalized to submit to the Prime Minister for approval in November this year
- □ Integrating VSDG into national annual & 5 year development plan
- Develop VSDG indicators based on the goals and targets specified in NAP
- □ Set up monitoring & reviewing framework for VSDGs to facilitate the process of monitoring, reviewing, and reporting VSDG
- ☐ Mobilize domestic and international financial resources to implement the NAP: Promulgate specific mechanisms and policies to mobilize financial resources, especially from the private sector (PPP...)




VSDGs MONITORING AND REVIEW



INITIAL RESULTS OF SDGs INDICATOR REVIEW

- ☐ The feasibility of SDG indicators in Viet Nam
- > 124 indicators are feasible;
- > 106 indicators are infeasible.
- □ Baseline
- > 89/124 indicators have available data.
- > 141/230 indicators have no available data.
- ☐ Indicator integration into national statistical system
- 30 indicators are integrated into the 2015 Statistics Law



REGULATION ON VSDG MONITORING AND REVIEW

- □ SDG monitoring, review and reporting have been regulated in the National Action Plan on 2030 Agenda implementation
- □ The Ministry of Planning and Investment (MPI) takes the lead, in collaboration with other ministries/sectors, provinces and other stakeholders to monitor and review the implementation of SDG; develop reports on the implementation of SDGs and submit the reports to the Government and the National Assembly
- □ The formulation of the reports on SDG implementation should mobilize widely participation of all stakeholders, including the social and political organizations, socio-professional organizations, domestic and international organizations.



NEXT STEPS FOR VSDG MONITORING AND REVIEW

- □ Develop VSDG indicators (concepts, contents, calculation methods to ensure the national ownership of data).
- Indicators of VSDG will consist of:
- Indicators of national system;
- Indicators of ministerial, sectoral system;
- Indicators of provincial, district, commune-level system




NEXT STEPS FOR VSDG MONITORING AND REVIEW

- □ Setting up VSDG indicators monitoring system
- Principle of setting
- Ensuring the feasibility
- Consistent with characteristics of Viet Nam
- Ensuring the international comparison
- ✓ Suitable for different levels (global, regional, national, provincial, district and commune)



NEXT STEPS FOR VSDG MONITORING AND REVIEW

- □ Determining the scope of statistics
- □ Adding VSDG to national statistic list
- □ Supplement forms of data collection
- □ Develop the online indicator information systems for SDG monitoring and reporting
- □ Identify focal point in monitoring and reviewing each goal and target
- □ Enhancing capacity of statistics for SDGs (staff of the GSO and other line ministries, sectors as well as local level)
- Mobilizing technical and financial support for monitoring and reviewing.




DIRECTION FOR REVIEW MECHANISM

- ☐ The national reviews should be inclusive, participatory and engage people at all levels (parliament, National Council for SD, civil society, private sector and other stakeholders).
- ☐ The review could be based on a report of team of peer reviewers, that would include major group representatives, as well as on the national accountability reports.



DIRECTION FOR REVIEW FORM

- □ National reviews can take different forms, ranging from basic monitoring to more comprehensive review to support and advise governments in achieving the SDGs
- □ Analytical reports on SDGs implementation should provide an analysis of best practices and make policy recommendations where progress has been poor.
- □ Discussions and exchange of experiences and best practices at consultations/meetings to support the review process.
