Stats:

- More than 80% from human activities are discharged into rivers/sea without treatment.
- As of 2011, 16% of total electricity production was from hydropower.
- 70% of deaths from natural disasters are from floods
- 1.4 billion people currently live in river basins where the use of water exceeds minimum recharge levels.
